Because a <u>complete</u> application for renewal and/or the required fees were not filed with the Alcohol & Marijuana Control Office (AMCO) by February 28, 2020, **your liquor license expired at midnight, February 28, 2020**, per AS 04.11.540.

# THE SERVICE, SALE, CONSUMPTION, MANUFACTURE, AND/OR DISTRIBUTION OF ALCOHOL ON YOUR PREMISES MUST CEASE IMMEDIATELY.

If you submitted a renewal application that was determined to be incomplete, your license has expired for failure to complete the application by the statutory deadline.

The Alcoholic Beverage Control (ABC) Board will consider a written request to reinstate the license if the request is accompanied by a complete renewal application, all required fees (including any penalties and \$1000.00 reinstatement fee), and proof of good cause for the failure to file and pay by February 28, 2020, per 3 AAC 304.160(e). If you wish for this request to be considered by the ABC Board at its meeting on March 31 – April 1, 2020, all items must be complete and received by AMCO staff on or before March 13, 2020.

If you submitted a renewal application (and fees) for a license that has expired for failure to complete the application by the deadline, and if you <u>do not</u> wish to request that the ABC Board reinstate and renew your license, you may request a refund of your license fee by contacting AMCO staff. The \$300 renewal application fee and \$500 late penalty fee are non-refundable.

Completed documents (with the exception of fingerprint cards and checks) may be scanned and emailed, and any questions or concerns may be sent to <u>alcohol.licensing@alaska.gov</u>.
