Requested Action:

Renewal Application

Statutory Authority:

AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.480(a): "A local governing body may protest the issuance, renewal, relocation, or transfer to another person of a license by sending the board and the applicant a protest and the reasons for the protest within 60 days of receipt from the board of notice of filing of the application... The board shall consider a protest and testimony received at a hearing conducted under AS 04.11.510(b)(2) or (4) when it considers the application... If an application or continued operation is protested, the board shall deny the application or continued operation unless the board finds that the protest is arbitrary, capricious, and unreasonable."

AS 04.11.510(b)(2): "The board may review an application for the issuance, renewal, transfer of location, or transfer to another person of a license without affording the applicant notice or hearing, except...(2) the board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local governing body to an application if a hearing is not required under this subsection;"

Staff Rec.: Hold a public hearing; deny the application with a 180 day abeyance.

**Background:** The Matanuska – Susitna Borough protests due to payment of delinquent property taxes owed to the Borough.

The licensee should be notified that under 3 AAC 304.145(h), this abeyance period may not be extended or renewed.

This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 6-18-19, an inspection was conducted at your establishment. Initially I made contact with a server who advised me she was employed under 30 days. She then directed me to the cook who she stated served the alcohol. The cook looked at me, and walked out the back door. I assumed he was getting his server card but he never came back. I then made contact with Karl Wurlitzer, licensee. Wurlitzer was asked to provide proof of server education (in the form of a card issued to him) to which he replied, "I haven't had one in years". I noticed that the establishment did not have the alcohol license displayed and there were no required signs posted. A review of your past renewals of Section 7: Alcohol Server Education, you checked that you certify that all licensees, agents and employees who sell or server alcoholic beverages or check identification of a patrons have completed a server education course.

A check with Alaska CHARR going back to 2012, revealed they had no records of you taking a class. I also checked with TIPS and they have no record of you possessing a server card.

Your attention is directed to AS 04.21.025: Alcohol server education, AS 04.21.030: Responsibility of licensee, agents and employees, AS04.16.150: Licensee responsible for violations, AS 04.21.065: Posting of warning signs, AS 04.11.630: Accessibility of license and licensed premises to inspection, 3AAC 304.185: Licensed premises, and AS 04.16.210: Penalty for making false statements

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPREARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.

3 AAC 304.525 (B) provides that upon receipt of a Notice of Violation, a licensee may request to appear before the Director and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice and the Director must grant an appearance within ten days after receipt of a request. A Licensee shall respond, either orally or in writing, to the Notice.
