Latitude 62 Lodge is located in Talkeetna, Alaska, a historic district and tourist destination located on the south side of Denali National Park and Byers Lake State Park. We at Latitude 62 promote tourism by encouraging people to visit our many gift shops and museums in downtown Talkeetna. We also encourage them to take scenic flights around Denali, go for jet boat rides or fish on the local rivers, also try out the Denali Zip Line or ride the Alaska Railroad which stops in Talkeetna. We have one full wall of brochures show casing the many businesses located in Talkeetna.

We are open year round so we also promote tourism in the winter, skiing, dog mushing, snowmachining, Aurora viewing to name a few.

We have 13 nightly rentals, 12 motel rooms and one private cabin. Our motel rooms do not have cooking facilities but the private cabin has a limited kitchen. Our motel has a full service restaurant and cocktail lounge. We do not stock alcohol in the rooms but it is available at the bar.

The building was constructed in 1986 to provide a place of tourists to come and stay. We where shut down in April/May because of the pandemic. At that time we did some painting and repairs on the floors, walls, restrooms, etc. as money allowed.

Having a liquor license encourages people to come and spend a night or two. Issuance of a liquor license at Latitude 62 Lodge has enabled thousands of tourists from around the world to enjoy a beverage while staying and dining in our establishment.

I, Nancy Leah Trump, am currently operating and have managed and operated Latitude 62 Lodge since 1986.


