This is a notice to you as licensee that an alleged violation has occurred. Note: This is not an accusation or a criminal complaint.

Saverda stated her card expired about 5 years ago and does not have a current server card. She has been supervisor for about 4 months.

Your attention is directed to 3AAC 304.465: Alcohol server education, AS 04.21.025: Alcohol server education, AS 04.21.030: Responsibility of licensee, agents, and employees, AS 04.16.150: Licensee responsible for violations and Anchorage Municipal Code 10.50.015(R) which states you have to have server education prior to working with alcoholic beverages

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.






