I've reattached the additional AB-17 sheet and appreciate the patience.

I guess I'm confused on what all I need to do.

We are in the process of transferring ownership from my parents to myself.

In December of 2019 we filed our biennial report with the CBPL and corrected it in February of 2020 to reflect the change in ownership.

In May of 2020 I applied for the transfer of license (forms AB-01, et. al.). I was informed on June 16th that our transfer was incomplete due to a few things among them the incorrect info on ownership.
