## **MEMORANDUM**

Requested Action:

Request for time extension.

Statutory Authority:

AS 04.11.030(b): "If an application for the transfer of ownership of a license from a deceased licensee is not made within 90 days of the death of the licensee or within an additional 90 days if an application for transfer of ownership made by the executor is denied, or no petition is made to the board for an extension of time under (c) of this section within the time, the license is forfeited."

AS 04.11.030(c): "The board may extend the time limits in (b) of this section on petition of the executor or administrator."

**Background:** On April 20, 2021 AMCO received a notice from Susan Renner, treasurer of American Cruise Lines, Inc. that Charles A. Robertson, 35% shareholder and President had passed away. American Cruise Lines, Inc. is requesting a 90 day time extension to file a controlling interest transfer application and to continue operations.

American Cruise Lines, Inc. (ACL) holds seasonal common carrier liquor license 5684 to serve alcoholic beverages for consumption aboard its cruise ship American Constellation.

We are writing to inform you of the following changes that have taken place in the corporation's ownership:

- 1. Mr. Charles A. Robertson, previously reported as the owner of 35% of the Corporation's stock, has died and is no longer an owner.
- 2. Mr. Robert L. James, previously reported as the owner of 12% of the Corporation's stock, sold all of his stock back to the Corporation and is no longer an owner.
- 3. Carol A. Robertson, previously reported as the owner of 27% of the Corporation's stock, is now the owner of 73% of the Corporation's stock, all in her role as the trustee for certain trusts created for the Robertson family.

We are aware that these changes should have been reported to you already. The past year has been extraordinary and these transactions are complex. This is not an excuse for failure to report, but merely an explanation.

We would like to request your consent to these transfers – or an extension of time (90 days) to provide any additional details or forms that you might require.
