Consider the additional petition signatures and approve the application with delegation.

**Statutory
Authority:**

AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.400(g): "The board may approve the issuance or transfer of ownership of a restaurant or eating place license in a municipality without regard to

(a) [population limits] of this section if the board finds that issuance or transfer of the license is necessary for the public convenience."

3 AAC 304.335: "(a) The board may issue a restaurant or eating place license under AS 04.11.400(g) upon a showing that (1) repealed 8/24/2001; (2) there is community support, which must be shown by a petition signed by a majority of the residents 21 years of age or over who reside within one mile of the proposed premises; and the governing body of the municipality in which the licensed premises are to be located approves the application."

3 AAC 304.115. "(a) If required by statute or regulation, a petition is a necessary part of an application for a new license, and for renewal, transfer, or relocation of an existing license. An application submitted without the required petition is incomplete. All petitions must be on forms prescribed by the board. Petition signatures must be obtained within the 90-day period immediately preceding the submission of the application. After an application has been filed, no additional signatures may be added to the petition, and no signatures may be withdrawn"

Background: In April 2020, right as Covid-19 was taking hold of the state, the applicant contacted AMCO staff with concerns about obtaining the required signatures by going door to door and requested guidance with finding alternative ways to obtain those signatures. After research by staff, AMCO explained to the applicant that electronic completed petitions would be allowable, but did not elaborate further or provide additional guidance as to how the electronic petition and signatures should look like at that time.

The first Restaurant/Eating Place – Public Convenience application was submitted on June 10, 2020 and returned July 24, 2020 for insufficient signatures and information on the petition. In the first returned application letter, staff wrote, "If you decide to conduct another electronic petition, please contact our office

so we may offer some guidance on what language to use.”

The second Public Convenience application was submitted on November 12, 2020 and again returned for not enough valid signatures on February 8, 2021.

It was determined in the third attempt, that the applicant was going to need to provide at the minimum 149 valid signatures. Staff found that the petition was 3 valid signatures shy of meeting the minimum number.

Because the rest of the application documents were complete and had it not been for the pandemic and AMCO’s lack of direction or guidance on a new method for collecting proper online signatures, we feel that her application could and should have been deemed complete as far back as a year ago.

Management instructed the applicant on May 20, 2021 to “provide our office with 5 or more (signatures) that are valid (and) we should be able to deem your application complete”. The applicant provided 18 additional signatures and after a review, staff determined that there were 160 valid signatures on her petition.

Temporary approval was issued by AMCO management on May 21, 2021.

Your application is being returned to you because staff has determined that your establishment does not appear meet the requirements for a Restaurant/Eating Place – Public Convenience liquor license under AS 04.11.400(g), 3 AAC 304.115 and 3 AAC 304.335 due to the number of valid signatures obtained. If you wish to reapply, you must file all required application documents and pay a new application fee, per 3 AAC 304.105(e).

For your reference, the following items were determined to be incomplete:

- **AB-12: Petition**
 - According to the numbers you have provided, the absolute minimum number of valid signatures you would have to obtain within a one-mile radius would be 156. You have provided 219 signatures/survey responses.
 - After a review of all the provided signatures, dates and addresses, we have determined that the number of valid signatures obtained are only 109.
 - The signatures and surveys were found to be invalid for various reasons including:
 - The signee lives outside of the 1-mile radius of your proposed licensed premises.
 - Questions were skipped or left blank
 - Missing signee name, address, date of birth, etc.
 - Entries were illegible
- Statute 04.11.460 states that signatures must be collected. The survey/questionnaire does not contain the word signature. If you decide to conduct another electronic petition, please contact our office so we may offer some guidance on what language to use.
 - **Section 1**

"Permanent resident" means a person 21 years of age or older who has established a permanent place of abode. A person may be a permanent resident of only one place, per **3 AAC 304.115(b)**.

Signatures must be obtained within the 90-day period immediately before submitting the petition to the board.

*If there is no United States post office within a radius of five miles of the proposed licensed premises, the applicant must obtain the signatures of two-thirds of the permanent residents residing within a five mile radius of the proposed licensed premises. The map should show the applicable area.

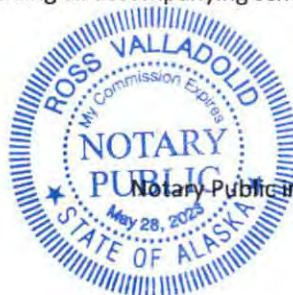

Petition Narrative

Zernia Enterprises Inc. dba Mermaid Grotto Cafe is seeking approval for a restaurant/eating place, public convenience beer and wine license. The physical address of the property is 512 Port Avenue Seward, Alaska. It is adjacent to the Alaska Railroad Seward Depot and in the industrial zone. It is located at the corner of Port Avenue and Leirer Road.

When calculating how many year around residents live within a 1 mile radius we printed off a Google map and used their measurement tool to find the one mile mark. On the enclosed map you will see the one mile radius circle. We then traveled around this area and observed/counted the residences and came up with 414 residences. With online research we were able to find that 107 residences in this mile are being used for nightly rentals for profit(Vrbo and Airbnb). Additionally, at the time we checked and were getting signatures, there were 14 unoccupied/for rent properties. These factors bring the total down to 293 residences. 51% if the total would require us to have 149 signatures.

Due to the Covid-19 pandemic we felt it was appropriate to offer an online option for people to show their support. This online survey was advertised via our Facebook and Instagram pages. We received 138 total online submissions with 24 being disqualified due to residing outside the mile marker. We have included the 114 that qualify. We also had petition sheets at the restaurant for those that came in. We have been open for dining since Nov. 23rd, 2020. With the two methods combine we have collected 160 viable addresses. We have checked each individual address to verify it is inside of the mile and omitted or crossed off any address that is not in the mile. Again, we used google tools to help with these measurements. This amount is 54.5% of the original 293.

There will be a wait staff assigned to outdoor courtyard dining at all times when use is offered.

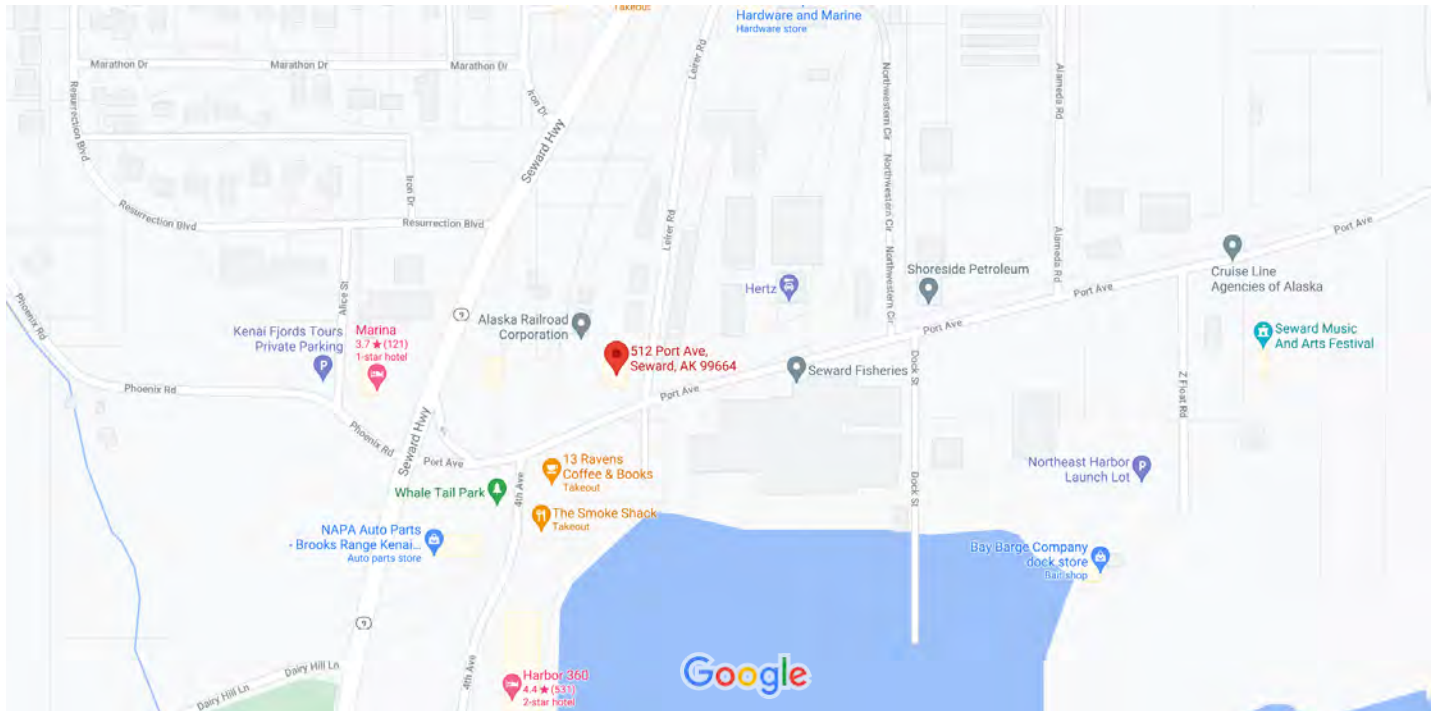
There will be signage at all exit points saying “No Alcohol beyond this point”.
