Rescind the previous approval with delegation, hold an informal hearing and deny the renewal application with 180-day abeyance period.

Statutory & Regulation Authority:

Requested

Action:

AS 04.11.510(b)(1): "if an application is denied, the notice of denial shall be furnished the applicant immediately in writing stating the reason for the denial in clear and concise language; the notice of denial must inform the applicant that the applicant is entitled to an informal conference with either the director or the board, and that, if not satisfied by the informal conference, the applicant is then entitled to a formal hearing conducted by the office of administrative hearings (AS 44.64.010); if the applicant requests a formal hearing, the office of administrative hearings shall adhere to AS 44.62.330 — 44.62.630 (Administrative Procedure Act); all interested persons may be heard at the hearing and unless waived by the applicant and the board, the formal hearing shall be held in the area for which the application is requested"

3 AAC 304.145(h) "The board may uphold a protest of an application or continued operation with a single abeyance period not to exceed 180 days if the local governing body indicates that the protest is subject to rescission and that it will be withdrawn if the applicant meets conditions set by the local governing body. If the local governing body notifies the board within the period of the abeyance that the protest has been removed, the application or continued operation is approved when all other applicable requirements have been met. If the local governing body has not notified the board within the period of the abeyance that it has removed the protest, the application or continued operation is denied. The period of abeyance may not be extended or renewed."

Background: At the April 28, 2021 Special ABC meeting, the Board approved the 2021-2022 renewal with delegation. On June 9, 2021, the Municipality of Anchorage protested the renewal application pending taxes owed to the Municipality and certification from the Anchorage Fire Department.

Thank you very much for bringing this new information to my attention. Randi agrees that there very likely was a misunderstanding in those previous dual conversations.

- The records I previously checked indicated we did, as you reported, have a passed background check for Mr. Ames but it occurred more than 5 years ago. In the event of a new officer change/transfer, we would then need new fees/fingerprints/ forms for Mr. Ames.
- That said, oddly, it doesn't give a specific date- just that it's over 5+ years. This would
 potentially support your statement of AMCO database not being updated
 correctly/incomplete.
- A situation that would not require fees/forms/signatures would be if Mr. Ames has in fact stayed in the same position as President since he passed that first test. I pulled (attached) CBPL filings 2014-present & Ames is first included 10/29/20. That is helpful data but does not verify when Ames most recently became President.

Either way, AMCO needs to correct update/correct this database. I also want this clearly document to prevent future misunderstandings. Can you please provide documentation of any kind verifying date when Ames most recently became President? I will then get authoritative answer from Enforcement on the previous background check data, consult my aforementioned supervisor Carrie and report back. I agree it appears this likely can be waived but I need to get this all confirmed first.

Susan Johnson is the attorney with whom I work on this matter, and she was the other individual who spoke with AMCO about the transfer application.

We do not dispute that fingerprints would be required for the new LLC manager and the new officer, but I think there is a bit of confusion about my communications with Randi about Chris Ames. Chris Ames is an existing officer of the licensed entity, and has been since he was reported as such and submitted fingerprints to AMCO in 2014. For reference, attached is an unsigned version of the notice letter that was sent to AMCO in 2014. What we understood from Randi was that Chris Ames was already qualified on the existing license, but AMCO's database was inadvertently not updated with his information. Randi indicated that she checked with Carrie Craig on the matter, and Carrie confirmed there was nothing further needed for him. Nealy & Tish – hello.

1st off, I 100% understand how based on this email, I can see how you or anyone could interpret that as verification from former alcohol OLE (now marijuana OLE) that no further action was required, including fingerprints/forms/fees. I spoke with Randi at length to ascertain the complex.

- At that time in late fall 2020 Randi was being contacted by 2 different individuals regarding a potential transfer application, which is where a misunderstanding could have possibly started. Entirely possible that was Nealy and Tish.
- On that related note, we did indeed later receive a transfer application for 1090, which was received approximately 12/4 and is currently in our processing queue.
- So Randi's response was in the context of "you are planning to soon send in a transfer application. Let's just deal with this at once, while recognizing that you did report, meeting reporting requirements." It was not at any time in the context of "no action is needed period forever" but, again, in retrospect it's reasonable to expect that it meant the latter and not the former.
- Going back to Randi's instructions she is/was correct that the fingerprints/fees/forms (would)will be eventually needed for that transfer when that app would be eventually submitted. But the caveat is we also need it for the renewal, which needs to be processed ASAP.

Bottom line: I apologize for the miscommunication. But the only exemption for the form/fingerprint/fee requirement is for companies on the stock exchange. (That is only because NYSE & others already require their own fingerprinting/background checks so we recognize their process rather than needlessly duplicate the requirements.) If you are publicly traded, please let me know so I can notate that for the file. Otherwise, we still need what was asked for in the incomplete letter for the renewal AND the transfer AND the previously reported officer change. Deadline Reminders:
