Provisions

Requested Action:

New Restaurant or Eating Place – Public Convenience license

Statutory and Regulatory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.400(g): "The board may approve the issuance or transfer of ownership of a restaurant or eating place license in a municipality without regard to

- (a) [population limits] of this section if the board finds that issuance or transfer of the license is necessary for the public convenience."
- 3 AAC 304.335: "(a) The board may issue a restaurant or eating place license under AS 04.11.400(g) upon a showing that
  - (1) repealed 8/24/2001;
  - (2) there is community support, which must be shown by a petition signed by a majority of the residents 21 years of age or over who reside within one mile of the proposed premises; and
  - (3) the governing body of the municipality in which the licensed premises are to be located approves the application."

3 AAC 304.115(a): "...Petition signatures must be obtained within the 90-day period immediately preceding the submission of the application. After an application has been filed, no additional signatures may be added to the petition, and no signatures may be withdrawn."

**Staff Rec.:** Approve with delegation

**Background:** This application is for a new restaurant or eating place – public convenience license in the City of Seward. 3 AAC 304.335 requires approval of the local governing body and community support as expressed by a petition signed by a majority of the residents 21 years of age or older who live within one mile of the proposed licensed premises.

The applicant determined the number of signatures required by identifying the number of residences within a mile of the proposed licensed premises through communication with the City of Seward which was 180.

Using these methods, it was determined that the minimum number of required, valid signatures is 91. By examining all dates, addresses and searching for any disqualifying elements, staff verified that the applicant has provided 118 valid signatures.

Any application for a restaurant / eating place - public convenience (REPC) license or any liquor license application for a premises located in an area with no local governing body must file a petition in accordance with AS 04.11.400(g), AS 04.11.460, 3 AAC 304.115, and/or 3 AAC 304.335. Instructions vary with the type of area in which your proposed premises are located.

Please read the instructions in Section 2 of this form carefully.

A liquor license application for a premises that is within 50 miles of the boundary of a local governing body must submit a petition signed by the majority of the permanent residents residing within one mile of the proposed premises per AS 04.11.460(a).

A liquor license application for a premises that is 50 miles or more from the boundary of a local governing body must submit a petition signed by two-thirds of the permanent residents residing within a five mile radius of the United States post office nearest to the proposed licensed premises per AS 04.11.460(b)



Please read these instructions carefully.

The following information must accompany all liquor license applications requiring petitions:

- 1. A map showing the population within:
  - a. the one mile radius with the proposed premises as center (required for REPC applications and for premises within 50 miles of the boundary of a local government)

OR

- b. the five mile radius with the United States post office as center (required for premises 50 miles or more from the boundary of a local government)\*
- Graphic designation on a map showing the general area where petition signatures were obtained
- 3. A narrative and mathematical calculation of how population totals were determined
- 4. A narrative of how signatures were obtained (door to door solicitation; premises solicitation; etc.)

"Permanent resident" means a person 21 years of age or older who has established a permanent place of abode. A person may be a permanent resident of only one place, per 3 AAC 304.115(b).

Signatures must be obtained within the 90-day period immediately before submitting the petition to the board.

\*If there is no United States post office within a radius of five miles of the proposed licensed premises, the applicant must obtain the signatures of two-thirds of the permanent residents residing within a five mile radius of the proposed licensed premises. The map should show the applicable area.

https://www.towncharts.com/Alaska/Demographics/Seward-city-AK-Demographics-data.html, the 2019 population was 2,773 people. Of those 2773 people, 25% (693ppl) (see photo A. attached) are under the age of 21, which brings the total to 2080 over the age of 21 (according to towncharts.com).

A. 2773 x .25=693

B. 2773-693=2080

The location of Primrose Provisions is in the downtown district which consists of businesses and commercial buildings as opposed to residential use. In addition, many of the residents that do live in the downtown area are seasonal workers and not year-round.

The areas East and South of our location are made up of water and a non-liveable road/area.

According to Alaska Corrections Dept., there are appx 550 inmates at the Spring Creek Correctional Center which is within Seward City Limits. This brings the total population down to 1530 people.

C. 2080-550=1530

According to the City of Seward, a majority of the 21 and over population live outside of the one mile radius such as the residential subdivisions of Dora Way (300 ppl) Forest Acres (500ppl), Jesse Lee/Resurrection Blvd/Benson (high school area) (200 ppl), Southern Nash Road (350 ppl). This brings the population down to 200.

D. 500+300+200+350=1350

E. 1530-1350=180

From this we can conclude there are 180 people within a one mile radius of Primrose Provisions (501 Railway Ave, Suite B) that are over the age of 21.

F. 180/2=90


With this information, we can conclude that we need at least 91 signatures for a majority. We have collected a total 132 signatures.

The signatures were gathered online on jotform.com, door to door, and on premises.






# Figure 8: Seward, AK and Area Age by Generation



### **Primrose Provisions Security Plan**

A supervisor over the age of 21 will always be present during operating hours. All employees 21 and over will have TAPS certification. When not serving beer and wine, storage of alcohol will be locked.

There will be security cameras inside and outside with angles of all areas where alcohol will be consumed. There will be signs stating that anyone under the age of 21 needs to be supervised by a legal guardian while they are on premises. There will be signs outside at both entrances/exits to the sidewalk that no alcohol can go past that point and that all alcohol must be consumed on the deck/Primrose Provisions premises. The deck is fully enclosed with wood rails and is approximately 5 feet above the sidewalk. The exits and entrances to the sidewalk have cameras angled at them to ensure that no one is taking alcohol off premises.

There will be extra staff over the age of 21 on when there is outdoor seating (sunny days only...which isn't common in Seward) to ensure that no one is illegally consuming alcohol. There will be a staff member committed to just the outdoor dining area when it is open.


