AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.540: "...If a complete application for renewal has not been filed by February 28 or the required fees and the penalty fees have not been paid by that date, the license expires at 12:00 midnight February 28."

3 AAC 304.160(f): "The board will deny a request for reinstatement submitted under (e) of this section if

(1) the license became available in accordance with 3 AAC 304.100(2) and was issued to a different applicant, unless the limit of licenses under AS 04.11.400 has not been reached; or

(2) the board finds that the failure to timely file or pay was caused by

(A) the licensee's failure to notify the board of a change of the licensee's mailing address;

(B) a transfer of ownership of the business for which the license was issued without written approval of the board in violation of AS 04.11.040;

(C) a lease of the licensed business to another person in violation of AS 04.11.450(c);
or

(D) any other action of the licensee whether active or tacit that the board finds constitutes a failure to lawfully operate the business for which the license was issued."

Staff Rec.:

Evaluate reinstatement request in accordance with 3 AAC 304.160(f).

Background: During the 2021/2022 licensing period, a renewal application was not submitted by the February 28, 2021 deadline. A warning letter was mailed and emailed to the licensee on February 2, 2021 and the expiration and cessation of operations letter was mailed and emailed on March 5, 2021. The expiration letter was returned from USPS on March 11, 2021.

On August 5, 2021 staff discovered when the transfer of ownership was effectuated in October of 2019, the examiner failed to update the contact information, including the

mailing address, in AMCO's database, therefore the renewal application and subsequent expiration letters were sent to the wrong address. After this discovery of staff error, management waived the late fees and the requirement to draft a request to reinstate, however it was required that they complete the renewal packet. The renewal application was deemed complete on August 18, 2021.



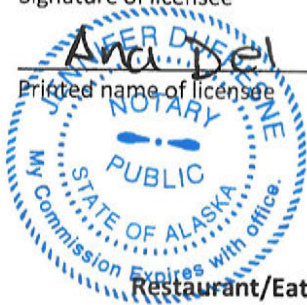

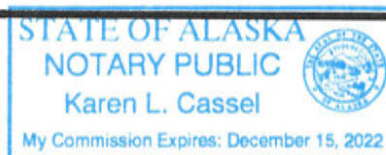

Good morning,

Thank you for coming into the office yesterday and the concerns you raised about the status of your license #5823 are addressed today by leadership. Our office expired your license in error and to correct that error as of today, the status of your license has been reverted back to "Valid". We have also fixed the ownership information in our database to show the correct owner, mailing address and email address to ensure this will not happen again.

I am reaching out to you to detail the remedy our office has taken to correct our error and to give you instructions on how to renew your license.

Firstly, license #5823 is now a valid license but still has an expiration date and this license cannot be operated until it is renewed. You may however, continue to operate **as of today by using the attached 2/22/2021 letter from Director Glen Klinkhart as a temporary license.** I have attached this letter/temporary license to this correspondence. Print out this letter and hang it in your establishment as it functions as a temporary license while your renewal process is underway and gives you the right to continue selling alcoholic beverages at your establishment.

You must submit a 2021-22 renewal application and associated fees. Per leadership the \$500 late fee and the \$1000 reinstatement fee will not apply for your renewal process. For the renewal application you must pay the \$600 license fee for your license type and the \$300 renewal application fee as well as any fingerprint fees that may be needed. (see notes below on fingerprint card fees) I have attached a blank renewal application, **AB-17**, for your use. As a Restaurant/Eating Place license you must also fill out and submit the attached

AB-33 form and submit it with your renewal application as well. You may submit the fee payment by sending a check in to our office or contacting our front desk at 907-269-0350 to pay by credit card. Alternatively, our front desk is open from 9am-12pm and 1pm-4pm should you wish to drop off the application and payment.

For your convenience I have attached a printout of your entity (Cilantro Inc #99025) ownership details from the database of Corporations, Business and Professional Licensing (CBPL). This printout shows that the renewal application you will submit must list the following entity officers:

Ana Del Real with title of President and Treasurer with 100% ownership

Arleet Del Real with title of Secretary and Vice President with 0% ownership

Please note that our office has on file the fingerprint background information for Ana Del Real but not for Arleet Del Real. Our office requires that any President, Vice President or Secretary must be listed on the application as well as any entity member with 10% more ownership. Because Arleet Del Real has both the title of Secretary and Vice President he will need to be listed on the renewal application and you will need to submit a fingerprint card, fee of \$48.25 and completed AB-08a form for him. A blank AB-08a form is attached for your use.

You are not required to list Gustavo Del Real with title of Director and 0% ownership but **should you wish to list him you may**. If he is listed on the renewal application he will have signature authority on the license and we will need a fingerprint card, fee of \$48.25 and the AB-08a form for him as well.

I have also attached a printout of your business license (#2121390). The business license shows that the business is owned by Ana Del Real but it should reflect that the business is owned by the entity "Cilantro's Inc". We strongly suggest you contact CBPL and correct the ownership of your business license to show AMCO approved ownership.
