On 6-29-20, an inspection was conducted at your establishment. Contact was made with manager Grant Feather, who stated he has been working at this location for approximately 8 weeks. Feather was asked to provide proof of server education to which he stated he has had it in the past but doesn't have it now. Feather stated 3 or 4 other employees who work in the liquor store, who have been employed longer than 30 days, do not have server education. Feather stated due to COVID, the last two classes that have been advertised were on such short notice, he could not adjust his and his employees schedules to attend training. However, he did state they were all scheduled to attend training on 6-30-20 on your premises. On 6-30-20, Inv. Hamilton contacted Alaska CHARR who advised him that the last class taught in Soldotna was on June 10th of 2020, in. They further stated they usually try to give at least a weeks notice of the class. Finally, there is no class scheduled in Soldotna on June 30, 2020.

Your attention is referred to AS 04.21.025: Alcohol server education, and AS 04.21.030: Responsibility of of licensee, agents and employees

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation.
