Please let this email serve as a formal response to Notice of Violation #22-1813.

From the onset, please know that my clients and the Managers take these matters very seriously and at all times want to cooperate with the ABC Board and to do only what is legal and appropriate under Title 4.

On October 7, 2022, I received an email from you indicating that you had visited Ocean Shores and advised them to stop selling alcohol due to your concern over their continued operations as the holders of a tourism license. Your concern was due to the fact that the bar and restaurant were still open and the hotel not open to the public after being closing for the season in late September. As soon as I got that message, I made direct contact with my client Michael Warburton who is the owner of Ocean Shores. Sometime very shortly after this exchange, I am now advised that Manager, Chris Miller, contacted you directly and advised you that he had corrected your concerns. He says that he asked you if everything was "good" which in his mind meant could operations continue. He indicates that you said "yes" and that you were waiting on responses from the attorneys. Unfortunately, Mr. Miller took your response as it was okay for

them to proceed with the sale of alcohol. Mr. Miller does not recall you asking him to cease alcohol service on that call or when you called him earlier that day. I do think there was an honest miscommunication here. I myself never spoke with Mr. Miller during this time. My contact was with my client. However, since receiving this Notice of Violation, a meeting was held between the owner, the manager, and legal counsel to again discuss the requirements of Title 4 relative to a manager to insure continued Title 4 compliance.

Additionally, since October 7, Manager Chris Miller has changed all of his social media to reflect the proper name of the licensed premises — "Kannery Grill." A d/b/a name change had been contemplated by the parties but was never effectuated. In the future, the name will remain Kannery Grill.

Please let me know if you have further questions or concerns. My client is glad to speak to you, the Director, and/or the Board itself about these matters at any time. I can gladly prepare a brief outlining my client's legal position relative to the operation of a tourism license in the off season. I did not think it appropriate to do so in this response but am glad to do so in short order should you or the Director want me to do so.

Note: This is not an accusation or a criminal complaint.

On November 12-13, 22, AMCO Director Wilson and Anchorage Police Department Patrol inspected the Dress-In-Black Party held at 420 W. 3<sup>rd</sup> Avenue, Anchorage, Alaska. Director Wilson and APD were on-site from 2330 on 11/12 to 0020 on 11/13 and again from 0155 to 0230. The Caterer's Permit permitting the sales, delivery, and consumption of alcoholic beverages at the event was issued to Burrito King holder of beverage dispensary license 4109. The following violations of AS 04 (Alcoholic Beverages) were observed and documented.

- 1. AS 04.21.065 Failure to Posting Warning Signs; 3 AAC 304.185 Failure to Post Permit. The holder of a caterer's permit shall post permit conspicuously on the licensed premise and the warning signs required under AS 04.21.065(b), including (1) signage warning of potential birth defects from the consumption of alcohol, (2) signage warning that service of alcohol to an individual under the age of 21 is punishable as a felony, and (3) signage warning civil liability for unaccompanied minors on premises. The licensee shall post the first two signs in a manner conspicuous to the purchaser and consumer or alcohol and the third sign at each door which customers enter the licensed premises. When forwarding the approved, but conditioned permit to Mr. Allen, the individual designated by the licensee as the agent or employee that would be present at the event, the Director wrote in an email: "I know you and Mr. Gallo are aware of all obligations, but please also ensure the permit and all other required signage is displayed as required and visible to the public." Mr. Allen responded, "Thx very much Joan. This event will be managed appropriately to be in compliance, including a good neighbor focus." From the start of the event to the Director's arrival at 2330, no signage of any kind was posted at the door through which customers enter the licensed premises. Prior to 0020 neither of the first two signs or the permit were posted in a conspicuous place on the licensed premises. This violation was only corrected when the Director requested the posting. None of the signage was 11 by 14 in dimension.
- 2. Service of Alcohol by Individuals Not Identified in the Caterer's Permit Application. Pursuant to Section 4 of the caterer's permit application, the licensee must "enter ALL information for ALL servers at the event." Individuals who do not provide complete information may not be accepted as servers." The following individuals were serving alcoholic beverages (with required education cards) and were not identified in the application: Bobbi Williams, Anny Sanchez.
- 3. AS 04.16.210 Penalty for making false statement (If a false statement is made in an application under AS 04.11.260 AS 04.11.290, the applicant is guilty of perjury, and upon conviction, is subject to the penalty provided by law); 3 AAC 304.685 (the caterer, or a specified employee or agent of the caterer, shall be present on the catered premises at all times alcoholic beverages are possessed, served, or consumed under the permit) On Caterer's Permit Application AB-04 the licensee identified James Allen as the "licensee, employee, or agent who will be present." Upon request to speak to Mr. Allen, Director Wilson was informed he was not on-site and was not in Anchorage. He was alleged to be flying back to the State at the time of the event. The Director confirmed with Mr. Alvarenga at the close of the event that Mr. Allen was at no point present that evening. Moreover, Mr. Alvarenga who stated he was the agent of the licensee admitted to leaving the catered event. Mr. Alvarenga had no intent to return until directed to do so by the Director. In a subsequent communication, Mr. Alexander stated Mr. Allen was hospitalized in Las Vegas at the time of the event. Nevertheless, the licensee chose to hold the event in his absence rather than cancel it or identify in writing to the Director the licensee, employee, or argent who would be present on running the event in Mr. Allen's absence.

- 4. AS 04.21.030(1) Responsibility of Licensees, Agents, and Employees. The licensee has a duty to exercise that degree of care that a reasonable person would observe to ensure that a business under the person's control is lawfully conducted, including, but not limited to acting with reasonable diligence to determine that agents or employees are advised of the provisions of this title and the regulations adopted under this title. Although not identified in the application, Director Wilson was informed by Robert Alexander at approximately 2345 on 11/12/22 that Jorge Alvarenga, the alleged agent of the licensee, had left the event for the evening. As such, no representative of the licensee was present until his return was requested by Director Wilson. Mr. Alvarenga returned on site at 0020. Mr. Alvarenga further informed the Director that signs were up and in place prior to the event and must have been torn down. This representation is contrary to the representation of Ms. Alexander, Mr. Alexander's wife, who informed the Director the signage was provided to her and/or Mr. Alexander for posting. Mr. Alvarenga appears to have been dishonest with the Director.
- 5. AS 04.11.010 (a person may not knowingly sell, offer for sale, possess for sale or barter, traffic in an alcoholic beverage unless under license of permit issued under this title); AS 04.11.230 (a caterer's permit may only be issued for designated premises for a specific occasion and for a limited period of time) -- Violation of the Conditions of the Caterer's Permit; Sales of Alcoholic Beverages After The Designated Time of Closure. In its communication to the licensee forwarding the caterer's permit, the correspondence stated in bold letters "Please Pay Attention to the AMCO Comments section of every approved permit for any additional instructions/conditions by our enforcement team." An express condition of the permit in the additional instructions stated, "Event is only approved to 2 a.m., not the requested 3 a.m. Crowd control at closure is a must outside." On November 10, 2022, The Director reiterated that requirement verbally to Mr. James Allen, the individual designated on the permit application as responsible for the event, and in writing to Mr. Allen and Mr. Alonso Gallo, the individual Mr. Abraham Gallo designated to contact AMCO in an email stating: "I am verifying that you have received this approval of the caterer's permit application. Please note the limitation on the time for the event." On 11/13/22, before leaving the initial inspection of the premises at 0020, the Director verbally informed Mr. Alvarenga outside where there was no question of his ability to hear her that per the conditions on the application the event ends at 2 a.m. and all guests must have left the licensed premises at that time. The Director also directed Mr. Alvarenga of the requirements for crowd control at exit. APD Officers present informed Mr. Alvarenga that the exits should be staggered and started at 0115 am so the premises may be emptied by closure time. The Director informed Mr. Alvarenga that she would return at 0200 to verify compliance. The Director did return at 0200. She witnessed loud music still coming from the premises and new patrons being permitted inside the facility. The parking lot adjacent to 420 W. 3rd Ave, was full and additional vehicles were parked in the parking lot across 3rd Avenue. The Director requested officer assist and continued to observe additional patrons entering the facility and music emanating from the premises. With APD Patrol assistance the Director approached the customer door at approximately 0220 and requested Mr. Alvarenga to come outside. Another welldressed individual joined Mr. Alvarenga stating he also worked from Mr. Gallo. The Director directed Mr. Alvarenga to close down operations. Mr. Alvarenga stated that notwithstanding the Director's direct statements to him (as witnessed by APD) the front page of the permit identified the event as ending at 3 am and as such he believed the event and the sales of alcohol could continue. The Director reiterated her statements and showed Mr. Alvarenga the conditions of closure on the permit, which he alleged he had not seen. Mr. Allen who was identified on the application as the person who would be on site for the event and who was also expressly made aware of the 0200 closure was not present and was out of state. Mr. Alonso Gallo was also not present.
- 6. AS 04.21.030(2) Responsibility of Licensees, Agents, and Employees. The licensee has a duty to exercise that degree of care that a reasonable person would observe to ensure that a business under the person's control is lawfully conducted, including, but not limited to compliance with public health, fire, and safety codes and ordinances. Violation of AMC Municipal Fire Code. The crash bar on exit doors on the western side of 420 W. 3<sup>rd</sup> Avenue were tied shut by wire (photo enclosed) creating a danger to the public.
- 7. AS 04.16.150 Duty of Licensee over Agents. A licensee may neither knowingly allow agents or employees to violate this title or regulations adopted under this title nor recklessly nor with criminal negligence fail to act in accordance with the duty prescribed under AS 04.21.030 with the result that an agent or employee of the licensee violates a law or regulation. Based upon all of the above, the licensee exercised such insufficient control that it knowingly violated the statutes, regulations, and ordinances

identified above and/or recklessly or with criminal negligence failed to act in accordance with the duties set forth at AS 04.21.030.

8. Apparent Supplanting of License and Intentional Misrepresentation to the Director, AMCO Enforcement originally denied the permit, finding that "Mr. Robert Alexander [holder of the LED Lounge/Tri-Grill license] was attempting to use Mr. Abraham Gallo's licenses to supplant for his license at this location." Mr. Abraham Gallo directed Mr. Alonso Gallo to contact the Director to appeal the denial. The Director spoke to Mr. Alonso Gallo and Mr. James Allen and received numerous assurances that but for bartending Mr. Alexander was not running the event. Mr. Allen changed prior advertisement to remove any reference to LED Lounge and required the removal of the advertisement of the event from the LED Facebook page. Based upon these representations, the Director approved the caterer's permit. However, upon her arrival at the event, it became clear that Mr. Alexander was indeed running the event. Mr. Alexander was the only person present at the event when the Director arrived. When asked where the permits and signage was Mr. Alexander directed his wife to print and post the permit and signage. The Director spoke to Mrs. Alexander. Mrs. Alexander showed the Director the email the licensee forwarded to Mr. Alexander that included the permit and its conditions. Outdoor security at the event reported to Mr. Alexander. Based upon the Director's own observations at both times she inspected this event, it became clear the licensee and his agents intentionally misinformed the Director for the sole purpose of financial gain. When combined with bounded crash doors preventing exit of the public from the facility in the case of an emergency, the licensee and its agents have engaged in conduct wholly unbefitting of a licensee and can expect an accusation for revocation or suspension of license 4109 to follow.

Subject: Response to Notice of Violation (NOV) dated November 14, 2022.

This is a response to the notice of alleged violations. Please accept this letter as further explanation to the stated violations as they were not committed with intent to deliberately disobey.

1. AS 04.21.065 – Failure to Posting Warning Signs; 3 AAC 304.185 – Failure to Post Permit: A copy of the permit was emailed to Mr. Allen to post at the location. Prior to the event he was in Las Vegas, NV for nearly a week for a work conference. Mr. Allen is currently a Human Resource Director of a large Native Corporation in Alaska. He is highly trained to write and follow policies to include following the directions given to him from the Director of AMCO. His intensions were to fly into Anchorage for the event he created and to operate it with the best of his abilities. The Gallo Group was aslo aware of his plans however, while expecting him to arrive he did not. Due to his no show, this caused a few shortages and issue for the policies set by AMCO. The following morning, we became aware that Mr. Allen was found in his hotel room in pain. Thereafter, he was admitted to Sun Rise Hospital in Nevada for a tear in his heart. At this time the information was forwarded to Director Wilson. As of today, Mr. Allen is still in the hospital and is currently fighting for his life.

Mr. Alexander was listed on the permit application as one of the staff members. While understanding the issue with his business and the location, this group was happy that he was there to step in with his years of experience to see that operations ran smoothly with no problems while staying within compliance of the law. Mr. Alexander continued to stress the importance of safety for the neighbors and customers.

**2. Service of Alcohol by Individuals Not Identified in the Caterer's Permit Application:** The permit was issued on 11/10/22. We learn on 11/12/22 one of the staff members could not make it in to work. We filled the position /changes but was not able to contact AMCO because the office was closed until 11/14/22. While we made the change, we ensured that the two people had their TAM cards on hand.

**3. AS 04.16.210 – Penalty for making false statement:** Mr. Allen had planned to go to the airport early Saturday (11/12/22) to standby for an earlier flight back to Anchorage to help with set up for the event. He was carried out the hotel in a stretcher and never made it to Alaska. He is still in the hospital today. He had full intension to be at the event and to manage it.

4. AS 04.21.030(1) – Responsibility of Licensees, Agents, and Employees: Mr. Alexander stated he had mentioned to Director Wilson that George had left 15-20 minutes ago with plans to return. He was able to get a hold of Jorge to tell him Director Wilson wanted him back on the site right away. Jorge did return within 20-30 min and stayed until the end of the event. Jorge is the project manager for The Gallo Group who oversees the construction at that location. He was there a great part of the day however he left for dinner. Due to Mr. Allen not being present, Mr. Alexander was left to oversee the event until Jorge returned. When Jorge return Mr. Alexander continue to help until the end of the event. Jorge was not aware of the correct sign to be posted. He assumed that the Director was talking about Alcohol land use permit that has been posted for several months.

5. AS 04.11.010 (a person may not knowingly sell, offer for sale, possess for sale or barter, traffic in an alcoholic beverage unless under license of permit issued under this title); AS 04.11.230 (a caterer's permit may only be issued for designated premises for a specific occasion and for a limited period of time) -- Violation of the Conditions of the Caterer's Permit; Sales of Alcoholic Beverages After The Designated Time of Closure: Jorge remembered having a conversation with the Director regarding closing. He also stated while he was talking to the Director there was a large presence of police officers near him and that he was afraid of being arrested. After the Director left, Jorge recalled that she mentioned something regarding time of closing. So, after Ms. Alexander posted the signs he went to check to see what was on the posted permit and saw that it stated 3am. He mentioned that to the Director when she returned. Jorge knew the Director had concerns; he would not continue making the problem larger by ignoring what the Director wanted. When the Director returned and started the closing time, Jorge with the help of Mr. Alexander shut down the event and cleared of customers from the building within 10-15 min. While several hundred customer all left in a hurry out the building and the adjacent parking lot they did it calmly and very peaceful.

6. AS 04.21.030(2) - Responsibility of Licensees, Agents, and Employees: The door in picture was used only for delivery for that event. Since Mr. Alexander added a door to the front of the building that door is no longer needed for egress for the 1<sup>st</sup> floor. It is now used for egress for the upstairs unit only.

7. AS 04.16.150 – Duty of Licensee over Agents: Base on the responses above our intensions were not to violate the statues, regulation or laws. However, we have certainly learned from our mistake, and it will ever happen again.

8. Apparent Supplanting of License and Intentional Misrepresentation to the Director: As we pray for Mr. Allen's full recovery, we also believed that if Mr. Allen could have made it to the event safely most issues would not have taken place and would not have caught us off guard. With understanding the issue at hand with Mr. Alexander's business and the MOA, we were grateful to have had him present and to fill-in the unexpected position to help lead. Due to it he was able to help get what the Director needed, keep the peace with the neighbors, and most of all he helped with the safety for nearly 400+ customer who came and left.

Upon entry of the bar the bartender Gabe Almenzor approached the officer and informed him and underage male individual (20 yo) was in the bar and asked if he could finish his food real quick since it was only five minutes past when persons under 21 had to be out. The individual was previously known to the officer and told the officer he was going to be a huge problem. Officer Connolly escorted the underage male individual out of the premises.

During the subsequent investigation and interview with the owner Tina Steffen, it was determined the bartender did not understand the Hill Bar was not designated a restaurant and that underage individuals were not allowed inside the premises without a parent, legal guardian, or spouse who is twenty-one. The owner also alluded the fairness of it due to another bar across the street allowing underage individuals inside the premises for the purpose of dining.

On 05/10/2022 Chief RJ Ely contacted Investigator Steven Johnson of AMCO to verify Hill Bar #1328 does not in fact have a Restaurant Designation Permit and recommend a Notice of Violation be issued. The above described is a violation of:

AS 04.16.049 Access of persons under the age of 21 to licensed premises.

#### I am so sorry. I misunderstood the notice.

In regards to the violation. I agree with most of the content, but definitely not all of it.

- 1) It is true that Gabe Almenzor was a new bartender and did not understand the law and/or differentiation between why underage can be in the Craig Inn for the purpose of dining, but not the Hill Bar. We failed to explain the difference to him, but I also do not believe that the Craig Officers fully understand all of those laws either I say this, because when I asked Chief Ely if they had a designation permit, he did not know. I knew, because I've tried to get one and know that Zat's Pizza has Craig's only allowable Designation Permit. I have had an employee meeting since then and have driven home the point with all current employees and will with all future employees. Gabe assumed that since Bowen was in the bar, and only eating chicken strips, and was with his brother, that it was ok. He knows the laws now, as well as all of our employees and we are doing our best to educate our customers. Gabe's fault in this matter, is that he was mistaken about parent/guardian vs. brother for a customer who is a legal adult and his parents don't live here.
- 2) The interaction with Mr. Price, did not quite go like it was reported in the Notice of Violation. The middle interaction was missing. When Gabe asked the officer if Bowen could stay, Officer Connolly said it would be fine and joked saying it would be ok as long as Bowen wasn't going to be a problem (referring to their previous interactions). The officer then asked Bowen if he planned on being a problem, in a light, joking manner, and Bowen replied that he did in fact plan on being a problem and had a bad attitude. Gabe went to the back room to get supplies and when he returned moments later, everyone was gone.
- 3) Officer Ely did inspect the property and took pictures of the warning signs. These warning signs have been in the same place by the front door for easily 20 years. At his suggestion, I posted another one at the entrance.

My comments to the officer and Mr. Johnson were that we do everything we can to obide by the law. My frustration is that when TKs at the Craig Inn opened up on the Craig Inn premises, the cut and dry law of no minors allowed in a bar became merky. Especially to the 18, 19, and 20 year old population (which includes Bowen and until recently, Gabe). I stated that before TKs opened, every other generation knew that underage kids weren't allowed in bars. Our bar has always had a house rule of NO ONE UNDER 21. During the Covid times, we were scraping for business and started allowing kids to come in with parents until 7pm for dining purposes only. I showed a copy of that House Rule to Officer Ely. Unfortunately, this policy grayed the line even more and our employees mistook the House Rule for AK Law. We hadn't thought about the fact that we need to teach these younger employees about the laws and designations. Even with training, they still don't agree, because of how other local businesses are run and because there are SO many establishments in Alaska (who I'm sure have designation permits) where they see food and alcohol and minors on a regular basis. Unfortunately for us, Zat's owns Craig's only permit and they don't even have dine-in anymore. I feel like the laws don't make sense to me as an owner, so how can they make sense to a bartender? Or customers? Bowen was there with his brother for the sole purpose of dining and blew 0.0 on the breathalyzer.

I am sorry for our part in this matter and realize that we are responsible for understanding the laws and educating our employees. I can assure you that we have taken this very seriously and have taken the necessary actions to prevent it from happening again.

I do hope that you plan to make changes to the laws regarding the number of Restaurant Designation Permits allowed in communities.
