Requested Action:

Reinstatement and renewal of license with consideration of population counts.

Statutory and Regulatory Authority:

AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.540: "...If a complete application for renewal has not been filed by February 28 or the required fees and the penalty fees have not been paid by that date, the license expires at 12:00 midnight February 28."

- 3 AAC 304.160(f): "The board will deny a request for reinstatement submitted under (e) of this section if
- (1) the license became available in accordance with 3 AAC 304.100(2) and wasissued to a different applicant, unless the limit of licenses under AS 04.11.400 has not been reached; or
- (2) the board finds that the failure to timely file or pay was caused by
- (A) the licensee's failure to notify the board of a change of the licensee's mailing address;
- (B) a transfer of ownership of the business for which the license was issued without written approval of the board in violation of AS 04.11.040;
- (C) a lease of the licensed business to another person in violation of AS 04.11.450(c); or
- (D) any other action of the licensee whether active or tacit that the board finds constitutes a failure to lawfully operate the business for which the license was issued."

**Staff Rec.:** Evaluate reinstatement request in accordance with 3 AAC 304.160(f).

**Update:** At the November 2, 2021 Board meeting the application(s) were tabled with a directive that the applicant attend the next meeting and make himself available to answer Board questions. At the January 18, 2022 Board meeting Dayton MacCallum, co-owner, was present and provided reasons why they were late with the renewal application including that the building burned own, there have been insurance issues, construction issues and finally Covid. Sarah Oates, President and CEO of CHARR, provided historic perspective on population limits and reinstatement/renewal

restrictive language that didn't exist until mid-2018. Jane Sawyer, Regulations Specialists, gave information on how population figures are calculated and that these figures are updated April 30 each year for the previous year. A possible new regulations project is discussed. Co-owner Nathan Davis requests the board to table the issue and give him a chance to discuss with local government and get new population numbers. The Board tables the issue until the June 28th meeting. On December 10, 2021 the Fairbanks North Star Borough waived protest for the reinstatement and renewals for both licenses. A new population count is posted on AMCO website dated 4/30/2022 with updated population figures.

**Background**: For license #4834, BDL – Duplicate, during the 2020/2021 licensing period, a renewal application was not submitted by the February 28, 2020 deadline. A warning letter was mailed and emailed to the licensee on February 10, 2020 and the expiration and cessation of operations letter was mailed and emailed on March 9, 2020.

For license #3195, BDL – master license, during the 2021/2022 licensing period, a renewal application was not submitted by the February 28, 2021 deadline. A warning letter was mailed and emailed to the licensee on February 2, 2021 and the expiration and cessation of operations letter was mailed and emailed on March 5, 2021. The licensee has submitted a request for reinstatement, paid all required fees and the renewal applications were deemed complete on October 11, 2021.

**Population Count:** Per the population count dated 4/30/2021, The Fairbanks North Star Borough allowed for 22 beverage dispensaries and there were 22 in existence. Per the updated population count dated 4/30/2022 the Fairbanks North Star Borough allows for 21 beverage dispensaries and there are currently 22 in existence, not including this one.
