Requested Action:

Transfer license application for Beverage Dispensary-Tourism license.

Statutory and Regulatory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.400(d): "The board may approve

- (1) the issuance of a new beverage dispensary or restaurant or eating place license without regard to (a) of this section if it appears that the issuance will encourage the tourist trade by encouraging the construction or improvement of
 - (A) a hotel, motel, resort, or similar business relating to the tourist trade witha dining facility or having kitchen facilities in a majority of its rental rooms and at least a minimum number of rental rooms required according to the population of the incorporated city, unified municipality, or population area established under (a) of this section in which the facility will be located, as follows:
 - (i) 10 rental rooms if the population is less than 1,501;
 - (ii) 20 rental rooms if the population is 1,501 2,500;
 - (iii) 25 rental rooms if the population is 2,501 5,000;
 - (iv) 30 rental rooms if the population is 5,001 15,000;
 - (v) 35 rental rooms if the population is 15,001 25,000;
 - (vi) 40 rental rooms if the population is 25,001 50,000; and
 - (vii) 50 rental rooms if the population is greater than 50,000; or
 - (B) an airport terminal; and"
- (2) the renewal or transfer of ownership of a beverage dispensary or restaurant or eating place license issued under (1) of this subsection if the
 - (A) holder of the license operates a hotel, motel, resort, or similar business relating to the tourist trade that
 - (i) has a dining facility on the licensed premises or kitchen facilities in a majority of its rental rooms; and

(ii) maintains at least the minimum number of rental rooms that the hotel, motel, resort, or similar business had at the time of initial licensure or that were required at the time of initial licensure; or

(B) licensed premises are located inside an airport terminal.

Staff Rec.: Approve with delegation

Background: This is an application to transfer a Beverage Dispensary – Tourism license to Delta Sky Club LLC.

AS 04.11.400(d)(2)(B) requires that the facility must be located in an airport terminal. Staff has determined that the license is compliant and is located in the Ted Stevens Anchorage International Airport terminal.

1. Explain how the issuance of a liquor license at your establishment has/will encourage tourism.

Delta Sky Club located at the Anchorage International Airport (ANC) is a hospitality lounge for certain customers of Delta Air Lines, Inc. ("Delta"). Delta has several flights daily to ANC with increased service during peak travel season. Delta Sky Club provides a variety of complimentary snacks, beverages (alcoholic and non-alcoholic) and services, as well as satellite televisions, newspapers and magazines, restrooms and free Wi-Fi. Customers over the age of 21 can purchase premium alcoholic beverages.

2. Explain how the facility was/will be constructed or improved in accordance with this application.

Delta Sky Club is an ~80-seat hospitality lounge that includes a full-service bar. Delta Sky Club has been operating in its current location at ANC since June 2021. Host Chen ANC FB LLC ("Host") holds Beverage Dispensary Tourism Liquor License #5469 for the premises. Compass Group USA, Inc. manages the use of the liquor license and provision of alcohol within the premises, and Delta operates the premises. Delta has entered into a Sublease with Host for the premises, and Host and Delta are seeking to transfer License #5469 from Host to Delta via this application.

3. Who operates the facility for which a liquor license is being applied?

Alan Rosselot is an Affiliate of Delta Airlines, Inc., who operates the tourism facility in which the license is located. Delta Airlines, Inc. currently operates ~55 Delta Clubs throughout the U.S.A. All staff that serve alcohol in the Delta Sky Club at ANC are TAP or eTIP certified and are dedicated to serving alcohol in a responsible manner.

4. Do you offer room rentals to the traveling public? N_0 .




