This letter is in response to the NOV issued to my client, Klondike's Pizzeria, on May 26, 2021.

Seasalt Bar and Grill, like many Alaska hospitality businesses, has reopened in stages and has suffered from low staffing and frequent staff turnover. The employee instructed by you in August of 2020, Chip Duggan, is no longer with the business. Mr. Duggan did not pass your verbal warning along to ownership. He did not take care of installing the signage left by you so the ownership was unaware that there was an issue. As reflected in your NOV, it is not that there were no signs, it was that one sign was missing and you indicate that the other signs that were posted had been "shrunk" to 8 inches by 10 inches.

The restaurant has corrected the signage issues identified in the NOV. The new staff has also been instructed that the signage must remain true to size. The ownership of the restaurant is motivated to comply with signage requirements and all AMCO regulations. Undersigned counsel is scheduled to visit the restaurant on July 9, 2021. At that time, I will

personally check the signage and provide additional reassurance to you that it is correct.


