



We have received attached the Enforcement violation letter from AMCO for the Liquor Store, package store license 469. The licensee, Dong Jae Choe, purchased and started operation in August 2022. He had two separate cash registers to segregate alcoholic sales and other item retail sales. However, he did not realize that he had to use separate register until he was caught by the enforcement.

Since we received the letter of violation, the Licensee took following actions.

1. Setup separate cash registers for retail and alcohol sale (pictures attached)
2. Ordered separate credit card processing machine through the processor, CDS, on 12/26/22. CDS told the licensee that new credit card processor will be delivered and installed by end of this week.

The violation was a result of licensee not understanding the requirement to have total segregation between alcohol and other item retail.



We received a Notice of Violation #3AAC 304.525 (License #3304) on December 28th, 2022. The Notice is about an incident at our Red Robin Tikahnu location restaurant (1190 N. Muldoon Road) that occurred on December 27th, 2022. The AMCO Case number is #22-2369. This letter serves to provide you with the actions we have taken at our restaurant to cure the violation and to prevent this type of incident from occurring again.

After receiving the notice, we reviewed all the other employees that work at this location to verify that all relevant employees have a valid unexpired TAP card not only on their person, but also on file in the office area located in the back of the restaurant. As an extra precaution, we engaged our payroll processor, ADP to generate a biweekly report indicating the upcoming expiration dates of current TAP's cards. This report will be reviewed by our Support Office each payroll cycle, to ensure that reminders are sent to the managers of our Red Robin locations about upcoming TAP card expirations.

The employee that was involved in this incident, Mr. Clayton Randolph, has been a very responsible member of our staff. He has taken immediate action to get his Alcohol Certification card. He is enrolled at the next available class to get that certification on Tuesday, January 10th, at 10AM. Mr. Randolph has also been instructed not to have any type of contact, cleaning, service, order taking, or inventory of anything containing alcohol, or to go behind the bar under any circumstances until his certification is completed. I will also send you a copy of Mr. Randolph's certification on Tuesday, after his course is completed.

We hope and trust that the actions we have taken will not only satisfy the AMCO with respect to this incident, but that it will strengthen our procedures to prevent this type of incident from ever occurring again.
