She goes on to speak to her report, including the new approach to looking at controlling interest applications which includes looking at the company's operating agreement instead of basing it solely on the 50%+ formula; marijuana licensing coming on board to AKACCIS; possibility of a local government portal in AKACCIS; short staff issues; reclassification of licensing examiners. Board comes out of deliberative session at 12:07pm.

Doug Moore moves to accept the Administrative Law Judge's decision as final on OAH 23-0585-ABC. Jan Hill seconds. No desire from board members to accept comments from involved parties. No discussion among board members. Doug, yes. Diane, yes. Jan, yes. Dana, yes. Motion carries 4-0.

● **PETITION UNDER AS 04.11.405.**

**Board to hold a public hearing as required by AS 04.11.405(b)**

**Haines Borough petition for additional Restaurant or Eating Place Licenses**

**TAB 9**

***Dana W. introduces the petition under AS 04.11.405. Doug M. moves to open public hearing in regards to the Haines Borough petition for additional Restaurant Eating Place licenses. Diane T. seconds. None opposed. Motion carries and public hearing is opened.***

*Dana W. notes the calculations of visitor counts used DEC information relating to cruise ships and their passenger amounts. Jane S. comments the Haines Borough is available and can take questions on their visitor count calculation. Doug M. asks if letters are included and Diane T. answers the letters are in the tab (Tab 9). Diane T. asks the Haines representative if they put this out for public comment in Haines. Gabriel G. comments that Annette Kreizer, borough manager, is on the call to take questions and people from the Haines Visitor Borough. Rebecca Hilton, tourism director for the Haines Borough, states that Annette Kreizer soon to be available but she will begin on her behalf. Rebecca Hilton speaks to the public comment process but notes Annette Kreizer now available. Dana W. comments the board requests information on the public process in Haines. Annette Kreizer goes over the public process in Haines for the resolution to*

*request additional licenses. The packet is published every Monday and the meeting is held the following Tuesday. She notes that at least two persons testified in support at the assembly public meeting. She adds that there was also a commerce committee hearing on this topic as far as public process. Diane T. comments it appears that the public was not given enough notice and only two people testified and the period for public comment was not long enough.*

*Annette Kreizer comments that it appears the draft minutes from the assembly meeting in question are not included in the packet the board is considering due to office turnover and that the minutes would have shown the public comments. Dana W. notes the resolution passed and asks what the vote was. Annette Kreizer states the vote was unanimous. Jane S. advises that the comments will be available for the board to view in a few moments.*

*Dana W. opens up the meeting for public testimony. Paul Thomas, owner of Package Store license, opines no action should be taken on this petition because the public couldn't view the agenda and board packet in time. He states that notification (of the public) and the criteria for qualifying should be set in regulation and speaks to Juneau's attempt to add licenses as an example. He states that there should be no licenses for sale as part of the criteria for allowing additional licenses and there is duplication between using visitor counts for both additional licenses and for seasonal restaurant tourism licenses. There should be clear guidelines and regulations before issuing more licenses beyond what the cap allows.*

*Joan W. comments that the board complied with the statutory mandate and met requirements and is following regulation. Diane T. asks if the cap of licenses is met in Haines. Jane S. answers yes. Gabriel G. comments Haines Borough has 2 restaurant licenses possible under the cap and currently has 3 licenses.*

*Via Palankis, owner of food truck in Haines, and supports the motion as it would help small businesses to create more brick and mortar places. Supports using tourism numbers to help grow local food economy. Doug M. asks if granting additional licenses would encourage Ms. Palankis to open a brick and mortar? Via Palankis answers yes but others small business owners will also be helped.*

*Sarah Oates, with Alaska Charr, agrees with Mr. Paul Thomas's comments. She disagrees with how Haines calculated its visitor population. Seasonal Restaurant tourism licenses could be an avenue for the business owners in Haines and adding 10 additional licenses is too many. She speaks to calculations on visitor counts for seasonal restaurant tourism licenses and encourages the opening of a regulations project to give guidelines on this. She also comments the public in Haines did not have enough time to engage in the public process.*

*Doug M. asks questions on Valdez petition. Jane S. and Gabriel G. give information on board approvals of Valdez with 10, Wasilla with 20, Soldotna with 20. Joan W. speaks of Juneau's petition that was then withdrawn and notes a city may request additional licenses every 2 years. Board discussion on timelines and application process time frames.*

*Annette Kreizer references Sarah Oates comments and clarifies that a seasonal license is not what Haines is asking for and Haines wants year round licenses and notes that Haines is asking for 'up to 10' additional licenses for brick and mortar stores.*

*Doug M. asks on process for Haines if petition denied. They could potentially come back at the next scheduled board meeting to reapply. Joan W. affirms that they can come back as often as they wish to.*

*Evan Wood, with Devils Club Brewing Company, speaks in support of the petition in Haines and comments that the legislative intent is to provide more municipal control for Haines and he is in favor of this. The purpose of*

*the board is not to protect the private investments of license holders. This type of license requires more food sales than alcohol and is not a risk to public health and there is no need for additional regulation.*

*Melissa Snell, wife of Kelly Jessup who owns Fogcutter Bar in Haines, states she will read Kelly Jessups letter. Mr. Jessup is against additional licenses and states adding more licenses does not fill the existing need. Tax values will be diluted and the value of existing licenses will be devalued.*

*Kristy Fowler, co-owner of Pioneer Bar in Haines is against this petition. She speaks about the difficulties of making a living in Haines year round and notes her establishment operates at a loss every winter. Through much hard work they now wish to sell their license and were banking on that and are blindsided by this petition for additional licenses. The Haines Borough did not take the needed steps to reach out to them especially during the busy summer season. She feels they had no opportunity to provide input and is now forced to defend their property which will be devalued if this passes.*

*Dana W. gives instruction on how to unmute yourself or raise your hand to provide comments.*

*Barbara Pardee, community member since 1970 and owned pizza restaurant for 12 years, states most community members didn't know this petition was going on. It is reckless to increase the number of licenses from 3 to 13 without any input from the community. There are many community members that prefer not to drink alcohol and just want a place to eat. There was no community input in her opinion.*

*Zach Wensol, Chilkoot Indian Association, is in support of adding the additional restaurant licenses. The Chilkoot Indian Association plans to open a restaurant along the waterfront. Haines is a notoriously difficult place to manage and being able to serve beer and wine would help with economic sovereignty. He states the Chilkoot Indian Association council voted unanimously to support the Haines Borough petition.*

*Diane T. asks if the Chilkoot Indian Association could apply for a seasonal? Joan W. states yes but that they wanted a year round and a seasonal might not meet their business needs. Board discussion with AMCO staff on requirements to apply for a seasonal restaurant tourism license.*

*Carrie Jaymont, owner of the Fireweed, comments on her experience buying a restaurant with a 'beer and wine' license and that now she is in the process of selling it (the license). She learned about the Haines Borough resolution after the fact and was unable to give public comment. She is concerned her license, now up for sale, will be devalued.*

*Dana W. notes it is now 11:32 and asks to table discussion to go into deliberative session scheduled for 11:30 and then come back to testimony after lunch, at 2pm. Board discussion.*

***Doug M. motions to table the petition public hearing and reconvene it at 2pm and move to deliberative session. Jan H. seconds. None opposed. Motion carries.***

*Dana W. reconvenes public hearing and reopens to public testimony.*

*Michael Ward, Lighthouse Bar and Restaurant, is against the petition. He states it is very difficult to successfully operate a year round restaurant in Haines. Adding 10 additional licenses to Haines is problematic and that is too many for small town. Winter operations are already difficult in Haines and there will be too much competition. The public didn't have much of an opportunity to discuss it because all business people were too busy and the assembly did not take the existing business people's perspective and the community in general did not get to weigh in on this.*

*Noland Woodard, owner of Alpenglowl Wood-Fired Pizza in Haines, comments that he is the person that got the petition to add additional licenses started and had a large role in the process. Noland Woodard gives history of his operations and how he came to begin this process. He comments on the background of why 10 licenses are asked for in the petition. He notes the wording is 'up to' 10 licenses not '10 licenses' and feels that the community is served by adding these licenses. He notes some licenses in Haines are not operated right now. Older businesses benefit but newer businesses are at a disadvantage. The main intent is to help the Haines community grow.*

*Sammons, unable to unmute or call in to speak in another way, comments in chat that he is in support of the petition.*

*Travis Kewkoll, runs catering business in Haines, is in support of the petition. Diversity of business offerings is good for business and is a boon for Haines. Young people need to have opportunities for their businesses.*

*Robert Chadwell, co-owner of Adventure Harvest in Haines, supports petition and states Haines needs revitalization and new investment. He notes some of those opposed to the petition are seeking to divest from the town and that only current license holders are in opposition with most community members in support.*

*Paul Thomas, Juneau package store owner, hopes that unused licenses in Haines mentioned by prior commenter is considered by the board before adding new licenses.*

*Via Palankis, owner of food truck in Haines, , reads a letter from Sarah Bishop-Cohen owner of restaurant in town that has an alcohol license and who is in support of the petition to increase the number of licenses.*

*Kristy Fowler, owner of Pioneer Bar, states that it should be hard to get an alcohol license and suggests that the ABC returns to the 'public convenience' license type. She notes that in winter the population drops by half and there is now a brewery, meadery and distillery now exist and are also competition. The new statute puts too much power in the hands of local government and recounts her conversations with the mayor. She has put a lot into serving this community, employs over 20 young people in the community and has played by the rules.*

*Jacob Rynelle, manager at Alpenglowl Pizza restaurant, states that the brewery and distillery are tasting rooms with a drink limit and prior comments on this seem wrong. He says there was a public process and that older businesses should not make it harder for newer businesses.*

*Noland Woodard, owner of Alpenglowl Pizza restaurant, notes there are licenses available in Haines but that the licenses are not for sale by themselves but you must buy the entire existing business and building. There are no licenses available in this respect. He followed the process to add new licenses by the book and took all measures required by the state. Asks the board to allow Haines the opportunity for economic growth and provide for the Haines community.*

*Margarett Jones, Haines resident and waitress and bartender, is against the license increase and comments that it is not enough for a business to serve beer and wine to exist successfully in Haines. She is against increasing the drinking establishments in Haines. She states there is one possible seasonal restaurant tourism license and one restaurant license for sale that are available. The population limit should not be discarded. Ten licenses are too much of an increase. The public comment process was not robust enough.*

*Travis Kewkoll, runs catering business in Haines, comments that there was more than adequate opportunity for the public to provide input.*

*Dana W. asks for further testimony and sees none. Doug M. motions to close public comment. Diane T. seconds None opposed. Motion carries, public comment closed.*

*Dana W. asks the office if the board may approve less than 10 licenses. Jane S. answers yes. Dana W. asks the office, if 10 licenses are approved then they are available, and anyone can apply? Jane S. and Joan W. answer yes. Board discussion touches on consideration of what is in the public interest. Diane T. asks if public convenience licenses completely went away with title 4. Jane S. and Joan W. answer yes. Doug M. comments on the number of licenses asked for in the petition and the history given by Noland Woodard on how that number was arrived at. Diane T. opines that there wasn't enough public input. Board discussion on Haines Borough public input process. Doug M. asks Joan W. for wording to Haines Borough that the board prefers more robust public input. Joan W. gives possibilities and options. Board discussion on what the statute requires for this application from the applicant. Jan H. comments she agrees with the comments that the public input process seems to have been rushed through the Haines assembly. She agrees with Diane T. that the public input was not robust enough and that there should have been more effort from Haines Borough to receive public comment. Dana W. agrees it seems there was not a lot of time for public comment. Doug M. comments on timeframes for licensure, timeframes for this petition process and that in any case this summer season will be over before any resolution of this issue. Dana W. raises concerns that the application itself was flawed as the application only used tourism numbers. Board discussion on legislative intent for this license type and populations counts that can be included to support the application. Jan H. comments that when people in Haines heard the number 10 this was a scary number and a lesser number would have been a better option.*

*Kevin H. summarize options before the board. Diane T. motions to deny petition. Doug M. seconds. Board discussion. None opposed. Motion carries, petition denied.*

**1. Package Store Orders and Manufacturer Direct Shipments** **TAB 75**

**Status:** Public comment closed June 3, 2024. Comments were received.

**Board action:** TBD at meeting

*Dana W. introduces the project and Joan W. opens the discussion. Dana W. notes written comments received were considered. Dana W. gives options regarding what actions can be taken and calls for the will of the board. Board discussion. Kristina S. gives overview of changes and amendments Dana W. notes Alaska Liquors USA comment that age verification system be allowed for package store licensees as well. Kristina S. clarifies that package stores are allowed to use age verification system but must retain a copy of an approved age identification document. She adds that this requirement was kept due to package stores shipping to local option communities. Joan W. comments that the regulations are separated into two sections, one for package stores, one for manufacturer direct shipment licensees. Dana W. asks if the board wishes to amend the draft as written. The board has no desire to amend. Joan W. comments that public comment is closed, and Kevin H. agrees. **Diane T. motions to adopt the regulations and send to law for final review. Doug M. seconds. None opposed. Motion carries.***

**B. Board Consideration**

**1. Alcohol for Non-beverage Use.**

**TAB 76**

**Status:** For board discussion.

**Potential Board Actions:** TDB at meeting

*Joan W. summarizes the regulations project and authority under Title 4 rewrite to regulate alcohol for human consumption. She gives overview of production of rhodiola (an alpine plant) extract (tincture) for health reasons. The production of rhodiola tincture uses food-grade ethanol to product this product. The manufacturer of rhodiola tincture must seek out-of-state producers to obtain the food-grade ethanol (non-denatured alcohol) and so the intent is to allow the producer to purchase from an in-state producer and support local industry. Covid era production of hand sanitizer is an example. Board discussion. Doug M. opines that the board should facilitate the purchase of food grade ethanol from in-state suppliers. Kristina S. notes that there is a potential fee for the application and this is a discussion point. Board discussion on fees. Board agrees on fee per transaction of \$100. **Doug M. motions to open a regulatory project, send the amended draft with \$100 fee to law for initial review and then out for public comment. Diane T. seconds. None opposed. Motion carries.***

**2. Business License for Application.**

**TAB 77**

**Status:** For board discussion.

**Potential Board Actions:** TDB at meeting

*Diane T. mentions chat from Ana Fisk with Brown Jug who would like to speak. Dana W. states her request to speak was on the project for package stores and manufacturer direct shipment licensees and that public comment is closed for that regulations project. Dana W. notes her written comment was received and considered for that project.*

*Kristina S. summarizes the project and that the office would like to require business license information during the application process and mentions AK-ACCIS development issues allow for this. She states that AK-ACCIS can link their system to the State of Alaska business license and entity license systems for verification purposes. For best practice and efficiency this project allows for a better and more correct application process. Board discussion. Diane T. comments that she is for anything that creates a better process for the applicant and the office. Sarah Oates, CHARR representative, comments on possible complications between the dba listed on the business license and the establishment's actual dba. Joan W. notes we are at the stage of getting public comment. Jane S. comments that the wording is 'doing business as' so as to distinguish between dba (trade name) and entity name. Diane T. thinks just the business license number is sufficient. Kristina S. speaks about AK-ACCIS capacity to add the business license information into the application which could then be changed as appropriate by the applicant and mentions Zach Essary as an expert to refer to for business license rules in the state. Jane S. gives outline of how marijuana application processes work with business license information required. **Diane T. motions to open the regulations project, approve the draft to send to law for initial review and subsequent public comment. Jan H. seconds. None opposed. Motion carries***

**C. Trade Practice Regulations Status and Board Discussion on Amendments**

*Joan W. provides status on where trade practice regulations stand. The regulations went through final review from the Department of Law and were sent to the Lt. Governor for signature. The Lt. Governor received an additional comment and the Department of Law is in the midst of a subsequent review. Joan W. is not sure where the regulations are at currently. Joan W. mentions advisory sent out to licensees advising of this situation. Until the regulations are final she comments that all should 'act with caution'. Kevin H. comments that this project is in limbo and so is hesitant to advise the board to open any new project that will amend these regulations (that have not yet been made effective). Dana W. states that technically the regulations haven't gone through and so we couldn't open a new project on regulations that don't yet exist. Dana W. mentions legislative audit and this is a serious concern for the board.*

*Diane T. asks if there are exceptions on the federal level? Joan W. comments that we modeled our exceptions after federal exceptions. Joan W. notes she cannot give legal advice. Dana W. notes state law trumps federal exceptions. Kevin H. states the 21<sup>st</sup> amendment gives the state all the authority to act. Board discussion on federal and state exceptions. Lee Ellis, Brewers Guild, comments on AS 04.16.017(1) and notes this almost mirrors federal language.*

*Diane T. asks about line cleaning and Lee Ellis, Brewers Guild, clarifies. Dana W. brings up inducements such as a give away of a \$400 cooler. Lee Ellis comments that at the federal level give aways are not illegal but that it is in the proposed state trade regulations. Kevin H. speaks to Mr. Ellis' position and this interpretation and that this may be subject to disagreement. Kevin H. states the statute should speak for itself. Dana W. states this is a discussion only and not guidance for anyone absent the finalization of the trade regulations.*

*Sarah Oats, Alaska CHARR, comments the advisory notice was only sent to licensees and not those on the 'listserv' and therefore her trade association did not receive the advisory notice. Sarah O. does not agree with the information presented in the advisory notice that was sent and states industry members are disturbed by it. She is for opening up 'conceptual' trade regulations project at this time.*

*Lee Ellis, Brewers Guild, states that retailers/licensees are confused on how to act and would like guidance. Dana W. comments that retailers/licensees should be cautious going forward. Joan W. suggests she withdraw the advisory and that the licensees should look at the statute. Further board discussion. Dana W., Jane S. and Kevin H. speak about the coming weeks while Joan W. will be gone.*

*Scott Steward, Wholesaler representative, speaks on behalf of package stores and their uncertainty and confusion. Scott S. asks a question on line cleaning from the wholesaler perspective. Diane T. mentions she supports sending a follow up advisory out to the licensees. Joan W. points back to the advisory that was sent as providing the information needed. Board discussion on whether or if to send a subsequent advisory and, if so, how to word and present it.*

*Kevin H. outlines concerns with sending an additional statement/advisory. Mr. Degrasse, Wholesaler representative, opines more direction is needed on what can be done legally. Ana Fisk, Brown Jug/Liquor Stores USA North, comments either take back the advisory notice or further clarify what it means. She further adds that all operations at the 24 retail locations are upset. Diane T. reiterates she supports sending a follow up advisory notice to explain what the wait is for. Joan W. clarifies why there is a wait. Dana W. reads parts of the advisory notice out loud. He goes on to say that he can't disagree with any of those statements. Further board discussion on if additional guidance can be provided other than what already was and other than what is in statute.*

*Kevin H. hopes to have a response in his department in a few days but cannot know when the Lt. Governor's Office might response. Joan W. opines that the board consider opening a regulatory project based on board members Doug M. and Diane T. concerns and bring that draft to the September meeting. She suggests we go back to the minutes from the April meeting to find the concerns from Diane T. and Doug M. when drafting an amendment project. Kevin H. comments this is general enough to open a project. Diane T. agrees. There is a possibility of holding a special meeting but this is to be determined. **Diane T. motions to open a general amendment of trade practices regulatory project that are in line with Diane T. and Doug M.'s comments/concerns from the April meeting.** Dana W. comments that limitations on package stores and incentives were part of that April discussion. **Doug seconds the motion. None opposed. Motion carries.***

*Dana W. leaves at the discretion of the Director whether to rescind or redo the advisory or not. Joan W. comments she hopes the trade regulations will be final sooner than later.*
