This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

On 1/04/2023, during a routine inspection of your licensed premises, it was observed by AMCO Special Investigator Moses that employees Dexjimi Lin and Bing Pan's Alcohol Server Education Course (a.k.a. TAP) cards expired on 03/04/22.

Your attention is directed to AS 04.21.025: Alcohol Server Education Course, AS 04.21.025: Responsibility of licensees, agents and employees and AS 04.15.150: Licensee responsible for violations.

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.

3 AAC 304.525 (B) provides that upon receipt of a Notice of Violation, a licensee may request to appear before the Director and be heard regarding the Notice of Violation. A Licensee shall respond, either orally or in writing, to the Notice.






