This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 10-5-22, an inspection was conducted at your establishment. The Bartender, Ashlee S. Champion-Hibbetts, was asked to provide proof of current alcohol server education. Champion-Hibbetts gave Inv. Hamilton a Tap Card, #169602, which had expired on 6-22-22. Champion-Hibbetts was told to stop serving alcohol until she provided the Alcohol Beverage Control Board proof of current server education.
