If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

She was identified as Donna Irene Slaughter. She stated she did not have server education either. She has been employed for five years. Both were told to stop selling alcoholic beverages until they could provide proof of server education to the ABC Board. The same violation happened on 7-1-20, AMC Case 20-0646. I am in receipt of the Notice of Violation dated 5/17/2023. Please accept this as Big John's response.

Both persons named in the NoV have received their TAP certification (see attached copy of cards).

While Ms. Slaughter could be considered "*....employed for five years.*" she has not been actively employed for that length of time. Rather, she had left the employment of Big John's and this employment began only nine months ago. However, the comment "*She stated she did not have server education either.*" is puzzling. There is a (recently expired) copy of her TAP card provided at time of hire (Certificate #179063; attached).

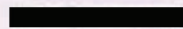
