This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 1-3-23, an inspection was conducted at your establishment. Server Kyong Eun Blair was asked to provide proof of current alcohol server education. She replied he has a TAP card but not on her. Ms. Blair was told to stop serving alcoholic beverages until she provided proof to the Board she has current alcohol server education. Inv. Hamilton contacted CHARR and learned that Ms. Blair has a TAP Certificate #132257 which had expired on 10-14-17.

Your attention is directed to AS 04.21.025: Alcohol server training, AS 04.21.030: Responsibility of licensees, agents, and employees, AS 04.16.150: Licensee responsible for violations and Anchorage Municipal code 10.50.015(s) which reads: "For a licensee to employ in the licensed business in any capacity which involves the sale or dispensing of alcoholic beverages to the public, any person who has not, prior to the commencement of employment, successfully completed a liquor server awareness training program approved by the state alcoholic beverage control board as provided by sections 2.30.125.B and 10.50.035.B.6."
