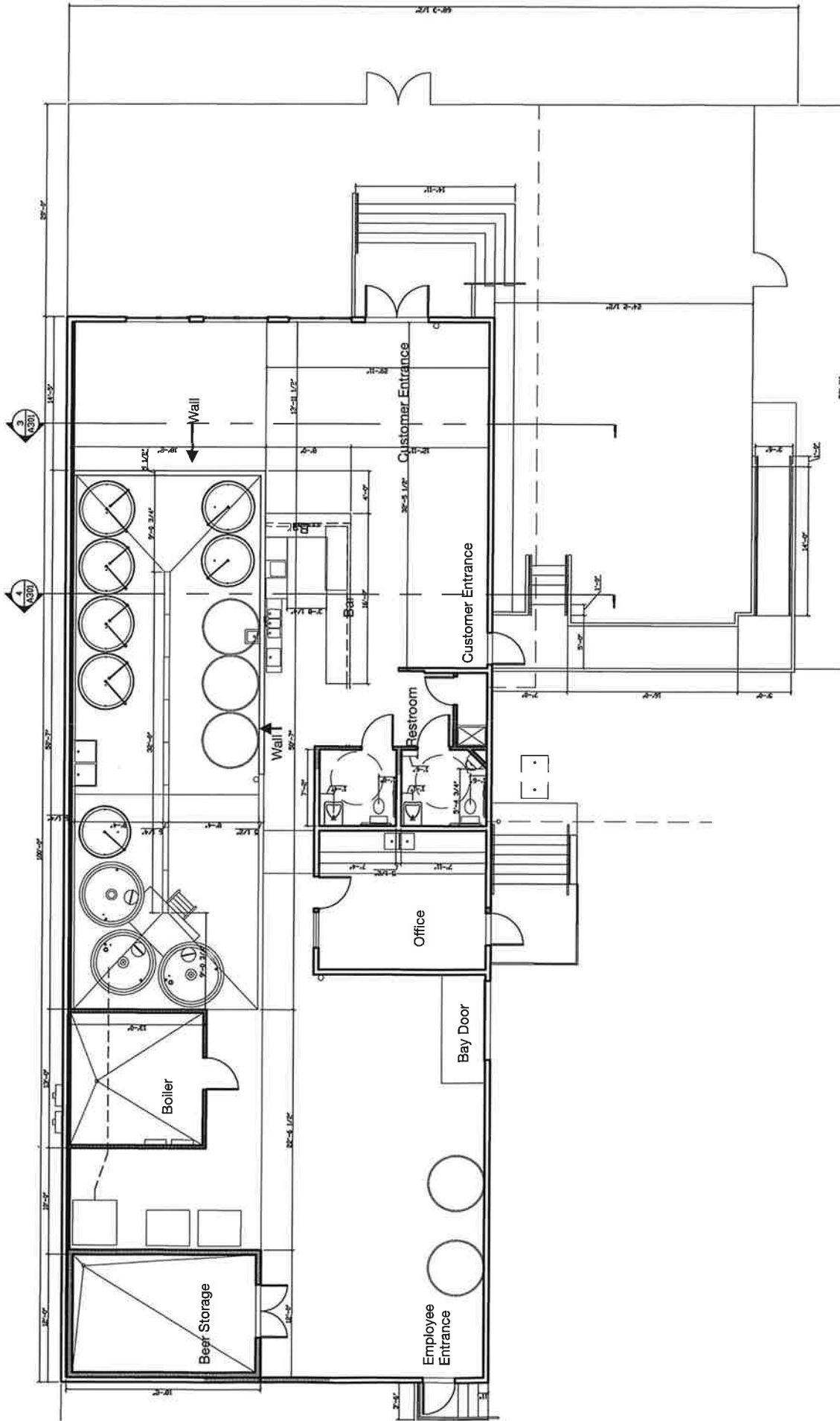

Outdoor Security Plan

Personnel will conduct routine inspections of the outdoor area to ensure adherence to the regulations within the authorized perimeter.

Persons under 21 will only be allowed in the area with a parent, legal guardian, or spouse of age.

A wood fence at least 4' high spans the N and W sides of the perimeter. A 3' chain fence runs along the East side of the perimeter.
