Security Statement

Only ticketed passengers are allowed to board the vessel. Employees of the licensed premises include: • Bar Services Manager and Bar Supervisor, responsible for the daily management of the bar and its staff; • Head Wine Steward, responsible for the supervision of the Bar Services Team; • Bar Services Team includes Bartenders and Stewards, responsible for making and providing drinks to passengers; and Bar Assistants, responsible for bussing, cleaning and catering events. Each of these employees, as well as all security staff is required to complete the Responsible Serving of Alcohol (RSA) Training, as mandated by company policy. Each employee's RSA training is recorded and copies of those records are kept on board the ship. Security and Prevention of alcoholic beverage service to intoxicated individuals: • RSA Training; • Alcohol restriction notices are posted/published in the ship's bar areas, on-board daily publication, Cabin Services Directory and all passenger cabins; • Minor-only occupied cabins are required to be searched for alcohol by cabin steward; • All occasions of anticipated refusal of service to a suspected intoxicated passenger is reported early to Bar Service Manager/Supervisor (BSM) and the suspect passenger is approached by BSM and Security Staff. If the individual suspected of intoxication complies with BSM, they are offered only nonalcoholic beverages; • All individuals showing signs of crude or inappropriate behavior, aggression, drowsiness, or slurring are reported to the BSM and service of alcoholic beverages is politely refused; • BSM maintains a record of all Refusals of Service reported.






