



Totem Marina LLC d/b/a Marina Pizza & Grill is located at 201 Katlian Street, Sitka, AK 99835. The outside area will be open to customers during the summer months for dining and alcohol consumption.

We will always have a manager on site, and there will be staff walking between the indoor area and outdoor area to monitor alcohol consumption. The outdoor patio is bordered mostly by the ocean and has an enclosure all the way around it so no one can take alcohol outside the patio area. We will also have the appropriate legal signage posted stating no alcohol beyond this point. When the indoor seating area is open and the outdoor seating area is closed, doors to the outdoor seating area will be closed and used only for emergency egress. Staff in the indoor seating area will monitor activity, to ensure patrons do not attempt to use the outside area when it is closed.
