364 - Renewal Application

This renewal application was deemed complete and scheduled for the December 2, 2025, board meeting. The City of Kodiak has since protested the renewal application.

"The Deputy Fire Marshal determined that the premises described in the renewal applications, 102 W Marine Way, is not code compliant. The deficiencies are identified in the Deputy Fire Marshal's November 5, 2025, letter, a copy of which is submitted with this protest.

The Council protests renewal of beverage dispensary license #254 and club license #364 because a business should not be operated from unsafe premises. The Council requests that the board uphold the protests, pursuant to 3 AAC 305.085(h), until the applicant meets the conditions set by the Council. Protest of the license #254 and #364 renewal applications will be withdrawn upon the Fire Marshal's report that the premises deficiencies identified in the Deputy Fire Marshal's November 5, 2025 letter have been satisfactorily corrected and that the 102 W Marine Way premises comply with the City's fire, health, and safety codes. The City Clerk will notify the Alcohol & Marijuana Control Office if the protests are rescinded."

Under 3 AAC 305.085(h) The board may uphold a protest of an application or continued operation with an initial abeyance period of not more than 180 days if the local governing body indicates that the protest is subject to rescission and that it will be withdrawn if the applicant meets conditions set by the local governing body. If the local governing body notifies the board within the period of the abeyance that the protest has been removed, the application or continued operation will be approved when all other applicable requirements have been met.

If the local governing body has not notified the board within the period of the abeyance that the local governing body has removed the protest, the application or continued operation is denied.

If the protest is not a conditional protest, then other rules apply and... the board shall deny the application or continued operation unless the board finds that the protest is arbitrary, capricious, or unreasonable – AS 04.11.480

To: The Alcoholic Beverage Control Board,

The City Council of the City of Kodiak protests the renewal of beverage dispensary license #254 and club license #364, subject to rescission of the protest. The applicant was given notice of this protest and an opportunity to be heard by the Council at its November 13, 2025 meeting.

Kodiak City Code 5.12.030(d)(6) provides that the Council may protest an application for a beverage license when business's premises do not comply with municipal fire, health, or safety codes.

The Deputy Fire Marshal determined that the premises described in the renewal applications, 102 W Marine Way, is not code compliant. The deficiencies are identified in the Deputy Fire Marshal's November 5, 2025, letter, a copy of which is submitted with this protest.

The Council protests renewal of beverage dispensary license #254 and club license #364 because a business should not be operated from unsafe premises. The Council requests that the board uphold the protests, pursuant to 3 AAC 305.085(h), until the applicant meets the conditions set by the Council.

Protest of the license #254 and #364 renewal applications will be withdrawn upon the Fire Marshal's report that the premises deficiencies identified in the Deputy Fire Marshal's November 5, 2025 letter have been satisfactorily corrected and that the 102 W Marine Way premises comply with the City's fire, health, and safety codes. The City Clerk will notify the Alcohol & Marijuana Control Office if the protests are rescinded.

AMCO Renewal Request, Kodiak Elks Lodge/ Tropics Lounge

At this time, Kodiak Fire Department, Office of the Fire Marshal is protesting with conditions the renewal of AMCO Beverage Dispensary License #254 and Club License #364 for Fire Code Violations. Inspection was completed on 11/5/2025. Most violations were minor, but the wet and dry sprinkler system are over due for service. The Kitchen hood system was also past due for annual service. We recommend protest until conditions are fixed and Life Safety Systems brought back to operational status.

International Fire Code

Chapter 9 Fire Prevention and life safety systems Section 901.6 Inspection, Testing and Maintenance-

Fire protection and life safety systems shall be maintained in an operative condition at all times, and shall be replaced or repaired where defective.

Section 606.3.3.1- Inspection of commercial cooking equipment.

- Low-volume cooking operations such as places of religious worship, seasonal businesses and senior centers- Inspection Frequency-12 Months

Once Systems are inspected and repairs made. We will lift conditional protest of the License.
