Re: Benchwarmers, LLC dba Polar Ice Rink's restaurant endorsement application.

Benchwarmers, LLC dba Polar Ice Rink, is applying for restaurant endorsement for their sporting activity or event site license (on this agenda, application with license No. 60183).

Examiner's assessment based on submitted application and answers to examiner's questions of applicant: Benchwarmers, LLC dba Polar Ice Rink's portion of the sports center being requested as the licensed premises, does not seem to include a restaurant nor will they be making the food items. Blue District (a separate business within the sports center) would be the maker and provider of the food items. The board is asked to determine whether Benchwarmers, LLC dba Polar Ice Rink qualifies for the endorsement.

Applicable statute(s) and regulation(s):

AS 04.09.450 (d) The board may issue an endorsement under this section only if the board finds

- (1) that the establishment or portion of the establishment for which the endorsement is requested is a bona fide restaurant;
- (2) there is supervision on the premises adequate to reasonably ensure that a person under 21 years of age will not obtain alcoholic beverages; and
- (3) that it is unlikely that persons under 21 years of age not employed on the premises will enter and remain on the premises of the bona fide restaurant for the purposes other than dining.

AS 04.21.080(b)(3) "bona fide restaurant" means an establishment or a portion of an establishment where, during all times alcoholic beverages are served or consumed, the patron's principal activity is consumption of food and a variety of types of food items appropriate for meals is prepared on site (see definition below) and available for sale as shown on a menu provided to patrons and filed with the board.

3 AAC 305.397. "A variety of types of food items appropriate for meals is prepared on site" means the meals are prepared on site in a commercial kitchen and that the majority of meal preparation involves more than warming or rewarming food in movable kitchen appliances, such as slow-cookers and microwave ovens.

Note: the formula of 50/50 alcohol/food does not apply here. The requirement is only for Restaurant or Eating Place licenses.


