





A detailed diagram of the proposed licensed premises is required for all alcohol license applications, per AS 04.11.260, 3 AAC 305.630 and 3 AAC 305.660.  - Dimensions (AMCO does not accept diagrams drawn to scale)

 - Points of reference, such as a compass rose indicating True North
 - All entrances, exits, walls, bars, and fixtures
- If your premises include multiple floors, please include a separate diagram of each floor.
 - You must identify the stairs between each floor, and each hallway/corridor that leads to each set of stairs.
- If your premises includes multiple floors, please include a separate diagram of each floor. You must identify the stairs between each floor, and each hallway/corridor that leads to each set of stairs.
- If your proposed premises is located within a building or building complex that contains multiple businesses and/or tenants, please provide an additional page that clearly shows the location of your proposed premises within the building or building complex, along with the addresses and/or suite numbers of the other businesses and/or tenants within the building or building complex.





Form AB-02: Premises Diagram



SEWARD DOGGIE BAR

Business Model and Alcohol Service Plan

Business Overview

The Doggie Bar is a concession trailer located on the current property adjacent to Preacher's Pond and the Howling Wolf Brewpub construction site. It will operate as a seasonal establishment during the summer months, providing outdoor alcohol service while construction of the Brewpub is completed. The operating hours will be from 11:00 AM to 6:00 PM, six days per week, with beer and wine as the sole alcohol offerings (no liquor service).

Business Model

1. Service Area:

- Alcohol will be served through a designated service window on the trailer.
- Customers will consume beverages in designated outdoor consumption areas, enclosed by temporary 4-foot plastic mesh fencing that uses the pond as a natural barrier.
- The premises diagram, attached to the application, outlines the service area, fencing, and alcohol storage locations.

2. Seating and Customer Model:

- The consumption area will include standing and informal seating arrangements, such as picnic tables and benches, as shown in the premises diagram.
- Customers will either stand or use available seating to enjoy their beverages.

3. Alcohol Service:

- Alcohol service staff will check the IDs of all new patrons before serving alcohol.
- Beer and wine will be sold at the service window, with no table service.

4. Seasonality: The Doggie Bar will operate in summer only and will not operate in winter months, given the outdoor-only nature of the business and the challenges posed by weather conditions.

5. Compliance and Training:

- All staff will undergo training on ID verification, responsible alcohol service, and recognizing intoxicated individuals to ensure compliance with Alaska laws.
- Signage will be posted at entrances and exits stating, "NO ALCOHOL BEYOND THIS POINT," and staff will enforce these boundaries.

Security Plan

Restricted Area and Fencing

1. The service area will be surrounded by 4-foot-tall plastic mesh fencing in compliance with FEMA flood plain restrictions. The pond will serve as a natural barrier along one side of the premises.
2. The fenced area will include clearly marked entrances/exits, which will remain unobstructed at all times for proper egress.

ID Checks and Monitoring

3. ID Verification:
 - All new patrons will have their IDs checked at the service windows prior to being served alcohol.
 - Staff will be trained in identifying fake IDs and handling situations involving underage patrons.
4. Monitoring Consumption:
 - Servers will monitor patrons within the consumption area to prevent overconsumption and ensure alcohol remains within the designated area.
 - If a patron appears intoxicated, staff will follow state-mandated protocols for refusal of service and ensuring safety.

Minor Access Restrictions

5. Minors will only be permitted in the fenced area when accompanied by a parent or legal guardian over the age of 18.
6. Signage at all entrances will clearly state, "No Minors Allowed Without a Parent or Legal Guardian."

Signage and Safety

7. Alaska Beverage Control (ABC) mandated posters will be displayed at the service windows and entrances, providing clear guidance on alcohol laws.
8. Proper signage will indicate that alcohol cannot leave the premises and minors cannot be in restricted areas unaccompanied.

Server Presence and Training

9. Servers will be physically present within the consumption area during operating hours to monitor patrons and enforce rules regarding alcohol consumption.
10. All staff will be trained in:
 - Handling disturbances or emergencies.

- Monitoring guests for signs of intoxication.
- Procedures for ejecting problematic patrons or calling law enforcement when necessary.

Emergency Procedures

11. Emergency exits will remain unobstructed, and all staff will be trained in emergency response, including fire safety and contacting law enforcement or medical personnel when needed.

Seasonal Adjustments

12. Given that the Doggie Bar operates only in the summer months, no additional winter-specific security measures are needed.
