Protest from Matanuska-Susitna Borough (MSB) for the following reasons:

- A) An application must be submitted to the Borough according to MSB 8.40.060.
- B) According to Borough records, an application has not been received providing all required information according to MSB 8.40.070.
- C) The MSB Assembly has not approved the transfer of this license. Approval or disapproval by the Assembly is based on such factors as the planning director's best interest finding, staff recommendation, public testimony, and other information the Assembly, in its discretion, deems relevant.

Relevant statutes and regulations:

AS 04.11.400(k): The board may allow the relocation of an existing beverage dispensary license under AS 04.09.200 or former AS 04.11.090 to a restaurant, eating place, or hotel, motel, resort, or similar business that contains a restaurant or eating place, an existing package store license

under AS 04.09.230 or former AS 04.11.150, an existing brewery retail license under AS 04.09.320, an existing winery retail license under AS 04.09.330, or an existing distillery retail license under AS 04.09.340 in a borough with a population of 50,000 or more into or within an incorporated city in the borough. The board may not approve the relocation unless, at the time of application, the existing number of issued licenses of the type under consideration for relocation located within the borough exceeds the maximum allowed under (a) of this section and the governing bodies of both the borough and the incorporated city approve the relocation. The board may allow not more than three relocations into each city under this subsection each decade. In this subsection, "decade" means each 10-year period beginning April 1 in a year ending in zero.

3 AAC 305.130. Consideration of transfer of location of a license under AS 04.11.400(k). (a) An application to transfer a license under AS 04.11.400(k) in a borough with a population of 50,000 or more into or within an incorporated city in the borough must comply with the notice requirements set out in AS 04.11.280, 04.11.290, and 3 AAC 305.070(d), as applicable. The criteria for denial of an application to transfer an alcoholic beverage license to another location as set out in AS 04.11.340 and denial of an application to transfer an alcoholic beverage license to another person as set out in AS 04.11.360 also apply to an application to transfer a license under AS 04.11.400(k). The notice requirements set out in this section apply to an application to transfer.....

(b) If the board approves an application to transfer a license issued under AS 04.11.400(k), the license becomes a license of the municipality in the new location. The license may be transferred to a new location and new person within the receiving municipality. If a license is transferred with a security interest under AS 04.11.360(4)(B) and 04.11.670, the retransfer back to the previous owner may not be made to the location of the former municipality.

(c) A license located in a municipality as a result of annexation is not counted as a new license for the purposes of AS 04.11.400(k).....

Background: Licensee, J & L Enterprises Inc., is applying to transfer ownership and location under 400(k) of beverage dispensary license 3888 to move the license from Matanuska-Susitna Borough into the City of Wasilla. Staff has verified that the proposed premises for relocation is located in the City of Wasilla. The proposed transfer qualifies under AS 04.11.400(k) as follows:

- Matanuska-Susitna Borough qualifies to give up its license because its population is counted at 96,758 (over the needed 50,000).
- The City of Wasilla qualifies to receive the license because, currently, the existing number of issued beverage dispensary licenses exceeds the maximum allowed. As of 5/27/25 the City of Wasilla is allowed 4 beverage dispensary licenses (1 per 3,000 population or fraction of) with a total of 7 beverage dispensary licenses issued within its boundaries.
- The license type qualifies as a type allowed to relocate under this statute, and further qualifies as containing a restaurant or eating place.
- This decade, the board has allowed one license to relocate from the Matanuska-Susitna Borough into the City of Wasilla. The board may allow no more than two more licenses

to relocate for a total of three in a decade. The decade encompasses the time period beginning April 1st, 2020 through March 31st, 2030.

On June 5th, 2025 the Matanuska-Susitna Borough protested the license transfer, in part, because they had not yet received a required relocation application from the applicant and the MSB. The applicant had submitted a copy of their MSB relocation application to AMCO along with their transfer application and it is attached for board review. The applicant notes they are taking steps to remedy this and submit the MSB relocation application and fees directly to MSB.

No response has been received from the City of Wasilla as of June 11, 2025.

Consideration:

3 AAC 305.070(d). Application for transfer of location reads:

(d) If a transfer of an alcoholic beverage license to another location is subject to AS 04.11.400(k), before the application is submitted to the board

(1) not more than 10 business days after the board office determines that the application is complete and the prerequisites of AS 04.11.400(k) are satisfied, the office of the board will notify the affected borough and incorporated city of the transfer of location application, and an accompanying transfer of license to another person, if applicable; the notice will include

(A) the date the board office received the complete application;

- (B) the license number;
- (C) the present or previous business name of the license to be transferred;
- (D) the names of the transferee and the transferor, if the application

includes a request to transfer a license to another person; and (E) the proposed new location of the license;

(2) the borough and incorporated city affected by the transfer request under AS 04.11.400(k) may respond to the notice under (a) of this section not later than 60 days after receipt of the notice; the borough or incorporated city may request that the board grant an extension of up to 120 additional days to respond;

(3) within the notification period, the borough and the municipality must provide written notification that they agree to the transfer under AS 04.11.400(k) to be approved by the office of the board; the board will not approve a transfer of location if the notification required by this paragraph is not received within the time allowed under (d)(2) of this section; if the borough and municipality timely respond, the board may consider whether to approve the relocation under 3 AAC 305.130.

<u>The board may wish to table this application</u> until both local governing bodies have weighed in to approve or protest the application within the allowed timeframe. The MSB and City of Wasilla were notified of a complete application under 3 AAC 305.070(d)(1) on May 27, 2025 and initially have 60 days to respond but may ask for an additional 120 days to respond. (total 180 days) <u>To date, neither local governing body has requested additional time for response.</u>

2. deny with 180 day abeyance, delegations are local governing body approvals

The board may wish to 'deny the application with 180 days abeyance' with delegation. That delegation to include the response of approval from both the municipality and the borough.
