Dana Walukiewicz opens to the topic of special board meetings going forward. Talks about special meetings via zoom. This will allow for time and efficiency. Considering the work of the office and the board.

● **PROTESTS OF REPL 2611 AND REPL 3293 BY KODIAK ISLAND BOROUGH AND CITY OF KODIAK**

TAB 1

Dana Walukiewicz summarizes the protests of two REPL's owned by Sook Yun. The board declined to take up the issue of the Borough's protest because they didn't believe they didn't have good standing and is now with OAH.

Kodiak Island Borough's protest of the continued operation.

Charles Cocciola speaks as the City's attorney. The City's protest of 3293 of the renewal cannot be reissued. He states that it has expired about a year ago. Mrs. Yun has no intention of operating the license. The board should deny the renewal of the license and allow the public to apply for it.

Stephani Kim (daughter of Mrs. Yun) talks about the history of the licenses and how 2611 has been temporarily surrendered. License 3293 is temporarily surrendered and is waiting for the transfer. The borough said that we didn't attend the assembly meeting, but I was there. 2611 was not objected for the renewal. We were good operators for 40 years for one license and 32 years for the other license. We didn't need both the licenses and so we decided to transfer one of the licenses.

Dana Walukiewicz mentions that if the board upholds the protests of either of the licenses then the transfer becomes a moot point.

Charles Cocciola, the City's attorney speaks to the protest of the transfer. The transferee owes taxes to the city but has made significant payments and believe that will be rescinded. There is nothing to transfer, the license has expired 2/28/2023. Should've been available March 2024. It goes back to the renewal, there is no licensed premises to renew it to.

Dana Walukiewicz starts with REPL 2611 protest of continued operations. A lengthy discussion follows.

Dana Walukiewicz uses MOA as an example of how they deal with bad licensees that are not good for public interest. He points out that he didn't see where the local government went to the licensee trying to work this out. The licensee had a hard time with a landlord, then they lose their license. He doesn't feel like that's a reasonable standard. This hasn't been applied evenly and consistently to all licensees. He expresses reservations with the city and borough's determination whether the licensee should receive a waiver. It is the board's jurisdiction not the borough or the city to determine. The jurisdiction of the city and borough is to bring the "bad actors" to the board.

Motion: To deny the Kodiak Island Borough's protest of continued operations of license 2611 by Diane Thompson. Doug Moore second. All vote yes. Protest denied.

Recess: 12:55pm

Reconvene: 1:05pm

Dana Walukiewicz calls to order recapping the motion to deny the protest of 2611. The Kodiak Island Borough's protest of renewal of license 3293 is the next subject.

Jane Sawyer asks if Dana can take roll.

All board members are present; Doug Moore and Jan Hill are present via zoom.

Dana Walukiewicz asks Mrs. Kim when the last time Second Floor Restaurant was operated?

Stephani Kim states that the last time license 3293 was operated was in 2019.

Jane Sawyer points to attachment 12 of the memo having the renewal, first, second, and third waiver included.

A discussion on third waivers commences.

Dana Walukiewicz states that the board has approved waivers of operations based on transfers and believes that the precedent has already been set when they show a plan to transfer, reconstruct, or what have you. He goes on to say that he's not concerned that the waiver doesn't have a plan to continue, he sees the transfer as the plan to utilize the license.

Diane Thompson says that she would have a problem with it if the lease was just recently signed, but it was signed in 2022.

Dana Walukiewicz states that the issue at hand is whether to uphold the protest of the renewal. He ponders the definition of arbitrary, capricious, or unreasonable. The protest is on the foundation of non-operations. Non-operation is common.

There is discussion about the possibility of unpaid taxes.

Aimee Williams from Kodiak Island Borough states that if your account is deactivated, they wouldn't show up in the default list. Filing is mandatory if the business is in operation.

Dana if the motion to uphold the Kodiak Island Borough protest, then everything after is a moot point. The license can't be transferred if it isn't renewed.

Motion: *To uphold the Kodiak Island Borough protest of renewal of license 3293 made by Diane Thompson. Second by Doug Moore. All vote yes. Motion passes.*

Motion: *To uphold the City of Kodiak protest of renewal of license 3293 by Doug Moore. Second by Jan Hill. All vote yes. Motion passes.*

Kevin Higgins reads 3 AAC 305.085(f).

Dana Walukiewicz states that he would expect that the local governing bodies would participate in any further proceedings regarding these protests, the board agrees.

The transfer is tabled pending any potential appeal.
