BOARD GOVERNANCE

PUBLIC TESTIMONY

Paul Thomas speaks to the process of granting rulings while an open, uncompleted regulation project is in the process, and the ramifications that it will have on regulations projects completed in this way, and that the licensees and the public will be affected. He states his concerns in how communities, licensees, the public and the potential of setting precedents in conflict of future regulations is a bad move for the board, and the industry.

Sarah Oates Harlow with Alaska CHARR thanks the board and staff for moving testimony to the beginning of the agenda. Shares her opinion about the tentative approval of the special meetings as of recent history. She hopes that it won't burden the staff. She states that she is happy to see that regulations projects are back on the agenda. She expresses her concerns about printing and distributing the new signs. Speaks to CHARR having an interest in working with AMCO specifically with regard to regulations. Requests that the meeting minutes include the details with regards to public testimony.

Dana Walukiewicz speaks to the 3-month delay to print the new signage.

Josh Anderson, new owner of the Triangle Club in Juneau, speaks to rules and regulations that haven't been fully vetted yet and how this affects small communities. He would like to see regulations be fully vetted before the board proceeds with actions. He states that the rules need to be figured out before we go ahead and implement new regulations. He expresses concern about the devaluation of his investments because the pieces of pie are getting smaller.

Diane Thompson asks if Josh Anderson is referring to additional REPL's?

Josh Anderson says, yes.

David McCasland owner of Deckhand Daves in Juneau speaks to trying to sell his license and the struggles of that because of additional REPL's and how they have 4 licenses for sale currently. There shouldn't be additional REPL's granted if there are licenses for sale.

Mitch Falk owner of Bullwinkle's Pizza 1690 speaks to having to finance everything to create his business. He believes that approving additional REPL's devalues the currently available licenses that can be sold. He agrees with David McCasland about available licenses that are for sale.

Public Testimony closed 9:31am.

Kevin Richard speaks to the Director's Report. Mentions SB15 and HB37, HB135 and the subcommittee hearings. One of his primary focuses is the hardships of the licensing department. License review and issuance, email ballots to vote electronically via email, or using board management software as options to avoid formal meetings to increase the speed of licensing.

Doug Moore asks if the board would still have their quarterly meeting.

Kevin Richard responds by saying, yes. This would only be for items that are considered for delegated consent.

Dana Walukiewicz asks if AK-ACCIS would be able to offer that functionality and suggests that AK-ACCIS be used if that were a possibility. He also agrees that what the Director is proposing could help speed things up.

Sara Chambers speaks to the consideration of email voting with the board. There wouldn't be an opportunity for the board to discussion or public input and instead, that would be part of a public meeting.

Diane Thompson appreciates the idea, because she has an application in the queue that has been there for a while.

LICENSING STATISTICS TAB 5

Sonya Irwin speaks to the licensing report, highlighting the reduction in the number of endorsements. She also states the allocation of duties to staff. She talks about the intake process of paper applications regarding the new AK-ACCIS system.

There is a short discussion on paper applications.

Doug Moore thanks the office.

Jan Hill is appreciative of the discussion.

The board accepts the licensing statistics.

ENFORCEMENT REPORT

A. Supervisor's Report

Joe Bankowski speaks to the supervisor's report. He speaks to enforcement being out across the state doing inspections. He thanks Beth Rosenbaum for the pivot table.

Diane Thompson speaks to the new digital IDs and asks if AMCO enforcement is a part of the new IDs?

Joe Bankowski says that no, they do not have a part of the new IDs.

Dana Walukiewicz has enforcement had any follow up with respect to the digital ID?

Joe Bankowski says that he hasn't heard anything since the board meeting where the DMV came to present to the board.

Joe Bankowski says that he will follow up on that and bring it back to the board at the next meeting.

The board accepts the supervisor's report.

B. Notices of Violation Issued and Licensee Responses

TAB 7

Dana Walukiewicz mentions the license of Mykel's Restaurant, WX LLC in Wasilla regarding the employment of minors on premises. He asks about the status.

Joe Bankowski states that he is unable to give an update on that as of right now.

Kevin Higgins speaks to a citation that was filed and a \$500 fine paid.

Dana Walukiewicz mentions that generally the fines are larger than that. He asks the board if they would want to issue an accusation. This was not a single occurrence, and they haven't followed up with enforcement. The board asks Mr. Bankowski and Mr. Richard to follow up on the matter. The board is concerned about Speedway having a re-occurring offense with a previous stipulated agreement and asks enforcement to follow up on the matter. They may be in violation of their stipulated agreement.

Kevin Higgins speaks to a stipulated agreement from 2023 and states that it was a flat fee. This would be a new violation.

Doug Moore states that as operators in the State of Alaska they need to clean up their act. Filing an accusation on this one might encourage them to get in compliance.

Michael Schwarz legal counsel for AK. Inc. states that he can reach out to his client and address this at the next meeting.

The board is happy to hear this.

Dana Walukiewicz would like to see an accusation with an increased fee on this violation.

The board accepts the NOV report.

PETITION UNDER AS 04.11.405.

A. City of Homer petition for additional Restaurant or Eating Place Licenses Board to hold a public hearing as required by AS 04.11.405(b)

TAB 8

Dana Walukiewicz opens the public hearing at 10:17am for the 10 additional REPL's. He asks the petitioner to speak to the reason for the petition.

Julie Engebretsen from the City of Homer speaks to the petition process and the reason for the petition. She mentions that there are 15 seasonal REPL's on the Homer Spit and a lack of other areas with the availability of those licenses. She states that there were 244, 000 people visiting Homer last year. To support the community and the growth of the economy they are requesting 10 additional REPL's.

Jan Hill asks how many existing businesses would be able to utilize the licenses immediately.

Julie Engebretsen speaks to Homer being a hub community and modeling themselves after Soldotna in a lot of ways.

Jan Hill is concerned about the number of licenses being asked for vs available businesses ready to utilize these licenses.

Julie Engebretsen states that she doesn't necessarily know every individual that requests this license type.

Kristina Serezhenkov speaks to the traditional 15 REPL's and goes on to say there is one Seasonal REPL Tourism that was approved but not effectuated.

There is a brief discussion about the difference between a Seasonal REPL Tourism license and a traditional REPL license that is utilized for only 6 months out of the year (seasonal).

Dana Walukiewicz opens the discussion up to the public.

Sarah Oates Harlow with Alaska CHARR speaks to the mention of Soldotna and Wasilla's petition as hub communities. Homer is not a hub community. Many other small communities petition for a similar number of additional licenses. This has created a controversy as a result of these petitions. Homer is allowed 4 and has 15, approving 10 more REPL's would be 800% more than allowed by population. Profit margins of restaurants prepandemic were 3-5%. Right now, post pandemic is closer to 1-2%. She believes that there are not likely 10 businesses in the community of Homer ready to be issued a restaurant eating place license within the next two years. She asks the board to reconsider and to consider issuing a smaller number now, and encouraging them to come back at a later date.

Doug Moore points out that Sarah Oates Harlow is correct in saying that hypothetically, the board could grant 5 and then Homer could come back in a year to say that they filled those 5 and that they'd like to petition for additional licenses.

Paul Thomas package store owner in Juneau speaks to Title 4 and the creation of new license types. One of them being the seasonal REPL tourism license which he feels would fit this situation better. He says that there are huge inconsistencies around the State. The smallest communities are getting hit with these huge overpopulation potentials, basically unlimited. There is a huge imbalance being created between the small and larger communities. He goes on to say that over 50% of them should be seasonal licenses, so that those year-round licenses would be available to someone else in the community.

Diane Thompson asks if there is a population cap on seasonal REPL tourism licenses.

Sonya Irwin responds by saying, yes, there is a formula to determine how many may be issued based off the population and tourism numbers.

Doug Moore asks Julie Engebretsen about the intention of asking for more REPL's? Why did the city of Homer ask for additional licenses.

Julie Engebretsen states her understanding of this petition was that they can petition for additional licenses and didn't know that seeking out businesses that are interested in these license types was a part of the process and would've liked more guidance if that was the case. She states that the board could probably issue less than 10 and meet the needs of the community. She continues to say that the previous comments were helpful, that here

we have 15 traditional licenses, but half of them are used seasonally, and there is a cap on seasonal licenses. Somehow, we need to handle our seasonal businesses a little bit differently, or something. We're in a spot right now where we have year-round businesses that have opened on our downtown strip that would like to be able to sell beer and wine and are unable to do that. She states that she is not comfortable putting out a number in the absence of approval from the city council.

Dana Walukiewicz closes public testimony at 10:44am and opens board discussion.

Diane Thompson states that we need to think long and hard about how to proceed and would like some kind of guidance.

Dana Walukiewicz speaks to the way he sees the statute and how it was written. His interpretation is that if you guys want and you can prove that you can support more licenses, you could get more. He is a little hesitant to counter the intent of the legislation to allow additional REPLs and there is no opposition to additional licenses in Homer. The public process was followed. The only opposition we're hearing is from outside the community of Homer. It would be different if it is not in the best interest of the public, as it was in Haines, but that's not the case here.

Doug isn't comfortable editing a request when he hasn't heard from the Homer community.

The bord recognizes Sarah Oates Harlow.

Sarah Oates speaks from CHARR to say that many restauranters have voiced opposition to her who wish to remain anonymous.

Julie Engebretsen speaks to the Homer Spit specifically being seasonal due to the Homer Spit's unique parameters.

Dana Walukiewicz each individual community has its own circumstances and is open to hearing each instance. He states his concerns about not hearing about the opposition directly from the restauranters.

Jan Hill is very concerned about this and agrees with a lot of Diane's comments. She would like to see a better way of processing these petitions. She brings up the seasonal license issues. She goes on to mention that the Haines petition included individuals that didn't want to be known in their opposition and thanks Sarah Oates Harlow for giving them a voice. The State of Alaska set up a formula for how many licenses are available in the communities and is afraid of amending the rules.

Dana Walukiewicz speaks to seasonal vs traditional REPL's and not comfortable having a licensee being forced to change their license type. His understanding of the regulations project was to give guidance to the local governing bodies on how to navigate the application process for these petitions. He is hesitant to override a local jurisdiction.

Doug Moore agrees and states that this should be a yea or nay vote because there is no opposition that they can determine.

Kevin Higgins clarifies that the board has the digression to approve 1 or more additional REPLs. It doesn't have to be 10 licenses or nothing.

Julie Engebretsen feels confident that Homer would support 5 licenses with the knowledge that there are several businesses interested.

Motion: To approve the petition to allow an additional 5 REPL's by Doug Moore. Second by Jan Hill. All vote yes. Motion passes. Friendly addition to this being effective immediately.

Jan Hill responds, saying she is present.

B. City and Borough of Juneau petition for additional Restaurant or Eating Place Licenses Board to hold a public hearing as required by AS 04.11.405(b)

<u>TAB 9</u>

Dana Walukiewicz introduces Greg Smith the Mayor of Juneau.

Greg Smith Mayor of Juneau speaks to requesting 8 additional REPL's. Talks about the extent of the petition process. There are at least 7 local businesses that would be interested in the REPL's. He speaks to discussing ways of addressing economic harm to current licensees that have invested in licenses already. The board is balancing existing licensees as well a prospective licensees. He reads AS 04.11.405 and states that Juneau meets the criteria listed in that section.

Dana Walukiewicz opens it up to board member questions. He thanks Mr. Smith for his thorough presentation of the petition. **He opens public testimony on the subject**.

David McCasland from Deckhand Dave's introduces himself and speaks to offering up any term financing to acquiring his license. States that there are 3 other licenses for sale that he is aware of.

Dana Walukiewicz asks what his asking price for his license is.

David McCasland states that he is asking the same as what he paid for it, \$50,000-60,000.

Peggy Cowan from Juneau thanks the board for their service and states that she supports the additional REPL's. More licenses will create more businesses, and more competition is good for the consumer, adding more licenses will help businesses be profitable and provide more choice to Juneau residents. She states her concern with Juneau's declining population, and particularly the decrease in younger generations.

Mitch Falk owner of Bullwinkle's Pizza speaks to 4 licenses being available and not one person has reached out in interest of those licenses. All of the current license holders have purchased their licenses. He thanks the board and asks they look at this matter very closely.

Josh Anderson from Triangle Club speaks in agreement with Mr. McCasland and Mr. Falk to say that this would devalue the current licensees licenses. He mentions business costs going up and creating more difficulties.

Skye Stekoll, part owner of Forbidden Peak Brewery speaks in support of the additional REPL's.

Mitch Faulk speaks to the requirement of more than 50% of your revenue having to come from the sale of food. He doesn't believe that a vast majority of the applicants understand that requirement.

Paul Thomas package store license owner states that approving additional licenses would be very hard to undue. This would be totally reversing what Title 4 was designed under, population counts based on licenses available. You

would be throwing out half of Title 4. He believes that regulations projects should be completed before pursuing additional licenses.

Diane Thompson believes that Mr. Thomas has a good point about approving additional licenses vs population count.

Doug Moore speaks to the statutory requirements under AS 04.11.405 regarding additional REPLs and how it is part of what the legislature has created.

Diane Thompson believes more guidance is needed.

Doug Moore states that there is government guidance. There is an avenue for local governing bodies to follow these procedures.

Dana Walukiewicz states that he doesn't believe there should be re-debating of the statute. The legislature put that in there and they gave the local jurisdictions an option if they feel that they service visitors from outside their community, they can petition to ask for additional licenses. They weigh the public interest as well as the board has to. He goes on to say that they keep hearing from one section of the public. He says that he feels for them but as a board they have to balance all public interest.

Frank Eagle from Lavelle's Bistro asks if Public Convenience Licenses still available?

Dana Walukiewicz states that he doesn't believe that that is germane to the conversation.

Max Stanley a local business owner in Juneau speaks to his support of additional REPL's. The Assembly of Juneau has thoroughly petitioned for more licenses. This is supported by statute and the local government has done their due diligence.

Paul Thomas speaks to statutes and legislative intent. He believes the board is heading down a path that is contrary to the legislative intent.

Sarah Oates Harlow from Alaska CHARR speaks to the petition process from 10 years to every year so that they can come back to petition the board for more licenses. There is no current mechanism to remove those licenses once those have been approved. Local governments can come forward to request additional licenses from a 10 year wait list to a wait period of one year. It's ridiculous to ask licensees to reduce their assets.

Doug Moore asks Mr. Gregg Smith what the reason the counsels went from asking for 20 additional licenses to 8?

Greg Smith responds by saying it was a more appropriate number based on the desire for those licenses and statute.

Dana Walukiewicz speaks to the application process and how the applicant has to qualify for the license and 8 additional licenses doesn't seem to be an excessive number. There have been a few comments about cutting up the pie into smaller slices of pie, but believes that looking at it as the pie itself getting bigger would be the way he would see it. If there aren't any restaurants to visit, then you can't go out at all.

Evan Wood holds many licenses and speaks the Mr. Smith's testimony. States that non-alcohol licensee's do not receive notifications from AMCO and that is why they are not here at this meeting. He speaks to his support of the additional licenses.

Dana Walukiewicz asks about his REPL vs his Seasonal REPL Tourism and how he acquired his license.

Evan Wood states that it became available.

Dana Walukiewicz states that how a licensee acquires their licenses is their prerogative and really isn't up to the board.

Diane Thompson says that reducing their number from 20 to 8 makes it more of a reasonable number and seems like the City of Juneau has done their due diligence to support the 8 additional licenses.

Doug Moore says that he doesn't believe how we can tie in the assumption that there are licenses for sale. He understands but doesn't know of any other legislation that takes into account any other instances where there could potentially be licenses for sale and takes that into account. Increasing by 8 licenses makes sense for Juneau's population.

Dana Walukiewicz speaks to this petition process, taking into consideration the visitors and that's a big factor for Juneau.

Josh Anderson from Triangle Club speaks to Mr. Thomas's point regarding the regulation process and issuing licenses that you can't undo.

Kevin Higgins clarifies that these licenses aren't available unless they apply for them through AMCO. Mentions AS 04.11.660 that it is a privilege and not a property right. When the legislature passed SB9 it included what was not included before, the section on the that the purpose and the policy behind Title 4. One of the things that says in AS 04.06.005, as long as the board is following Title 4 and regulations adopted by Title 4, it is acting in the appropriate balancing of the public interest, the interest of licensees, of current license holders, and the interest of the industry in general. He goes on to state that everyone can read AS 04.11.405 and have different interpretations of it. He doesn't believe that there is anything there that suggests that the board is somehow acting beyond the scope of its authority when it's deciding these petitions in the absence of regulations, regulations may help, but it could be an uphill argument to say that they are necessary.

Sara Chambers thanks Kevin Higgins for his insight. She goes on to explain that there was no motion regarding a regulations project during the November meeting. The board discussed some concepts but didn't actually open a Regs project. There was no motion.

Mitch Faulk from Bullwinkle's Pizza states that he didn't have a choice, and had to buy a license.

Sarah Oates Harlow states she had a different recollection of the regulations project. However, the reason she wanted to speak is because the statement that the legislature says that here's this new process, now if the local government asked for it, then issue it to them. And what it actually says is that the board may issue, not shall issue.

Dana Walukiewicz appreciates the may vs shall distinction that Mrs. Oates Harlow points out.

Sarah Oates Harlow clarifies that she wasn't specifically speaking to the petition from Juneau. She can also appreciate the board's comment about this being a slippery slope when considering licenses having values in regard to businesses trying to recoup costs.

Dana Walukiewicz mentions that it is a slippery slope when considering private business dealings and values of licenses. It is a business decision, and it is a decision that a business has to make solely on their own.

Jan Hill appreciates comments and questions. She is concerned about the additional licenses in general. She has been keeping an eye on the public process and believes that they have been thorough in their consideration. She appreciates the reduction of petitioned number of additional licenses from 20 to 8. She doesn't believe that the legislature would've been able to foresee this kind of concern when crafting the rewrite.

Dana Walukiewicz closes the public hearing.

<u>Motion:</u> To approve 8 additional REPLs for the city of Juneau by Doug Moore. Second by Diane Thompson. All vote yes. Motion passes.

Dana Walukiewicz speaks to the memo and the application under the AS 04.11.460.

Kristina Serezhenkov speaks about the application and the thoroughly reviewed location, the location from the nearest municipality, and under what statute this application was allowed and determined, it was allowed.

Dana Walukiewicz checks with Janice Hill to make sure she is present, and she is.

A. Open Regulations Projects Board Consideration

1. General Amendments of Trade Practices

TAB 39

Status: Law edits of board approved draft do not align with board directive and change existing regulations language at 3 AAC 305.515.

Potential Board Actions: TDB at meeting

Dana Walukiewicz introduces. He provides a brief history of Title 4 requiring new trade practices regulations so that licensees could operate within the new laws. He notes that this project is the second round of regulations addressing trade practices. He informs the board that the Department of Law has objected to the last round of amendments to trade practices. Chief Assistant Attorney General Rebecca Polizzotto of the legislation,

regulations, and legislative research section sent a letter objecting to some of the regulations in that, in her review, they are inconsistent with Federal Regulation. He asks if Rebecca Polizzotto is present.

Kevin Higgins states that Rebecca Polizzotto is not present at this meeting.

Dana Walukiewicz asks Kevin Higgins where that leaves the board as the current round of trade practice regulations are objected to but the initial trade practices regulations are law?

Kevin Higgins states that Dana Walukiewicz is correct and the letter is the response that contains the reasons for rejecting this current round of trade practice regulations. Kevin Higgins speaks to Law's processes and his role and the internal checks and balances at play.

Dana Walukiewicz reiterates that though this current round of trade practices are not in effect, the original trade practices regulations are in effect and asks for Kevin Higgins confirmation.

Kevin Higgins confirms and asks Kristina Serezhenkov on Law's edits of the current trade practices as presented in the memo..

Kristina Serezhenkov speaks to the minor differences that are not substantial in the draft presented with Law's edits and to the major differences that are substantial.

Dana Walukiewicz clarifies that Law both modified the proposed draft and went back and changed some of the money amounts that the board had not wished to change in this draft.

Kristina Serezhenkov confirms and speaks to receiving the letter just the day before and notes it is not posted publicly on the website as there was no staff or time to do so prior to the board meeting.

Dana Walukiewicz asks Kevin Higgins to confirm that Law's edits are not 'unilaterally changing the law'.

Kevin Higgins confirms.

Diane Thompson asks if Law's edits and letter is just a 'suggestion'. Dana Walukiewicz states that the letter is 'more than just a suggestion' and that 'you must make these changes for us (Law) in order to go forward'. Kevin Higgins confirms that he also understand the letter this way. Dana Walukiewicz continues that he understands that the proposed regulations changes that the board unanimously approved would go nowhere unless Law's changes were made and asks if there are any alternatives? He adds that process that created the initial trade practices was sound and lots of public comments and input were taken in the development of the draft.

Kevin Higgins advises that the current proposed regulations will not go to the Lt. Governor unless Law's changes are made. He also states that there may be a possibility of working on those areas of agreement and having those advance but leaving aside those areas of disagreement. The project must have an amended request or the project will not move forward.

Dana Walukiewicz notes he struggles with the arguments presented in the letter. He states that he feels that Rebecca Polizzotto has the position that the trade practice regulations must 'be exact' with the Federal trade practice CFR's. He notes there are multiple instances within our regulations that are clearly different than what's in federal regulation and gives the licenses themselves as an example.

Dana Walukiewicz recognizes Lee Ellis to speak.

Sara Chambers asks if a member of the public should weigh in on an open regs project.

Kristina Serezhenkov reminds board of the status of project and that it has not yet been publicly noticed. Board discussion on regulations process and status of project in relation to drafting regulations procedures.

Lee Ellis, Secretary of the Board of Brewers Guild and owner of Midnight Brewing Company speaks and opines that there are many differences in the regulations and federal law and encourages the board to consider getting another legal opinion. Research is needed.

Diane Thompson asks about the specifics of the objections about the \$300 per location and the \$400 exterior signs. Dana Walukiewicz advises Law also objected to limitations on number of locations if a license was part of a license chain and goes on record to say he disagrees with Law's analysis. He continues that 'we are not limited to just what is in Federal regulation'. He further clarifies that Law's interpretation is a very restrictive and narrow one. Board discussion. Doug Moore opines that the board is tasked with a uniquely Alaskan way of regulations creation. Concerns are expressed about how Law came to their position and that the public process is negated with Law becoming an advocate of one licensee.

Dana Walukiewicz speaks to the reason he disagrees with the determination. He states that he is concerned about how Law came to this determination and may have taken up an appeal process through the administrative procedures act.

Sara Chambers offers a possible solution by bifurcating the issue between what you agree with and what you don't agree with. We could advocate and ask for more direction.

Dana Walukiewicz appreciates Ms. Chambers's input and moves back to the original draft the board approved for trade practices. He gives an overview of the drafts, both the board approved draft and the Law edited draft, and asks Kevin Higgins if Law can perhaps come to a board meeting to explain their position.

Kevin Higgins states that he understands that this letter is the response to an invitation to come to this meeting.

Dana Walukiewicz suggests that industry members affected by this get involved politically and that there are numerous instances of regulations more or less restrictive than Federal law. Doug Moore is in agreement. Board discussion touches on marijuana regulations as an example of not following federal law exactly and are in violation of Federal law.

Kevin Higgins speaks to the state laws in regard to trade practices and marijuana and points out that for trade practices State law affirmatively says we have to be consistent with Federal law.

Dana Walukiewicz asks 'what is the definition of consistent' and notes her (Chief Assistant Attorney General Rebecca Polizzotto) understanding is that it is exact while he is arguing that the Legislature's intent was that regulations were not exact, word for word.

Diane Thompson points out that the board takes into account what is in the best interest of the public in Alaska.

Sara Chambers advises it is not unusual for executive branch attorneys to disagree with legislative branch attorneys. Board discussion includes Kevin Higgins, who points out that regulations attorney has statutory authority to hold up the process.

Doug Moore does not want to 'cave' on this issue and notes the hard work that went into the creation of the trade regulations. He quotes portions of Rebecca Polizzotto's letter.

Dana Walukiewicz asks if the board wants to start a new regulatory process that deals with manufacturer retail licenses as this is an area of agreement with Law. Board discussion includes Sara Chambers who opines on regulations processes.

Dana Walukiewicz asks if the board needs more time and that perhaps this could be tabled. He goes on the record to voice frustration with the overly restrictive interpretation of the word 'consistent' and the' corruption of the proces's. He further opines that this was supposed to be a cursory review of the proposed regulations but that the Department of Law took it upon themselves to become an advocate of a single licensee, and in effect adjudicated a regulatory position which is against the intent of the legislature. He speaks about a letter that was sent to Department of Law that held up the initial trade regulations process and it was from a licensee.

Doug Moore comments that once the public comment period is done the Department of Law should be looking at the process the board went through. Dana Walukiewicz interjects 'it should be an unbiased review'.

Sarah Oates Harlow requests that she receive a copy of this letter because her phone is getting a lot of activity from the industry over this topic. She would not like to see the trade practices project bifurcated.

Doug Moore states he just saw the letter yesterday and the board has no desire to hold up this regulations project.

Kristina Serezhenkov states that staff has requested the letter is posted to the website for public access through the IT department as staff able to do this for AMCO are out of office and that it will be posted soon.

Next actions are discussed by the Board. Doug Moore motions to table the project to the next board meeting. Janice Hill seconds the motion. Janice Hill comments that the letter is puzzling and agrees that more time is needed by the board to digest the letter.

Kevin Richard brings up if the letter can be publicly posted online or if it is of confidential nature. Board discussion touches on the public process and Law has given permission to post the letter online.

All vote yes to table project. Motion carries.

B. Board Requests (if any)

Dana Walukiewicz speaks on guidance to local governments on the petition for additional restaurant or eating place and asks if the board would like to give specific guidance. Board discussion on process and what is considered an 'open' project. Diane Thompson would like to see more guidance on this process. Kevin Richard comments that the board could benefit from the development in the office of a framework of how the petitions are handled now and on the statutes and then present that to the board. Diane Thompson comments on the Juneau petition and that without the public testimony she would have had no idea that 7 people were ready to put their application in for licenses. Board discussion. Sara Chambers speaks about the board benefitting from input from the public and from licensees and this is called a scoping document to determine if a regulations project is necessary.

Doug Moore comments that all is spelled out in statute and notes statutory wording on providing 'additional justification' to demonstrate granting of additional licenses is in the public interest. His concern is license holders who believe their licenses are worth money and don't want competition. He notes that the legislature wrote the statue and allows for this and so it is allowed. He asks can you regulate a city to a standard that requires them (for example) to hold two public meetings with X amount of announcement for their resolutions? He does not believe we can regulate that. Dana Walukiewicz would like 'the additional information' requirement clarified to be more instructive to jurisdictions.

No other board requests are heard.

C. Paper Applications Discussion

Kevin Richard speaks to the number of paper applications still being submitted and asks if the board has a desire to exclude the paper applications all together.

Dana Walukiewicz mentions the diversity of the state in consideration but is inclined to enforce the digital application.

Doug Moore mentions that he doesn't agree with forcing people to apply digitally. He still feels that there's a place for paper applications.

Janice Hill agrees with Doug Moore because there are individuals that still don't own cell phones or computers. Elderly people may be affected who live low tech lives.

Dana Walukiewicz speaks to the fact that these are people that are in business selling alcohol and they should have technology to apply online. He thinks it's in the best interest of everyone.

Diane Thompson speaks to how the public comment is across the board that applications are taking so long. The office is burdened and licensees complain about the time it takes. She suggests upping the fee for paper applications so it's less of a burden on the office?

Sarah Oates Harlow speaks to this and has hesitations on going to full paper applications.

Kevin Richard clarifies his desire to gauge interest to investigate this further.

The board agrees they are interested and agree to a fact finding mission on the topic.
