

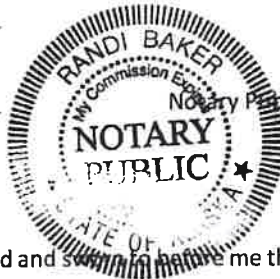

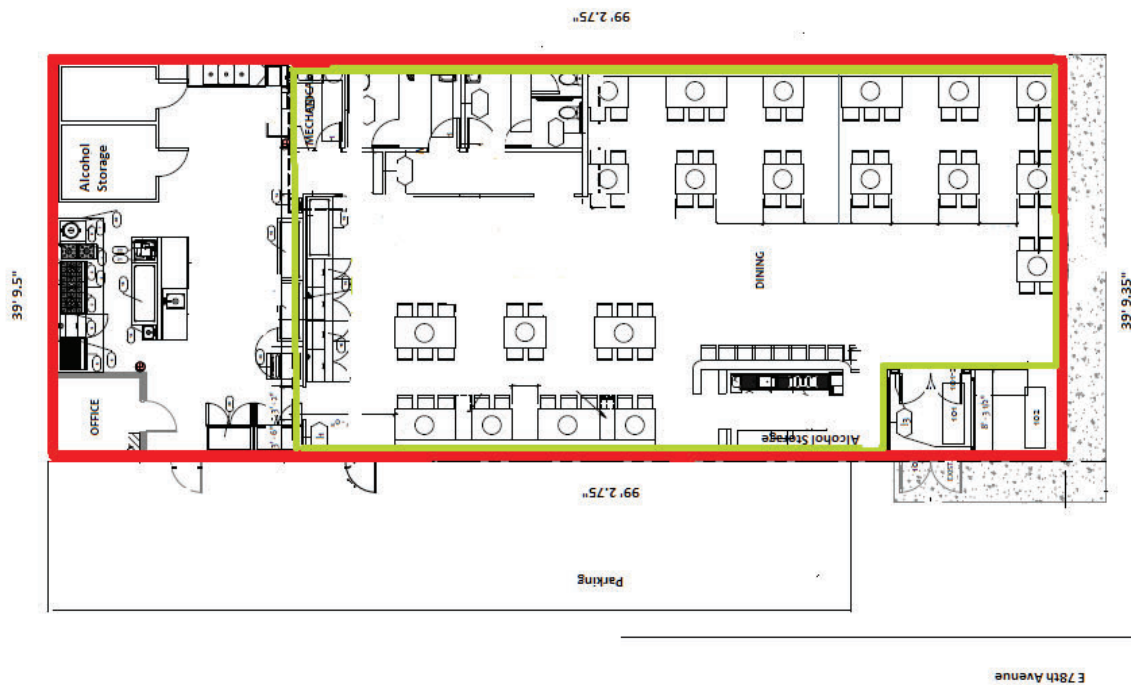

Underage staff will not have access to alcoholic beverages unless they are busing a table, when they are, they will be supervised by someone over 21 years of age.

Gogi will ensure that no alcohol is consumed or accessed by a minor in the establishment. All Gogi servers are TAPS certified. All minors must be accompanied by a parent or legal guardian (over the age of 21) while in the restricted area when any alcohol is being served, sold, or consumed. Underage persons will be monitored closely by our professionally trained alcohol servers. Servers will check the identification of all patrons ordering an alcoholic beverage and keep an eye on tables with minors to ensure they are not drinking alcohol. Proper signage will be posted at all points of entry indicating no minors may enter without a parent or legal guardian. All staff is trained in the identification of fake ID's. Keeping all serving areas viable without any increased risk to minors exposed to alcohol will continue to be part of our training for our staff. All servers will closely monitor that only the guests that have been carded with have alcoholic beverages.

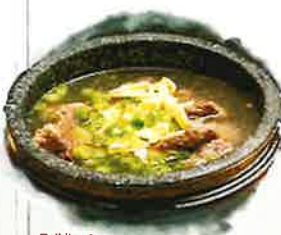
