- Dining by persons 16 2 20 years of age: AS 04.16.049(a) 2.
- Dining by persons under the age of 16 years, accompanied by a person over the age of 21: AS 04.16.049(a) 3.
- Employment for any persons under 21 years of age: AS 04.16.049(c)

NOTE: Under AS 04.16.049(d), a Department of Labor and Workforce Development work permit is not required to employ a person 18 - 20 years of age.

Underage persons will be monitored closely by our professionally trained alcohol servers. Servers will check the identification of all patrons ordering an alcoholic beverage and keep an eye on tables with minors to ensure they are not drinking alcohol. Proper signage will be posted at all points of entry indicating no minors may enter without a parent or legal guardian. All staff is trained in the identification of fake ID's. Keeping all serving areas viable without any increased risk to minors exposed to alcohol will continue to be part of our training for our staff. All servers will closely monitor that only the guests that have been carded with have alcoholic beverages.


