PUBLIC COMMENT PERIOD

Sara Oates Harlow with Alaska CHARR appreciates that the tabs and agenda are being posted earlier than in the past. She speaks to her support and excitement regarding the best practices page with guidance documents to come out. She touches on a number of changes that have happened in Anchorage such as mandatory ID checks being required at all establishments and how that was repealed a couple months later. She goes then points out that the FAQs on the AMCO website are outdated. She requests that the FAQs be updated. She goes on to mention the change in Trible IDs not being accepted as a form of ID and requests that there is more of an effort to be more public about changes.

Jana Weltzin added a shout out to Enforcement for the extra help lately, as well as all the AMCO staff. Public comment closed 9:35am

• DIRECTORS REPORT + DELEGATION OF AUTHORITY

TAB 4

Director Kevin Richard speaks about the Administrative Order that was issued by the Governor on May 9, 2025 and how it impacts AMCO. Mr. Richard explains that with the Administrative Order only regulations that have already gone to public comment are still being worked on. To work on new regulations projects, a waiver would be required. He mentions the waiver process for hiring under the Administrative Order. He speaks to the agency side of AK-ACCIS and how the office is working with the vendor on improving that since it is such a significant time expense to manually input paper applications. Director Richard asks that the board continue to consider the use of an online board management system to improve upon the tab system that is currently being utilized. He also touches on the AMCO website update for FAQs in an effort to improve a better first draft of submitted applications to improve licensing times.

Dana Walukiewicz asks if AK-ACCIS can facilitate a board control system like On Board.

Kevin Richard said that On Board is already ready when it would have to be added to AK-ACCIS.

Diane Thompson asks if transfers are available in AK-ACCIS.

Jane Sawyer responds by saying yes, but glitches are still being worked through in AK-ACCIS.

Kevin Richard talks about the Additional Delegation of Authority 3 AAC 305.035. He discusses temporary authority of issuing new license applications and transfers.

Dana Walukiewicz thanks the Director and recalls when the regulations were rewritten, how it was the intent to make sure that the Board was familiar with the activities that were delegated to the Director.

Kevin Richard expresses his understanding of the caution needed when considering temporary licenses.

<u>Motion:</u> To delegate authority to the Director by Diane Thompson. Second by Jan Hill. All vote yes. Motion carries.

The Board circles back to Public Comment.

LICENSING STATISTICS

Sonya Irwin speaks to the licensing report touching on the new, transfer, renewal, and endorsement applications in the queue.

Dana Walukiewicz speaks on transfers and the process and what it means to submit a complete application to qualify to be entered into the queue. He expresses his hopes that the best practices being added to the AMCO website will improve upon the evaluation times.

Doug Moore adds to the conversation about submitting a thorough application to be entered into the queue.

Dana Walukiewicz suggests if anyone is struggling to submit a complete application it might be a good idea to reach out to an attorney. They can be a helpful resource, however definitely not necessary. He would like to eventually see a visual representation of what the queue looks like in a public view. He hesitates to order that but believes it would be a good idea going forward.

Jane Sawyer says that it's been 18 months since we started with the new system and we are just now getting out from under the water in that system. It still has a lot of glitches, but we're getting there very slowly. She goes on to acknowledge that the oldest application in the queue is from February, which is 4 months.

Dana Walukiewicz stresses that it is **only** 4 months. Since the office used to provide guidance that it can take 6 months to process transfer applications. It's not that unusual, so please bear with the staff

Joe Bankowski speaks to the higher rate of inspections. Travel limitations due to the Administrative Order and how it affects the enforcement process. He mentions filling the vacancy of the Enforcement Specialist 1 position and the delay due to the Administrative Order on the hiring process. He includes that the DMV will be speaking to the board later today as a follow-up that the board requested at the last meeting. Mr. Bankowski includes that enforcement is continuing to work with the developers on integrating with the AK-ACCIS system for case management functionality.

Dana Walukiewicz asks about the basis of the non-rural investigations and what kind of follow-up happens based on the complaints.

Joe Bankowski responds by saying that investigations can stem from either a call to AMCO or a routine inspection which could then lead to an investigation.

Jane Sawyer describes how the statistics are currently generated via many spreadsheets, and we are looking forward to utilizing AK-ACCIS to generate reports in the future.

• Notices of Violation Issued and Licensee Responses

TAB 7

Diane Thompson asks if her recollections are correct that there was a fine for the underage kids working without a work permit.

Dana Walukiewicz responds by saying that, yes, he believes that her recollection is correct and that the investigators had found that there are a number of instances in which Olive Garden hired under 18-year-olds, which is allowable, but there still needs to be a Department of Labor permit for them to work there, and they had not done that. The investigators had obtained a list of the hours worked, and it was quite extensive. The Board directed the Director to issue an accusation which was done, and a stipulated agreement was made between Olive Garden and AMCO for reduced penalties. There is another NOV that is specifically related to a missing TAP card, but they are for the same entity.

Joe Bankowski adds that, yes, those violations were for two licenses but were under the same ownership.

Dana Walukiewicz moves onto the next NOV for Gallo's Restaurant. He states that this was an instance of a minor working there without Department of Labor approval and they had been working there for 5.5 months. The Board has been pretty consistent in the nature of these violations and essentially directing the Director to issue an accusation which usually results in a stipulated agreement.

Diane Thompson states that it looks like they've had 3 other NOVs in the last 5 years.

Dana Walukiewicz clarifies that there were NOVs for server education, pricing, and marketing.

Joe Bankowski confirms that those priors were through a different license, but under the same ownership.

Dana Walukiewicz continues with the concern that this entity has multiple restaurants and multiple BDLs. He goes on to say that we want to ensure that it doesn't become a pervasive problem throughout its chain of restaurants and that there's future compliance.

Doug Moore mentions that this one is different to him because yes, it was 5.5 months, but it was one person and not multiple people or a pattern. He points out that the two previous violations were for different reasons.

Dana Walukiewicz suggests we monitor the situation and keep an eye on it.

Rene Johnston speaks as a representative for Gallos to explain the circumstances and states that this wouldn't happen again.

Dana Walukiewicz appreciated the board feedback and states that we will keep an eye on them, agreeing that the previous violations were not under the same circumstance.

Dana Walukiewicz transitions into the next NOV from Uncle Joe's Pizzeria with a similar case with an underage person working without a permit. He mentions that it was a 1-time instance and asks if the board has concerns with this item.

No concerns stated by the board.

Dana Walukiewicz moves onto the Burger Fi NOV regarding a lack of server education card which was satisfied by completing certification and training. No issue with that one.

Dana Walukiewicz speaks about Phili's Pizza's NOV.

Jana Weltzin speaks as legal counsel for the licensee and explains that special events lead up to the NOV. She mentions that the city passed a motion to stop all alcohol sales at 10pm. She states that the management's focus is to maintain the 50/50 food/alcohol sales.

Joe Bankowski mentions the follow up communication with the licensee.

Doug Moore says that he's struggling with this one a little bit because some of the events in Anchorage have fallen under the same parameters.

Diane Thompson mentions that we should keep an eye on them.

Jana Weltzin states that they were just operating the live music event beyond the approved hours and they cancelled the third event in response to their mistake.

Dana Walukiewicz asks the board if they have any further discussion.

No further discussion.

Dana Walukiewicz continues onto the NOV regarding Soul Casa regarding server education cards and asks if they had submitted certification completion and if the fine was paid.

Joe Bankowski responded by saying that they are likely still in the window of time to be able to contest or pay.

Dana Walukiewicz asks if there is any further discussion or questions.

There is none.

Dana Walukiewicz moves onto Sammy's City Diner's NOV's for lack of server education course, and warning signs.

Dana Walukiewicz requests that enforcement follow up on the NOV for the warning signs and, if necessary, issue a fine.

- POPULATION AND LICENSE COUNT
 - A. Population and License Count Chart Overview

Kristina Serezhenkov introduces the population and license count chart and mentions that it can be found on the AMCO website. She goes on to say that the license type limitations are based on population. Certain types of licenses are not limited by population. She explains the dates and when the figures are determined and approved by the Director. Mentions that these charts will be updated once a year. She explains how to read the chart and gives an explanation as to what the graphics mean.

Dana Walukiewicz mentions that he is in support of these documents being available on the website but is concerned that it would need to be updated frequently so that a potential applicant wouldn't get the wrong information and think that there is a license available when one is not. He suggests that anyone interested in applying should reach out to the office.

Dana Walukiewicz thanks Kristina Serezhenkov for the work.

Jan Hill thanks Kristina Serezhenkov as well, this will help her answer the public's questions.

Sarah Oats Harlow from CHARR reads 04.11.405 and states that this is specific to the local government making petition for additional licenses over the population limits, which would equate to 4 for Homer. Previous public convenience licenses were converted to REPLs which then put Homer way over the 4 licenses. Yet during all the meetings, the discussion was about the issuance of licenses over what's been granted, not what are allowed under population limits. Those are two very different things for many cities.

Doug Moore breaks down what Sarah Oats Harlow was conveying by saying that they had 15 licenses, then the board approved 5 more, and that puts them at 20, but it doesn't technically put them at 20, it in fact puts them at 9.

Sarah Oats Harlow points out that the regulations section is later on in the agenda but would encourage the board to consider this as being an important public safety matter.

Dana Walukiewicz responds by saying that the local jurisdiction wouldn't know that information unless they

asked the AMCO office how many were granted and grandfathered in and in excess of that population limit. He does state that he believes the intent of the statute was to grant additional beyond what's already issued. He agrees that it's a good idea to clarify that it is indeed, in addition to those allowed by population cap, plus those that are previously grandfathered in. Otherwise, what would the point be of approving something like that where you couldn't issue anything.

Doug Moore asks about the number of licenses that are not REPLs, are the BDLs and PSL and all the other license types that are limited by population using the Matanuska Susitna Borough as an example.

Dana Walukiewicz then asks if 2 BDLs transferred to a city from the Borough? This would make it so the Mat-Su Borough wouldn't be able to get additional BDLs, correct?

Kristina Serezhenkov explains that her understanding is that if one license moves from a borough to a city, then a spot opens up in the Mat-Su.

Dana Walukiewicz asks if a license was transferred from Mat-Su to Wasilla, can that be done even though Wasilla is maxed out?

Kristina Serezhenkov responds to say that if the Board chooses to allow it, then, yes. Wasilla is, for example, maxed out with their BDLs at 7, so the one that moves to Wasilla is now a grandfathered BDL, and they will then be at 8 licenses.

Dana Walukiewicz asks if that would then open up a BDL in the Mat-Su.

Kristina Serezhenkov states that, yes, it would as far as she understands.

Jane Sawyer clarifies 04.11.400(k) transfers that go from the borough to a city and that both local governments need to approve that transfer.

Jana Weltzin mentions that only 3 per every 10 years can be transferred from the borough to the city.

Dana Walukiewicz thanks Kristina Serezhenkov for the presentation.

Dana Walukiewicz introduces an at ease regarding tab 47 to gather information. He states that there is now an agreed stipulated agreement for the Chop House at Lake Lucille and asks Director Richard to give a status update.

Kevin Richard updates the board to say that the accusation was issued to the licensee, there was an informal conference which resulted in an agreement to resolve the accusation. He outlines the agreement involving a fine and quarterly audits to ensure compliance with AS 04.09.450 and AS 04.16.049. These audits will be reported to AMCO enforcement.

Dana Walukiewicz speaks to the accusations in history's past and the resulting agreements. He expresses appreciation of the auditing portion of it and believes this is consistent with past agreements.

Dana Walukiewicz states that the manufacturer licenses are not competing, however the retail applications are competing. He says that he would like to hear from the licensees and how the competing applications would affect the manufacturer license applications. Sometimes the competing applications come down to a coin flip. Dana reads 3 AAC 305.100. He reads 305.105(e).

Jane Sawyer stipulates that the local government can display a preference, and they were just notified Friday, and the office has not heard back from local government.

Doug Moore expresses concern about proceeding at this stage.

Dana Walukiewicz points out the protest period being 60 days. He asks both competing applicants if they'd appreciate going forward with the manufacturer licenses knowing that one business has the possibility of not obtaining a retail license.

Andrew Wilson speaks to Dana's question as to how the manufacturer license as a stand alone would affect their business model. He states that they are dependent on the retail license.

Dana Walukiewicz asks if there's a representative for Harbor Mountain.

Zach Anderson states that they would not move forward with the manufacturing without the retail license.

Dana Walukiewicz thanks both of the applicants would require the retail license for both business models. He suggests that the items be tabled.

Kevin Richard mentions that he wanted to clarify that there's a process before any work can be done on any new regulations projects because of Administrative Order 358. If the board had a desire to draft or create a regulations project for SB-15, to clarify any of the language in it, or to create regulations to support it, then the ball is in motion on that.

Dana Walukiewicz says that he feels like SB-15 is clear.

Jane Sawyer asks for clarification on SB-15 regarding 18, 19, and 20 year olds being allowed to serve alcohol.

Diane states that that wasn't the original intention.

Dana Walukiewicz goes on to say that was not what was recommended by the board, and the language they supported was removed. As it is written currently, 18, 19, and 20 year olds are allowed to serve alcohol.

Kevin Richard mentions the reciprocity agreement between clubs and asks for any additional language.

Dana Walukiewicz asks if the office could draft some language for that.

Jan asks if that applies to any club.

Kevin Richard states as long as it's any patriotic association.

Doug states that he believes this is a good deal for the clubs.

Sara Chambers clarifies that if it hadn't been out for public comment, then it would be creating a new regulatory project. It would need a new public comment process.

Dana Walukiewicz asks if it would be exempt from the waiver process because it was already in process.

Kristina Serezhenkov clarifies that it was not out for public comment, it was waiting for laws' approval.

Dana Walukiewicz states he is hesitant to try to move it forward if law is not going to approve it. He includes that law's interpretation is that it needs to be the same at federal law. The Department of law will make the board change it to the federal level. He suggests that the board closes the project or table it.

Diane points out that this could affect package store licensees.

Doug and Dana agree.

Dana Walukiewicz asks for confirmation of the status of the regulatory project.

Kevin Richard speaks to the project being opened to provide something to the local governments as guidance regarding 04.11.405. He goes on to explain that there have been several different petitions that have come through with varying degrees of success, and each one has been presented differently, and the board has seen different approaches from different local governments. To promote consistency and make the deliberation process more simplified and uniform. If the office could provide something for the local government to give them understanding of what the board is looking for. He refers to his memo and two rough draft documents that lay out the requirements for a petition of this kind as well as a draft worksheet so that REPLs can provide with their submittal to capture information the board wants to see to help with the decision-making process.

Sarah Oats Harlow from Alaska Charr states that she has one request and one recommendation. The request pertains to tab 9 and the population figures. She states that they don't meet the requirements of 3 AAC 305.900, which specifically states that it has to show the quota of licenses available under AS 04.11.400(a)(2), which is per population limits. Currently, that's for those local governments that have added or requested for additional licenses like Homer and Haines. All that is listed there is the quota of licenses, plus. It does not show the number that would be allowable just by the population. She states that she believes this information is very important information for the board, public industry as well as being required by regulation. She clarifies that that is her request. She continues to say that her suggestion is that by going forward other pieces of information provided by the local government that have been granted additional licenses previously, be how many of those licenses have been built or not.

DIVISION OF MOTOR VEHICLES PRESENTATION

See recording starting at 04:35:16.

Discussion on the statute that states credentials are only valid if encased in plastic and presentation on the new mobile ID application for the DMV.

Dana Walukiewicz comments that he believes it would be beneficial to the industry to allow for it if the Department of Law says that there's room there for the board to provide guidance to the staff and enforcement.

Kevin Richard offers that it might be advisable if AMCO and DMV attorneys get with law and have something prepared by the September meeting for the board to be able to offer guidance on. Currently there is no clarification as to whether the statute is accepting of this. It would be beneficial to have that clarification

before issuing guidance.

BOARD COMMENTS

Diane Thompson speaks about the possibility of having the staff over for lunch and seeing if they'd like to do a tour of a brewery at King Street. Possibly in the fall.

Dana Walukiewicz expresses a desire to have staff come over for an educational talk about the brewing process.

Doug Moore says he's happy we're all here and appreciate the two-meeting process and is 100% on board.

Jan Hill echoes the same sentiment and is very happy to be participating in person. She is happy that there are two meetings now and feels like she has more understanding after every meeting.

Dana Walukiewicz says that how you become a good bartender is you make a drink and taste it. He says he is concerned about the direction this may go in when there are 18–20-year-olds. He echoes everyone's comments on the two-meeting format being beneficial. He appreciates the HME and LRE clarifications. He thanks the staff for all the hard work.
