



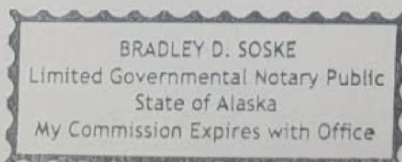

Policies and Practices

Our establishment maintains strict policies to ensure that persons under 21 years of age do not gain access to alcoholic beverages while dining or employed on the premises.

Dining Area Controls: Guests under the age of 21 are identified through mandatory ID verification at the point of service. Alcoholic beverages are served only by employees. Signage is posted in visible areas reminding patrons that alcoholic beverages will not be served to anyone under the age of 21. Persons under 16 must be accompanied by a person at least 21 years of age while in the dining area.

Employee Restrictions: No persons under the age of 21 is employed

Storage of Alcoholic Beverages: Alcoholic beverages are stored in a secured stockroom and behind the bar in restricted-access areas. Only employees 21 years of age or older are permitted to access or handle alcoholic beverage storage areas. Inventory is monitored and logged regularly to prevent unauthorized access.

Compliance Training and Oversight: All employees receive training regarding state alcohol laws, ID verification procedures, and company policies.

By implementing these policies, practices, and procedures, we ensure that alcoholic beverages are stored securely, served responsibly, and never made accessible to persons under the age of 21.

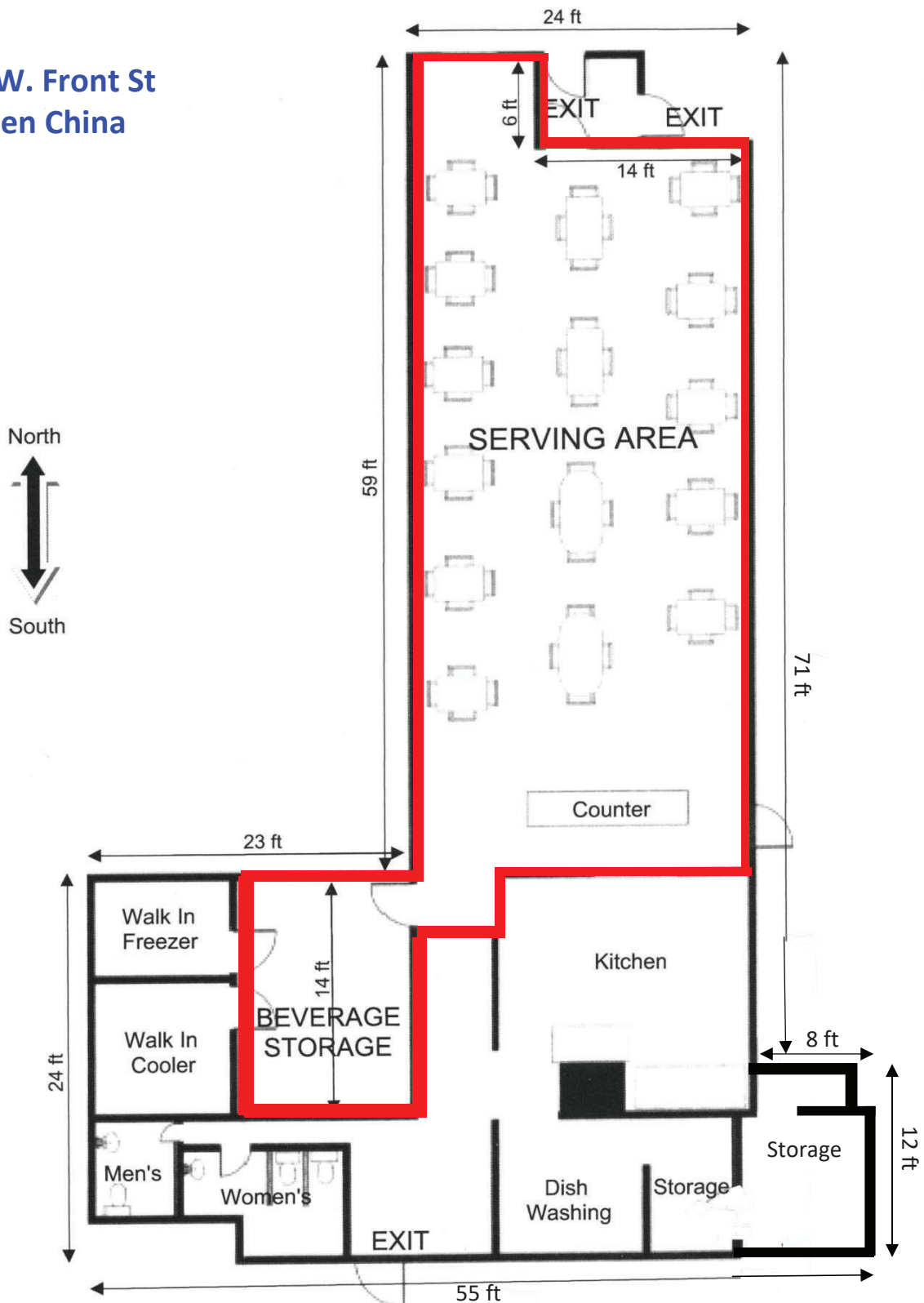
