On 05/04/2024 AMCO Investigator Johnson was informed by Ketchikan Airport Police Officer Nunnally he issued two citations to bartender William O'Brien of the Ketchikan Airport Lounge & Snack Bar for AS 04.16.030(a)(1) & AS 04.16.030(a)(3). Mr. O'Brien during an interview with Officer Nunnally admitted he over-served an individual but did not admit the individual was drunken upon entrance. The individual caused a disturbance on an Alaska Airlines flight after it left the terminal which in turn caused the crew to turn around and return to the terminal removing said individual from the flight. See attached Police report.



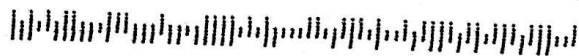
