RE: Transfer of Beverage

Dispensary License and Restaurant Endorsement.

This and That Grill, LLC in Fairbanks is applying for the transfer of beverage dispensary license 4247, at 3578 Airport Way, from Restaurant Concepts, LLC, and a new restaurant endorsement.

The City of Fairbanks is protesting both the transfer application and the restaurant endorsement application "until construction is finished and the building is ready for inspection" (protest attached).

The protest appears to be "...subject to rescission and it will be withdrawn if the applicant meets the conditions set..." 3 AAC 305.085.

Staff recommends the board deny the transfer and restaurant endorsement application with a 180 day abeyance under 3 AAC 305.085(h), and delegation to the director to approve and issue the license.

Patrons must be at least 21 years old to be served alcohol.

All patrons must show bona fide (legally acceptable) I.D. Examples include: Driver's license, State-issued identification card, Military identification card, and Passport.

Alcohol service will cease at one hour before closing.

Is an owner, manager, or assistant manager who is 21 years of age or older always present on the premises during business hours?


