Renewal Application

**Applicable statute: AS 04.11.330 Denial of license or permit renewal.**(a)(3). An application requesting renewal of a license or endorsement shall be denied if the applicant has not operated the licensed premises for at least 240 hours during each of the two preceding calendar years, unless the board determines that the licensed premises are under construction or cannot be operated through no fault of the applicant...

Applicable regulation: 3 AAC 305.120 Waiver of annual operating requirement and minimum operating requirements.(a) Except as provided in this section, the board will deny an application for renewal of a license or a license with one or more endorsements if the licensed premises were not operated for the time required under AS 04.11.330(a)(3) or (d)....

- (c) A waiver application for a calendar year must be made in writing to the board and must be accompanied by the non-refundable application fee of (1) an amount equal to one-half the applicable biennial license fee if a waiver application was not made for the previous year; or (2) double the amount of the fee paid for the previous waiver application....
- (e) The board may deny a third or subsequent, consecutive application for waiver (1) unless the licensee clearly shows that the licensed premises were not operated, because the premises were condemned or substantially destroyed by any cause...
- (f) Absent circumstances to the contrary, the board will deny a third or subsequent, consecutive application for waiver in the event of condemnation or destruction of the premises identified on an applicant's license are not leased or owned by the licensee...
- (g) The board may impose conditions along with the approval of a waiver application.
- (h) If a waiver application is denied, an application for license renewal for the succeeding license period will be denied by the board under AS 04.11.330(a)(3).

**3 AAC 305.085 Local governing body protest.**(h) The board may uphold a protest of an application or continued operation with an initial abeyance period of not more than 180 days if the local governing body indicates that the protest is subject to rescission and that it will be withdrawn if the applicant meets conditions set by the local governing body. If the local governing body notifies the board within the period of the abeyance that the protest has been removed, the application or continued operation will be approved when all other applicable requirements have been met. If the local governing body has not notified the board within the period of the abeyance that the local governing body has removed the protest, the application or continued operation is denied.

If the protest is not a conditional protest, then other rules apply and... the board shall deny the application or continued operation unless the board finds that the protest is arbitrary, capricious, or unreasonable - AS 04.11.480 Protest.

Background: This is the third waiver requested for this license. Licensee states that the denial of the transfer of location application from local government and lengthy appeal process lead to an inability to operate. Denial letter sent October 3, 2022. Third waiver with 2024-2025 renewal application were tabled at April 15, 2025, board meeting. Item tabled again at June 17, 2025, board meeting with MOA protest. A transfer application for the license was received and entered into queue as of August 28, 2025. Waiver application for 2025 has not yet been received. 2025 waiver applications are due November 14, 2025.

The MOA decided to postpone the special land use permit vote several times waiting for AMCO'S decision to approve to the separation distance of the proposed location and the school. July 2023 The MOA still did not received decision regarding the school issue, so the MOA postponed the SLUP vote indefinitely. At which time I appealed to the office of the administrative judge and later the Superior Court.

THE DECISIONS FROM THE BOTH OAJ AND THE SUPERIOR COURT BOTH DENIED THE TRANSFER ONE AFTER THE OTHER ENDING IN MID TO LATE 2024.

Re: Liquor License Fees Waiver Refund Request-2023 and 2024

I am requesting a refund of liquor license waiver fees for LED 2023 and 2024. I am making my request based on the following:

- 1. I applied for the liquor license transfer in Sept 2021 and the Municipality protested the liquor license transfer to the new location. I paid the MOA \$4,720 for a Special Land Use Permit (SLUP) that was forwarded to the Assembly with recommendations for approval by the Mayor's office and the staff from public works office for the license transfer. While the MOA waited for AMCO to approve the separation distance of a nearby school, the MOA continued to postpone the vote for SLUP over and over. Due to the length of time it took AMCO to approve the issue regarding the school, the MOA had postponed the SLUP vote indefinitely. At this time with the request of both AMCO Director's Ms. Joan Wilson and myself requested a vote for the SLUP. The MOA refused to bring back the SLUP to vote. In November of 2023, at the ABC Board meeting in Juneau I was present at the meeting to request the Board to overturn The MOA protest. After the discussion a motion was made to overturn the protest. However, there was no second to the motion. At that time I appealed to the Office of the Administrative Judge and then later the Superior Court. Both decisions were to uphold the protest. I believe this decision came much late in 2024.
- 2. I invested a substantial amount of money preparing for the new location that was denied, leaving no funds for an additional location.
- 3. After paying for a special land use permit that was never voted on, attorney fees, lease payments, renovating fees for the new location, loss of revenue stream, etc., I was unable to fund other options to continue with all of this not in my favor.
- 4. I understand the waiver fee process, but these circumstances are not typical and due to the protest and the time it took AMCO to approve the distance between the school and the proposed location and my strong efforts to open I was denied. I believe that I should not be subjected to these fees.

- 5. My efforts to continue my 8 year business at the new location has cost me hundreds of thousands of dollars with no returns.
- 6. In order to renew my license, AMCO has charged me these fees.

#### Resolution:

• I am requesting to the board that these waiver fees that was paid on March 28th, 2024 be refunded based on the circumstances outlined above.

The Anchorage Municipal Assembly at its regular meeting on **May 20, 2025** took the following actions:

#### WAIVE OF PROTEST
