This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 03/22/2024 at approximately 1301 hours, Investigators Linger and Hamilton, entered the AMVETS Post #49 located in Anchorage, AK. Bar Tender, Victoria Blaylock, identified by her AK ID asked if we were members. We told her we were not members and she asked if anyone wanted to sign us in. An unidentified man signed us in. Blaylock asked what we would like and I ordered a Heineken beer and club soda with lime. Inv. Linger was served the Heineken beer. Inv. Linger paid for the beer with prerecorded buy funds, a \$10.00 bill S/N: MF 82154202 C. Inv. Linger identified who we were to Blaylock and explained the violation that just occurred. Blaylock admitted she knew she couldn't sell alcohol to non-club members. Blaylock was issued citation# P00355226 for the violation and it was filed with the Anchorage Court Court on 03/26/2024.

This is in violation of AS 04.09.220 Club License

(d) Alcoholic beverages sold under a club license may be purchased only by

- (1) members of the club and their families;
- (2) widows or widowers of deceased members of the club who have been accorded club privileges; and
- (3) military personnel on active duty who are extended the privilege by patriotic organizations


