This 2025-2026 renewal application was deemed complete and scheduled for September 2025, Board Meeting for approval. A protest was submitted by the Kodiak Island Borough shortly before the September 2025, Board Meeting and was to be considered with the renewal. At the September meeting, the Board tabled the renewal application and protest to the November 2025, Special Board Meeting. At the November meeting, the Board tabled the renewal and protest to the January 2026, Special Board Meeting for consideration.

"The KIB Assembly objects to the renewal of License #4860 for the following reasons: The business has no active business personal property or real property accounts on record. The Assessor's Office confirmed with both Southern Glazer's and Odom that the listed address, "Bay 2," does not exist. Southern Glazer's does not appear to have employees or a physical storefront in Kodiak and is reportedly billed by Odom for local sales. It remains unclear whether Southern Glazer's is actively wholesaling in Kodiak. The business license details show that the physical address for this specific business license is located in Anchorage, Alaska. The actual license states that it "must be posted in a conspicuous place at the business location. It is not transferable or assignable."

*Under 3 AAC 305.085(h) The board may uphold a protest of an application or continued operation with an initial abeyance period of not more than 180 days if the local governing body indicates that the protest is subject to rescission and that it will be withdrawn if the applicant meets conditions set by the local governing body. If the local governing body notifies the board within the period of the abeyance that the protest has been removed, the application or continued operation will be approved when all other applicable requirements have been met.*  
*If the local governing body has not notified the board within the period of the abeyance that the local governing body has removed the protest, the application or continued operation is denied.*

*If the protest is not a conditional protest, then other rules apply and... the board shall deny the application or continued operation unless the board finds that the protest is arbitrary, capricious, or unreasonable – AS 04.11.480*

Dear Members of the Alcoholic Beverage Control Board,

The Kodiak Island Borough (KIB) has received notice of the application for renewal of General Wholesale License (GWL) #4860, held by Southern Glazer's of Alaska, located at 5152 Tom Stiles Road, Building B – Bay 2. Pursuant to AS 04.11.480 and 3 AAC 305.085(a), the KIB Assembly formally protests the renewal of this license. The basis for this protest was communicated to the licensee by letter dated August 22, 2025, and an opportunity for an informal hearing was provided on September 11, 2025.

**Under AS 04.11.480 and 3 AAC 305.085, local governments may protest the renewal of a liquor license based on facts that make the application objectionable to the governing body or on general public policy grounds (3 AAC 305.085(e)).**

The KIB Assembly objects to the renewal of License #4860 for the following reasons:

- The business has no active business personal property or real property accounts on record.
- The Assessor's Office confirmed with both Southern Glazer's and Odom that the listed address, "Bay 2," does not exist.
- Southern Glazer's does not appear to have employees or a physical storefront in Kodiak and is reportedly billed by Odom for local sales.
- It remains unclear whether Southern Glazer's is actively wholesaling in Kodiak.
- The business license details show that the physical address for this specific business license is located in Anchorage, Alaska.
- The actual license states that it "must be posted in a conspicuous place at the business location. It is not transferable or assignable."
