Timeline of Events:

11/19/2024: 3rd & 4th Waiver of Operations approved by ABC Board on the condition that a Transfer application be filed within 180 days.

5/12/2025: Transfer of Ownership & Location for BDL #3299 filed and placed in queue 5/12/2025, within the 180-day timeframe.

8/20/2025: 2025-2026 Renewal Application for BDL #3299 deemed complete, and notices for application sent, including notice to City of Kodiak and Kodiak Island Borough.

8/21/2025: Transfer of Ownership & Location deemed complete by AMCO staff. Notices for application sent, including notice to City of Kodiak and Kodiak Island Borough.

9/16/2025: 2025-2026 Renewal Application and Transfer Application approved with delegation by ABC Board at Regular Board meeting.

10/7/2025: City of Kodiak files protest of the 2025-2026 Renewal Application and the Transfer application due to Fire Marshal non-compliance. Their protest memo is provided in TABs 15 & 17 for this Agenda.

11/25/2025: ABC Board considers 2025-2026 Renewal and Transfer Applications with the City of Kodiak's protest. ABC Board chooses to table consideration till next special board meeting to allow time for transferee to work with the Fire Marshal on getting compliant.

12/31/2025: 5th Waiver of Operations is filed without payment. The Renewal and Transfer are unable to be effectuated due to the protest.

Applicable statute: AS 04.11.330(a)(3). An application requesting renewal of a license or endorsement shall be denied if the applicant has not operated the licensed premises for at least 240 hours during each of the two preceding calendar years, unless the board determines that the licensed premises are under construction or cannot be operated through no fault of the applicant;...

Applicable regulation: [3 AAC 305.120 Waiver of annual operating requirement and minimum operating requirements.](#) (a) Except as provided in this section, the board will deny an application for renewal of a license or a license with one or more endorsements if the licensed premises were not operated for the time required under [AS 04.11.330\(a\)\(3\)](#) or (d).

(b) A licensee may submit a waiver application to the board to request a waiver of the operating requirement in [AS 04.11.330](#) (a)(3) or (d). Under [AS 04.11.330\(a\)\(3\)](#), the board will determine whether, through no fault of the licensee or because the premises are under construction, the licensed premises could not be operated for the required time during the preceding calendar year.

(c) A waiver application for a calendar year must be made in writing to the board and must be accompanied by the non-refundable application fee of (1) an amount equal to one-half the applicable biennial license fee if a waiver application was not made for the previous year; or (2) double the amount of the fee paid for the previous waiver application.

(d) A waiver application must include a statement from the licensee explaining why the licensed premises was not in compliance with [AS 04.11.330\(a\)\(3\)](#) or (d). The licensee must provide a copy of the waiver application to any local governing body with jurisdiction over the license and licensed premises.

(e) The board may deny a third or subsequent, consecutive application for waiver (1) unless the licensee clearly shows that the licensed premises were not operated, because the premises were condemned or substantially destroyed by any cause; ...

(f) Absent circumstances to the contrary, the board will deny a third or subsequent, consecutive application for waiver in the event of condemnation or destruction of the premises if the premises identified on an applicant's license are not leased or owned by the licensee. Additionally, a third or subsequent consecutive application for waiver that does not identify a licensed premises location will be denied.

(g) The board may impose conditions along with the approval of a waiver application.

(h) If a waiver application is denied, an application for license renewal for the succeeding license period will be denied by the board under [AS 04.11.330\(a\)\(3\)](#).

(i) In addition to the application fee under (c) of this section, the applicant shall pay \$1,000 for an application that is received too late for board consideration at its last meeting of the calendar year for which the waiver is requested.

(j) In the event of the death of a licensee, destruction of the premises, or comparable circumstances showing extraordinary hardship, the board may waive fees required under (c) and (i) of this section.


Continued from section 3- Another issue we have had is Landlords are specific in using only certain companies for personal reasons. Either financial and or possible issues with those companies. At once point I even reached out to Taylor fire to see what time line they had, they were on island doing a project and not available immediately for work. I tried to assist were I could to alleviate some of the stresses of communicating what was needed for repairs. I also provided the fire inspection reports so they could get a good idea of what kind of work was needed to try and get a time line and when a crew would be available.

Back in 10/2024 we submitted a 4th AB-29 form and attended a board meeting, we were granted an extension to submit paper to do a transfer of ownership of the liquor license and location Transfer. We were granted 6 months from the board meeting time to submit all paper work. We met that deadline and submitted everything needed. My self-Antonia Bravo made sure everything was needed and communicated several times via phone calls to AMCO main office phone number 907-269-0350 and emailing to ensure premises drawings and all documents had been received and in good standings. Our case file didn't have any one assigned until late August 2025-Sept 16, 2025 and in review. We have exhausted communicating with both owners at both locations to expedite repairs that were needed in a timely manner. There has been a lot of confusion as well with protest being lifted at 402 Marine way suite #100. We are asking the City of Kodiak to provide us with updated paper work to ensure that is documented properly. We have also been communicating with Kyle the Fire inspector when updated small repairs have been completed. I've provided photos as well via email to Kyle for his records and ours. We have attended all meetings and kept up on all are other license to keep in good standing. We have been working hard to not to have another waiver, we had plenty of time but this time it was not are doing. We have tried to do everything we can to not have to have more fees imposed on our business. It has been very difficult being the tenant, are hands are tied. We are doing the best we can with what we can do. We ask the penalties be lifted as we were notified that we needed to once again file another AB-29 form. I'm new to all of this and it has been very hard on me managing many things and trying to keep all of this together for my family we depend on this. We have also paid all fees which have been in large amounts and we do understand those are the rules and we have complied and paid the waiver fees. I've been working on this paper work for about a year and three months. We really want to use our license; we have so many community supporters waiting for us.






