Endorsement

This is an application for a Restaurant Endorsement by Scott Van Valin, dba King Fisher Lounge. Mr. Valin holds a beverage dispensary license. The board is to determine whether the BDL premises qualify for a Restaurant Endorsement.

The board will read in the email correspondence attached that the kitchen and restaurant are not part of King Fisher Lounge BDL's premises; they are a separate entity and business.

AS 04.09.450. Restaurant endorsement.

(a) A restaurant endorsement authorizes the holder of a beverage dispensary license, fair license, golf course license, sporting activity or event license, club license, outdoor recreation lodge license, destination resort license, or beverage dispensary tourism license to allow a person

(1) under 21 years of age access as provided in (e) of this section to the premises of a bona fide restaurant on the licensed premises; and

(2) to enter or remain on the licensed premises to consume food or nonalcoholic beverages as authorized under AS 04.16.010(c)(5).

(b) The biennial fee for a restaurant endorsement is \$200.

(c) An application for a restaurant endorsement must specify the establishment or portion of the establishment that constitutes a bona fide restaurant.

(d) The board may issue an endorsement under this section only if the board finds

(1) that the establishment or portion of the establishment for which the endorsement is requested is a bona fide restaurant;

(2) there is supervision on the premises adequate to reasonably ensure that a person under 21 years of age will not obtain alcoholic beverages, except as provided under AS 04.16.049(d); and

(3) that it is unlikely that persons under 21 years of age not employed on the premises will enter and remain on the premises of the bona fide restaurant for purposes other than dining.

(e) The board may authorize the holder of a license with a restaurant endorsement

(1) to allow a person who is at least 16 years of age but under 21 years of age to enter and remain on the licensed premises for dining only;

(2) to allow a person who is under 16 years of age to enter and remain on the licensed

premises for dining only if

(A) the person is accompanied by a person who is 21 years of age or older; and

(B) the parent or guardian of the person consents to the person being on the licensed premises; and

(3) subject to AS 04.16.049, to employ or permit the employment of a person who is at least 16 years of age but under 21 years of age on the premises of the bona fide restaurant if the employer provides adequate supervision to ensure that an employee who is 16 or 17 years of age does not obtain alcoholic beverages.

(f) The holder of a license who engages in activity under this section without an endorsement under this section commits the offense of unendorsed restaurant service.

(g) The holder of a restaurant endorsement who engages in activity not authorized by the board under (e) of this section or fails to comply with the requirements of (e) of this section commits the offense of restaurant endorsement noncompliance.

(h) Unendorsed restaurant service is a violation and is punishable by a fine of \$500.00

(i) Restaurant endorsement noncompliance is a violation.

3 AAC 305.335. Restaurant endorsements. (a) A restaurant endorsement as described in AS 04.09.450 is available in addition to a license identified at 3 AAC 305.330(a)(4) to holders of a club license, sporting activity or event license, outdoor recreation lodge license, fair license, golf course license, or destination resort license if the establishment or portion of the establishment for which the endorsement is sought is a bona fide restaurant as defined at AS 04.21.080(b).

(b) An application for a restaurant endorsement must include a premises diagram specifying the establishment or portion of the premises to be subject to the endorsement and a security plan that demonstrates how the endorsement holder will comply with

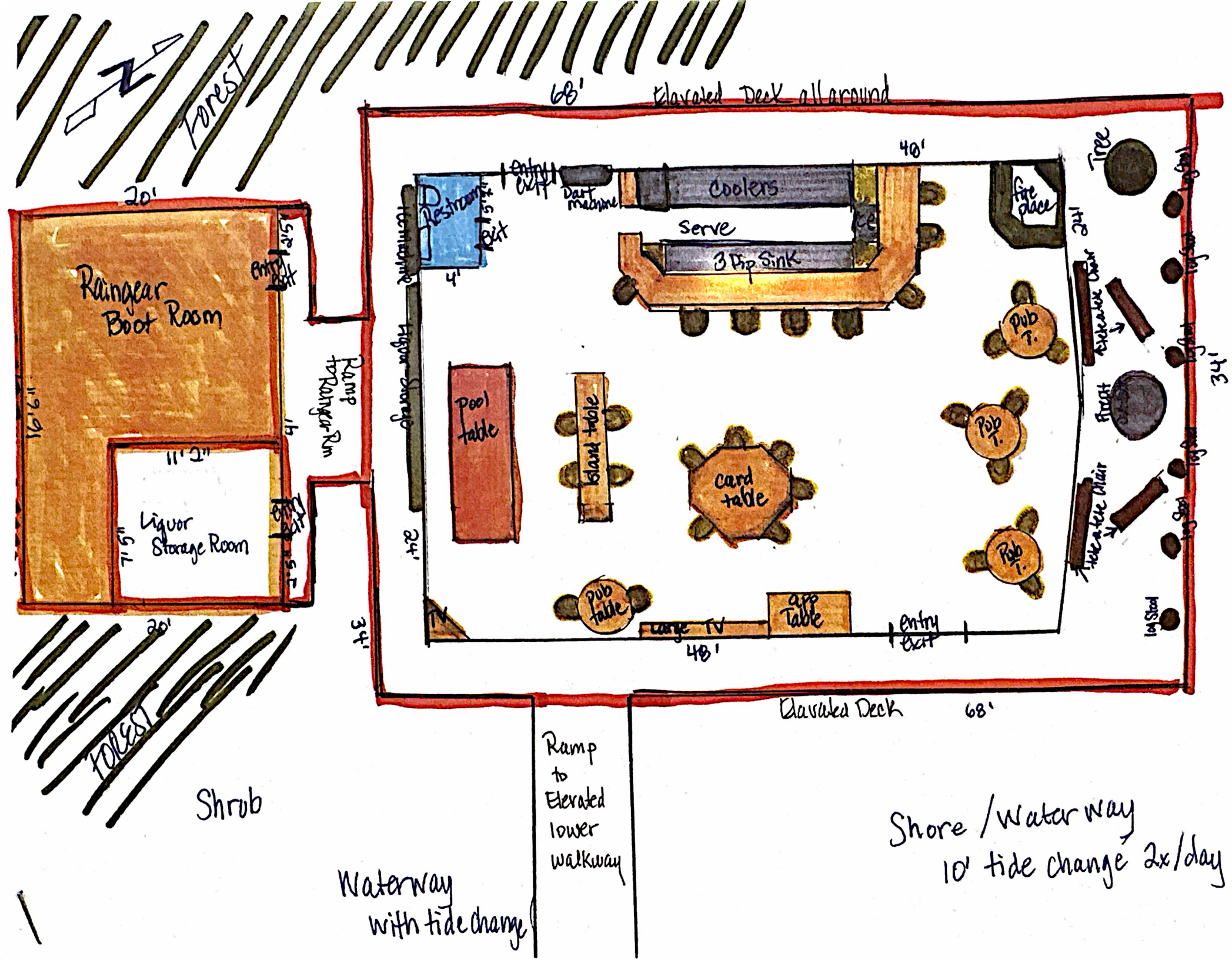
Hello, Nani,

Here is my follow up on your responses to the restaurant endorsement. I have more questions or request(s) for clarification. (I'll touch on the hotel motel endorsement in a separate email).

(from prior email correspondence – my questions are in blue, your answers are in red, my follow up in green)
I have the following initial questions,

- What is the boot room? **Store room for foul weather gear, rain jackets/bib/boots – okay. thank you. It looks like you consider that part of the licensed premises of the bar, King Fisher Lounge.** No, we don't. We were asked to provide a diagram of the bar facility and this building is 25' from the bar building so we included it in the diagram. It is NOT part of the bar facility
- the licensed person/entity/holder of the bar license is Scott Van Valin DBA King Fisher Lounge (not El Capitan Lodge).
 - what is the relationship between King Fisher Lounge and El Capitan Lodge? **King Fisher Lounge leases the building from El Capitan Lodge – okay. thank you.**
- which part of the establishment is the restaurant, **The Dining room is in a separate building located across from the KFL – okay. Not part of the licensed premises of the King Fisher Lounge.**
 - who owns and runs it? **El Capitan Lodge, LLC - okay. Not part of the licensed premises or leased premises to Scott Van Valin DBA King Fisher Lounge.**
 - who is making and providing the food? **Chefs employed by El Capitan Lodge – okay.**
- label the kitchen on the diagram itself, **Kitchen is in a separate building not attached to the Lounge. Unable to label the kitchen on the diagram because it is not connected to the Lounge, therefore not shown on the diagram. – I received the diagram you attached to show El Capitan Lodge's kitchen, dining area. Thank you.**
- provide a diagram of the kitchen, and its equipment **See Attached Diagram; Kitchen equipment includes Stove/Oven/Fryer; Refrigerators; Kitchen Sinks; Storage – Received. Thank you.**
- the menu for the King Fisher Lounge only lists alcoholic beverages. **Page one of the Guest Menu, lists food; page two is the alcohol beverage menu; On the guest menu, Day 1, 2, 3 "Appetizers" are served in the King Fisher Lounge – okay. thank you. BUT the licensed area of King Fisher Lounge is better known as a bar (there is a bar, pool table, card table, pub tables) and not a restaurant, is that fair to say? Correct AND, are you requesting the Restaurant Endorsement be issued to El Capitan Lodge (a separate business to King Fisher Lounge) and not King Fisher Lounge owned by Scott Van Valin? It was my understanding that this endorsement is required for the KFL with the Beverage Dispensary license as we do have persons under 21 on occasion with their family when at the Lodge as Food is served there/delivered by El Capitan Lodge Kitchen. When renewing 2 years ago, the gal in your office that was assisting me, she basically was saying this was what I was supposed to do. (we had issues trying to do it online as it wouldn't recognize Scott's SS# in the system)**
 - Who is the maker and the food provider of the list that is called "Guest Menu? **Chefs employed by El Capitan Lodge – okay. thank you.**

King Fisher Lounge
Policies, Procedures and Standards
Security Plan:
Preventions of Alcohol Transfer and Access Control

Applies to: King Fisher Lounge and El Capitan Lodge Employees effective upon season opening

Purpose:

The primary goal of this security is to prevent the unauthorized transfer of alcohol across the premises boundary and, more specifically, to restrict access to alcohol by minors. This plan encompasses personnel, practices, and physical barriers to ensure compliance with legal regulations and maintaining a safe environment for all patrons. The King Fisher Lounge and El Capitan Lodge are not open to the public. The lounge is an amenity for El Capitan Lodge guests to enjoy.

Personnel and Training:

Employee Training:

All employees involved in the sale or service of alcohol will undergo mandatory training on responsible alcohol service, including identifying and preventing sales to minors.

Identification and Verification:

Age Verification:

All individuals provide their drivers license to El Capitan Lodge in order to obtain a state of Alaska Fishing license. The El Capitan Lodge office advises all persons serving alcohol of any underage individuals. Underage patrons travel with their parents or grandparents. There will be no underage employees at both King Fisher Lounge and El Capitan Lodge.

Staff Intervention:

Staff members are empowered to refuse service or access to individuals who display signs of intoxication.

Physical Barriers:

The King Fisher Lounge is on private property and only for El Capitan Lodge guests and employees. It is in a remote location in Sarkar Cove, 50 miles NW of Klawock, AK

Gates and Entrances:

We are remote with limited access to the property. No outside guests are allowed to visit unless permission is granted by owner/managers. King Fisher Lounge and El Capitan Lodge are situated on private property with a gate at the entrance one mile out.

Secured Alcohol Storage:

Alcohol storage areas will be secured with restricted access, accessible only to authorized personnel.

Monitoring and Enforcement:

Surveillance System:

Camera's will be installed covering key areas where alcohol is served and stored.

Regularly review surveillance footage to identify any suspicious activities or potential violations.

Communication:

Maintain effective communication with all employee's that are involved with serving alcohol and monitoring alcohol consumption.

Hours of Service:

The King Fisher Lounge is open from 4p – 12p.

Outside Security Plan:

Monitor Patrons alcohol consumption who are sitting outside the dining room/guest cabins/walkways/King Fisher Lounge. Camera's will be installed to monitor outside area's and reviewed regularly.

King Fisher Lounge/El Capitan Lodge guests are not permitted past the office to the employee housing area. An exception is if aircraft are not able to land at the Lodge and guests have to drive out to another location to arrive/depart for their fishing experience.

Outside public patrons are not allowed on property.

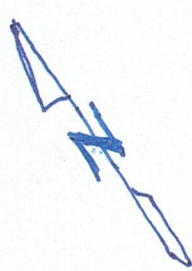
