



Outdoor Seating Security Plan

Physical Restrictions

The outdoor seating area will be entirely contained by a rope barrier. Entry to the outdoor seating area is restricted to two access points which are visible to the taproom staff at all times. The first access point to the outdoor seating area is located immediately north of the main taproom doors, on the West wall of the building. The second access point to the outdoor seating area is through the North taproom doors on the West wall of the building. Taproom staff have a clear and unobstructed view to both access points at all times.

The height of the rope barrier will not interfere with visual access to the fire standpipe, nor will it prevent emergency access to it.

Signage

Signs on the north door and the main entrance will state that beer may not be consumed outside except in the designated outdoor seating area. There will also be signs at each access point to the outdoor seating area stating that all beer must remain in and be consumed in the roped outdoor seating area.

Staff Training

Staff will be trained to treat the access points to the outdoor seating area as they do the entrances to the indoor taproom area. Training will include the importance of ensuring unaccompanied minors do not enter the outdoor seating area via either access point. Training will also include ensuring that beer does not leave nor is consumed outside of the roped outdoor seating area.

There are large windows that face directly onto the outdoor seating area. Staff will be trained to make frequent visual observations of the area and to enter the area on a regular basis to monitor activity.

All staff will be TAP certified and trained in the outdoor seating area security plan. Training will emphasize the importance of ensuring that alcohol does not leave the outdoor seating area and that minors do not have access to alcohol in the outdoor seating area. Staff will be trained in how to correct any security concerns that may arise in the outdoor seating area.

Describe the entire tract of land by using directions and distances:

The brewery is located on a single 42,007 SF tract of land with the legal description: Tulin-Jacobson Industrial Park, Lot 5B. On the tract there is one 20,926 SF building (144 E. Potter Dr.) in which the brewery occupies 3,913 SF. The brewery is in the northeast corner of the building. Other building tenants include a produce retailer, construction company, and a communications company.

Describe the brewery premises.

The brewery is depicted in the diagram submitted with this application. It is a single unit within the building. It is comprised of public tavern (or taproom) space for on-premises sale of beer and brewery operations space that is non-public.

The taproom features a storefront accessed via one set of locking double doors (Door 1) with two 6 ft. wide, non-opening windows on either side and accessed via one 3 ft. wide locking man door (Door 2) with a 9 ft. wide non-opening window to the South.

Behind the taproom area, to the West, is the 15.50 ft. by 10.33 ft. Serving Cooler for storing tax-determined beer in bottles, kegs and serving tanks for use in the taproom. The three serving tanks have a working volume of 15 bbls. and are gauged with calibrated sight glasses. The door to this cooler is lockable.

Behind the Serving Cooler, to the West, is the Bulk Cooler for storing un-taxpaid beer in bottles and kegs. The door to this cooler is lockable.

North of the Bulk Cooler, along the West wall of the brewery is storage space for the portable, manual bottling device and for empty kegs and bottles. Empty containers are thus segregated from filled containers in the Bulk and Serving Coolers.

At the West end of the North wall of the brewery are two doors: the 3 ft. wide man door (Door 4) and the 9 ft. wide overhead, loading door (Door 3). Both doors open to alley space and will be locked during non-business hours. Along this wall, in the brewery operations area, are the grain crushing equipment, the brew kettle, the mash tun, and the hot liquor tank. At the East end of the wall is the boiler room housing the 43 hp., natural gas fired, atmospheric steam boiler.

In the brewery operations area, near the brew kettle, there are eight unitanks. These tanks will be used for fermenting and conditioning and are gauged with removable sight glasses. Volumes are calibrated on the tanks themselves.

As shown on the attached diagram, the following walls contain the brewery production/beer storage area:

Three South walls one 30'-6" long, one 12'-9" long, and one 14'-0" long

Three East walls one 21'-4" long, one 23'-2" long, and one 13'-6" long

One North wall 61'-0" long

One West wall 58'-0" long

Exterior measurements for the entire unit are as follows:

One West wall 58'-0" long

Two South walls each 30'-6" long

One East wall 73'-0" long

One North wall 61'-0" long.

The brewery also includes a non-public storage mezzanine located (generally) over the taproom service and storage areas and the Serving Cooler. The mezzanine communicates only with the brewery operations area and is separate from the tavern. Measurements for the mezzanine are as follows: Two West walls one 4'-9" long and one 21'-3" long, Two South walls one 14'-8" long and one 8'-0" long, One East wall 26'-0" long, and One North wall 22'-8" long.

The portion of the brewery operated as a tavern and open to the public during business hours is described in the previous question and shaded green on the diagram submitted with this application. The tavern area is separated from the brewery operations area by walls and doors. There will be three lockable doors (Door 5, 6, & 9) between the taproom service area and brewery operations area.

As shown on the attached diagram, the following walls contain the taproom:

One South wall 30'-6" long

One East wall 59'-6" long

Three North walls one 2'-8" long, one 12'-9" long, and one 14'-0" long

Three West walls one 21'-4" long, one 15'-0" long, and one 23'-2" long

The taproom occupies one floor and is separated from the brewery production/beer storage area with walls containing lockable doors 5, 6, and 9 (as shown on the attached diagram).

You must identify areas of the brewery which are accessible to the public and areas which are not.

The tavern area, shaded green in diagram submitted, will be accessible to the public.

All brewery operations and storage areas, shaded blue in diagram submitted, will not be accessible to the public. The mezzanine will also not be accessible to the public.

Describe security measures to be used to segregate public areas from non-public areas.

Exterior doors (Doors 1-4) are lockable and secure. These doors will be closed during business hours and locked at all other times. Exterior windows do not open.

The doors between the public tavern and the brewery operations area are secure and lockable (Doors 5, 6, and 9). These doors will be kept closed during tavern business hours and will only be used by authorized persons. Cooler doors are lockable (Doors 7 and 8). They will only be used by authorized persons during business hours and will be locked at other times. The brewery operations area will only be accessible by authorized persons during business hours and will be securely locked at other times.

Describe in detail the method to be used for measuring beer for the purpose of tax determination. Identify the tanks which will periodically contain tax-determined beer, and any other areas where tax-determined beer will be.

All tanks in the brewery are accurately calibrated and gauged with sight glasses. In the brewery operations area are six unitanks having a working volume of 15 bbls. each, one unitank with a working volume of 30 bbls, and one unitank with a working volume of 2 bbls. Volumes are calibrated on the tanks themselves. In addition, Serving Vessels SV-01, SV-02 or SV-03 are each marked "Tax Determination Tank". Packaging will be in $\frac{1}{2}$ bbl. kegs, 1/6 bbl. kegs and 750 ml. bottles. In the latter case an equivalency of 0.07670 bbl. per 12 bottle case will be used. Un-taxpaid kegs and bottles will be stored in the Bulk Cooler.

Tax determination for beer sold on premises will occur when beer is moved to the Serving Cooler.

Provide description of the brewery security. Brewery building must be arranged and constructed to give adequate protection to the revenue. Describe locks, access to the brewery and how un-taxpaid goods will be protected during and after business hours

As described previously, Exterior doors (Doors 1-4) are lockable and secure. These doors will be closed during business hours and locked at all other times. Exterior windows do not open. Exterior security cameras cover the East and North walls of the building during and after business hours. These are the only walls that have doors that allow access to the brewery. Interior security cameras will cover un-taxpaid goods during and after business hours.

Un-taxpaid beer will only be in the brewery operations area. The doors between the public tavern and the brewery operations area are secure and lockable (Doors 5, 6, and 9). These doors will be kept closed during tavern business hours and will only be used by authorized persons. Cooler doors are lockable (Doors 7 and 8). They will only be used by authorized persons during business hours and will be locked at other times. This area will only be accessible by authorized persons during business hours and will be securely locked at other times.
