Attny. Jessica Brown- introduces herself as legal counsel and explains that the licensee has experienced some operational challenges but has entered into a purchase and sale agreement and wants to transfer the license immediately. Her understanding is that the licensee was under the impression that, when they closed, they thought they had to surrender the license as opposed to putting it into safekeeping. They did not consult council at that time.

Board Member Diane Thompson- asks how Holland America as the licensee didn't understand the decision, they made to not renew the license, which lead to the license being expired.

Attny. Jessica Brown- confirms that her understanding is that the licensee didn't understand their decision to surrender the license. AMCO staff did try their best to explain, but the licensee was focused on closing up shop and trying to minimize expenses and did not want to pay for the renewal at that time.

Program Coordinator Jane Sawyer- explains that the license expired in 2023 after at least two attempts to make the licensee understand that not renewing the license would essentially make the license evaporate. It wouldn't even become available. They made the decision not to renew the license and now they're requesting a reinstatement of the license including the necessary waivers.

Chair Dana Walukiewicz- states that what has changed is that the licensee has a buyer now.

Attny. Jessica Brown- offers a more charitable way to look at this is that in the aftermath of the earthquake and a lot of the operational problems that the hotel had, they were not as focused as they should have been on some of the privileges that were extended to them on behalf of the state.

The board enters a discussion regarding precedence on the matter involving other licenses (Table 6 and The Peppermill) where the board determined that licenses were surrendered, the office clearly communicated the ramifications that could follow those actions and then years later the licensee pursues reinstatement only after a perspective buyer shows interest in the license. The two instances discussed were denied.

Chair Dana Walukiewicz- adds that the board would only have considered reinstatements if there was something outside the control of the licensee with good cause and reason.

The board explores the possibility of other license types available for application highlighting Restaurant or Eating Place Licenses as well as Beverage Dispensary Tourism Licenses to operate.

Chair Dana Walukiewicz- states that he hates to see licenses disappear due to the population cap and acknowledges that every time a license goes away, it disappears forever. This really disappeared several years ago, and it was their decision to make it disappear. We don't have the facts and circumstances to grant reinstatement.

Juan Robles, son of licensees- agrees and says that this was a one-off mistake but now with the AK-ACCIS online licensing system it will be much easier for them to keep up with the maintenance of the license.

Chair Dana Walukiewicz- introduces tab 30. This is a general wholesale license, 4860 for Southern Glazers of Alaska in Kodiak. Kodiak Island Borough is protesting the renewal of the license for several reasons. They state that there is not active business property or real property accounts of record, incorrect listing of location, there are no employees or physical storefronts, it is unclear whether or not they're actively wholesaling in Kodiak, and the physical address is actually Anchorage, not Kodiak.

Jeff Lightfoot, general manager of Southern Glazer's- introduces himself and reads a letter from legal counsel. He asks for clarification whether AMCO would classify the operations of Southern Glazer Wine and Spirits in Kodiak as their distribution point. And if so, confirm that the wholesale license is required in Kodiak. If AMCO determines that these activities do constitute a distribution point, we respectfully request the protests file by Kodiak be denied. Southern Glazer's and the Odom Corporation work collaboratively to distribute alcohol beverages throughout Alaska, including Kodiak. Odom provides the on-the-ground operational support. Its employees perform fulfillment services for retailers by packing and shipping alcoholic beverages to retailers in Alaska and Kodiak. Odom then invoices Southern Glazer's for the work performed by its employees. In effect, the distribution of alcohol beverages to retailers in Kodiak is conducted on behalf of Southern Glazer's but carried out through an agency-typer relationship with Odom. Our question is whether AMCO considers these activities to rise to the level of distribution point, subject to AS 04.11.060. It is our belief that AMCO requires the license, and therefore Southern Glazer's wholesaler license in Kodiak must be maintained.

Chair Dana Walukiewicz- asks if Attny. Andrew Bocanumenth had an opportunity to look into the issue.

Attny. Andrew Bocanumenth- states that he received something this morning but has not had a chance to review it due to being in the meeting.

Chair Dana Walukiewicz- shares that this is more complicated issue than a simple renewal and simple protest. It could set a precedence and questions regarding whether, essentially, a subcontractor/sister company is doing work on behalf of another wholesaler. The letter alluded to an agreement between Southern Glazer's and Odom, is there an agreement?

Jeff Lightfoot, general manager of Southern Glazer's- confirms that there is a shared services agreement.

Program Coordinator Jane Sawyer- mentions that this is an old license and that kind of research wasn't allocated to it at this juncture.

In this statement the licensee mentions a denial letter; this denial letter was sent October 3, 2022. The office has received a transfer application for this license that was entered into the queue as of August 28, 2025.

Dana Walukiewicz summarizes to say that the AMCO office hasn't had an opportunity to process the transfer application and so the community has not received the transfer application, and we need a little more time to process that application and get it to the municipality, at which point they may or may not waive the protest.
