This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 4-9-24 an inspection was conducted at your establishment. On-duty personnel were asked to provide proof of server education. Bartender Hector F. Vazquez-Garcia provided a TIPS card, #5389104, which had expired on 10-15-2023. Mr. Vazquez-Garcia was told to stop serving alcohol until he presented a valid server card to a Board representative. He was issued a citation for expired server education.

Your attention is directed to AS 04.21.025: Alcohol server education and AS 04.21.030: Responsibility of licensees, agents, and employees.
