This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 5-6-24, an inspection was conducted at your establishment. Licensee's Ross Johnson and Brian Swanson were contacted and asked to provide proof of current server education. Johnson and Swanson provided current server education. Licensee Reid McDonald had left the building prior to my contacting him. A check with Alaska CHARR revealed his server education card, had expired on 10-29-23. On 5-10-24, licensee McDonald was issued a summons for no server education course. Citation number P00355249.

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.
