This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

"Iceworm Board Game Night", January 29, 2024, 5pm

"Iceworm Homebrew Competition", February 2, 2024, 6pm
