**Motion** to approve the prior meeting minutes by Diane Thompson. Second by Jan Hill. Unanimous affirmative vote. Motion carries.

- PUBLIC COMMENT PERIOD Time 9:50 AM

*Chair Dana Walukiewicz- introduces the public comment period and asks if there are any members of the public that would like to speak to anything. 9:41am*

*Tiffany Hall, president and CEO of Recover Alaska- explains that the organization works to reduce excessive alcohol use and harms around the state in an effort to create a safer environment. She thanks the board for making the time for public comment available and expresses appreciation of the thorough consideration the board takes in reviewing applications. She came to speak to the petition for additional REPLs for Sitka. She was involved in the process of changing Title IV and so she is familiar with the various changes that make this type of request and petition possible. She states for the record that the intention of applying for additional REPLs was really to be able to address traffic. She uses Sultana as a reference citing their small population and how many people they have coming through and why it would make sense for them to request additional licenses to serve the individuals who drive through every day, who maybe live outside but come in daily. She states that additional licenses don't make sense for Sitka, and it doesn't feel like it meets that need. Offers support in terms of public safety and health to say that the request from Sitka should be denied.*

*Jana Weltzin, legal counsel for JDW- thanks the staff for helping out and being flexible with her being on maternity leave.*

Isaiah Vreeman, president of the Anchorage Wolverines- thanks Director Richard for meeting with him to discuss some of the things the Wolverines are looking at since operating in the Sullivan Arena. Highlighting some issues with IDing and how that process works on the wet and dry sides including some of the challenges, especially as crowd numbers grow and bottlenecking can occur. He mentions trying to eliminate double IDing systems from a wet and dry side.

Chair Dana Walukiewicz- thanks Mr. Vreeman for being proactive in seeking advice from the office on the subject.

Director Kevin Richard- states that in the discussions with the licensee, the issue is to do with restricted access to licensed premises. So, when you have these wet and dry sections, the entire thing is a licensed premises, like a hotel lobby, you run into restricted access problems or concerns. He believes this would denote the need for a statutory change.

Michelle Kavouras, representing Sitka Counseling and Prevention- introduces herself to speak about the proposed increase of REPLs in Sitka. She stresses the importance of highlighting that if the local governing body thinks it's the ABC Board's responsibility to make final decisions without having all the information and facts being clearly and thoroughly reviewed by our local governing bodies, then it kind of leaves nobody accountable for making sure that this is in public health interest, especially when talking about youth. Pointing out that when the alcohol outlet density increases, the youth drinking rates do as well. She suggests being more careful about not having the numbers increase amongst the youth or making it socially acceptable, more so, we're trying to reduce the risks and harm, and increase protective factors, reducing those risk factors. What is being proposed would undo all the work that has taken place over the years. Pointing out that mental health and substance use risks have been almost entirely absent from a lot of these discussions. She would like to see a public health impact assessment before approving new REPLs and to look at law enforcement in Sitka. She states that there were 11 positions open with the police force.

Chair Dana Walukiewicz- states that the board will have a formal public hearing and at that point there is the opportunity for the public to comment and testify on that.

Joclynn Smith, a concerned community member- speaks about her lifelong best friend killing herself and how mental health and alcohol were factors. Most of her time was spent at a bar and she established a relationship with the people at the bar. This created instances where drinks were heavily poured, free drinks, drinking and driving all became common place. She asks to start a discussion or look at improving the training to include signs of emotional distress, suicidal ideation, patterns of behaviors of addiction, and the impacts of long-term alcohol use. She suggests having annual trainings and not every 3 years.

Chair Dana Walukiewicz- closes public comment period at 10:00 am.

- DIRECTORS REPORT

**TAB 4**

Director Kevin Richard- summarizes activities of the AMCO office since the last board meetings that were held in September. He touches on AO360 stakeholder meetings and administratively reclassifying the Administrative Assistant 1 position to an Administrative Assistant 2 position. There are a couple topics to be considered. The first is AO360 and the second is a request for board guidance on abandoned applications. In October, licensing examiners brought to light a number of licenses that were set to expire. They had outstanding pending applications. Review of files showed outreach by licensing examiners was thorough, exceptionally thorough. Some of the outreach numbers were 4 emails of 2 months to 19 emails over the course of 8 months in addition to phone calls. This is an example of staff trying to get answers to questions or get updates or needed information on an application so that it may be presented to the board in a timely manner. The licensing section consists of 3 licensing examiners and a supervisor who are responsible for processing applications for over 2,000 licenses. Each time a licensing examiner needs to request additional information, it slows the process. AMCO licensing staff is committed to helping licensees get their applications complete and accurate, so it may be presented to the board in a timely manner. In other regulations references to abandoned applications led to seeking guidance or direction from the board for an idea of appropriate volume of outreach, acknowledging that there is no magic number, but at what point can we essentially issue to a licensee a final request. It's frustrating for staff, takes significant time, and takes hours away from licensees that are

*current and prompt and willing to actively engage with staff. If a license is on the verge of expiration the supervisor generates a report and it's reviewed. He goes on to explain that licensees are given several attempts, including Mr. Richard reaching out directly. He states that part of his frustration, because when he calls, he gets a response.*

*Chair Dana Walukiewicz- summarizes Director Richard's research into the other department's functionality by saying that roughly 60 days looks to be the average timeframe for most agencies to consider an application abandoned if there's no response. If an application was considered abandoned the, they would have to reapply and pay new fees. Once Sonya or Kevin emails, then they finally respond. If they don't respond in 60 days, then the application would be considered abandoned.*

*Board member Jan Hill- states that she feels for staff and is shocked that something isn't already in place to take care of instances like this. She is more than willing to work on this matter with the office. She states that the circumstances are ridiculous.*

*Chair Dana Walukiewicz- asks the board if there are any objections with a 60-day abandonment policy via board guidance to the office.*

*No objections heard from the board.*

*Director Kevin Richard- moves onto the AMCO Budget Report under AS 04.06.075(c). He provides the current fiscal year 2026 expenditure revenue projections for AMCO. He then pivots to a previous board request for clarification on 3 AAC 305.660(a) regarding overlapping licensed premises. During the September 2025 board meeting a question arose whether a licensee could continue operating as an overlapping premises. Subsection (l) provides that the restrictions provided in (A) do not apply to overlapping premises for two or more licenses approved by the board before January 1, 2024. The response received from counsel was that ownership percentages of each person in the entity are immaterial because the entity is considered a legal person. Consequently, the ownership of overlapping licenses post 2023 must be identical regardless of whether the owners or group of owners are natural persons or entities. The ownership must be identical for overlapping purposes.*

**TAB 6**

*Chief Investigator Joe Bankowski- addresses the board for the enforcement report. He explains that the investigators have conducted 320 premises inspections between September 2<sup>nd</sup> and November 19<sup>th</sup>. There are currently 3 vacancies within the enforcement unit. The recruitment waiver for the Fairbanks vacancy was denied by the Department of Administration. Both the vacancies in Anchorage and Juneau closed and the next steps of the process will be taken as quickly as possible. A PSA for licensees and the public, we are consistently encountering alcohol servers without valid alcohol server education as required by AS 04.21.025.*

*Director Kevin Richard- states that the recruitment waiver was not approved by OMB, not the Department of Administration. In addition, the two other vacancies have been fairly recent, within the last month or two. When the original recruitment*

waiver was denied, we were fairly well staffed. The intent is to resubmit the waiver application.

The board accepts the enforcement report.

- Notices of Violation Issued and Licensee Responses

TAB 7

Chair Dana Walukiewicz- introduces the NOV report and asks about The Lands End NOV. From the NOV it appeared that there had been a change in the premises.

Investigator Hamilton- states that they have recently submitted an AB-14 to change the premises. When they changed the premises, they changed the flow of the establishment and that changed where the signs needed to be displayed. They were missing the pregnancy sign. They did get them up and corrected right away. There was no citation issued as they responded quickly.

Chair Dana Walukiewicz- asks about The Hunger Hut NOV where the on-duty clerk had an expired TAPS card. They were told to stop selling alcohol and then subsequently they were found selling alcohol, is that correct?

Investigator Hamilton- states that he told the clerk not to sell anymore alcohol due to the expired TAPS card. He went outside to write the citation for the expired server education card and when he came back in, the clerk continued to sell. She was told again not to sell alcohol. This occurred roughly 10 minutes after being told not to sell.

Chair Dana Walukiewicz- asks counsel if an accusation could be issued in this instance based on it being such an egregious act.

Attny. Andrew Bocanumenth- confirmed that an accusation could be issued.

**Motion** to direct the director to issue an accusation for The Hunger Hut in the amount of \$2000, with the ability to negotiate with the licensee, based on the facts and circumstances associated with the notice of violation by Jan Hill. Second by Doug Moore. Unanimous affirmative vote. Motion carries.

Chair Dana Walukiewicz- introduces another NOV for The Hangar involving minors working without proper documentation. They initially didn't respond but then did respond. Did they provide payroll records?

Chief Investigator Joe Bankowski- states they did respond and from that response they did provide the payroll records in which the NOV references 295 violations that occurred during that time.

Investigator Hamilton- confirms that the employment documents were received.

**Motion** to direct the director to issue an accusation for Tailwind Inc. license 3755 for the violations associated with the employment of underage individuals without appropriate work permission from the Department of Labor and have the director apply a fine consistent with previous accusations and allow the director the ability to negotiate with the licensee for suspension of a portion of that fine if they voluntarily agree to a future compliance program by Doug Moore. Second by Diane Thompson. Unanimous affirmative vote. Motion carries.

*Chair Dana Walukiewicz- jumps to the 2025-2026 renewal applications with or without endorsements while waiting for 11:30 am to start the petition at tab 8.*

*Local Government Liaison Kristina Serezhenkov- introduces the petition from the City and Borough of Sitka requesting 3 additional Restaurant or Eating Place Licenses. They've provided their resolution and a very robust packet with documentation about how they've publicly noticed and held their own meetings within their jurisdiction to approve and come up with this resolution. In addition to their items in the board packet, we also received a written comment from Ms. Michelle Kavoruras. The petition speaks for itself, and Ms. Amy Ainslie from the City and Borough of Sitka is ready to speak to the details of the petition.*

*Chair Dana Walukiewicz- opens the public hearing at 11:30 am*

*Amy Ainslie, Planning and Community Development Director for the City and Borough of Sitka- starts by saying that Kristina Serezhenkov's memo did a really nice job outlining the petition's compliance with Alaska Statute 04.11.405. She goes on to highlight the research into the other petitions of the 6 communities which have had petitions approved from 2023 to present were considered during this process. The second point highlighted is the extensive public process. Between July and October there were 5 public meetings. There have been 7 notices in the local newspaper, and ample press coverage from the newspaper and radio stations, there were also 3 separate notices sent to all active alcohol license holders as well. The third piece highlighted is the fair compromise reached to achieve and balance public interests.*

*Local Government Liaison Kristina Serezhenkov- clarifies that they are allowed 5 REPLs, they currently have 8, so they are 2 over, and that is a requirement that they be at or over cap in order to apply for this type of additional Restaurant or Eating Place Licenses. They have 8 active Restaurant or Eating Place Licenses, of which 1 chooses to be a seasonal license. They have no active Seasonal Restaurant or Eating Place Tourism Licenses, those tourism licenses that are issued for no more than 6 months. At this time there is one application pending for Sitka that hasn't made it to review or board completion.*

*Chair Dana Walukiewicz- again opens it up to public comment to encourage anyone who wishes to testify.*

*Tiffany Hall, President and CEO of Recover Alaska- speaks in opposition to the petition to increase the number of REPLs in Sitka. Sitka already has 2 more licenses than the population limits allow. The intent of the recent Title IV law change was not to get around population limits, it was to accommodate certain areas that do experience a lot of daily or weekly travel, or people coming in and out of those cities. She respectfully requests that the board ignore the comparison with other post-petition cities and instead focus on the intent of the law to consider the 15 to 1 ratio that is in statute. Population limits on alcohol outlet licenses have decades of research. Specifically, here in Alaska, when a community has more places selling alcohol, harm goes up. It's a numbers game. More outlets mean more consumption. There is not an adequate police force, there are gaps in their force right now. People drink more often and consume more alcohol in areas with higher outlet density. She points out that Sitka has seen 32 DUIs for 2025 already. Increasing the alcohol outlet density would exacerbate the issue. She urges the board to deny the petition to increase REPLs in Sitka.*

*Michelle Kavoruras, representing Sika Counseling and Prevention- states that the health and wellness of our community should be included should be included in the public interest piece. She expresses confusion about how the supporting*

documentation is presented in the format I was. It is very misleading when talking about different communities and our REPLs that were approved versus our total population. It should just be removed, it's not accurate. Our health and wellness in public interest are severely lacking. In September a 17-year-old who got a DUI in Sitka got 3 more in the last 30 days. She thanks the board.

Chair Dana Walukiewicz- Closes the public comment 11:47 am. Opens it up to board comment.

Board Member Doug Moore- asks the petitioner from Sitka, Amy Ainslie, about the understaffed police department in Sitka. He asks if Ms. Ainslie has any numbers so that he doesn't have to operate on hearsay.

Amy Ainslie, Planning and Community Development Director for the City and Borough of Sitka- responds to say that there are 8 officers in addition to our administrative levels, there is a lieutenant, and interim chief, another lieutenant who is currently in the academy and supports staff in police department administration. Law enforcement is facing workforce issues across the board, and Sitka is not immune from that. We consulted with our police department and with our police chief and shared that with the assembly when they passed this petition. They did not feel that passing this petition would place strain on our police department. Our police chief specifically stated that alcohol related calls generally do not come from restaurant or eating places with alcohol licenses.

Board Member Diane Thompson- asks if they had considered Seasonal REPL Tourism Licenses.

Amy Ainslie, Planning and Community Development Director for the City and Borough of Sitka- responds by saying the greater concern for our community is stabilizing our year-round economy. The year-round population has been stagnant and we're looking to grow economic opportunity. We're actively seeking to grow our year-round visitor industry as well and are investing hundreds of thousands of dollars in advertising to boost our year-round and off-season visitor industry. We're not opposed to anyone pursuing those seasonal licenses, our greater goals of having stable and year-round economy and population are better served by increasing the number of REPLs available in our community.

Board Member Diane Thompson- states that they are already over the license count by 2, if granted they will then be at 11 and the cap is 6.

Board Member Doug Moore- points out that we are allowed to do this and we have already done so several times.

A lengthy discussion begins at 02:02:32 of the recording.

**Motion** to approve the City and Borough of Sitka's petition for additional 3 REPL licenses by Doug Moore. Second by Jan Hill. Unanimous affirmative vote. Motion carries.

Program Coordinator Jane Sawyer- points out that in their resolution, paragraph 10 is asking the board to prioritize certain applications that have longer than 10 months of operation. She states for the record that there are processes of determining whether the application is going to be approved or not in the case of competing applications, which is what this paragraph is talking about. There is no favoring one over the other, at the end of the day there may be a drawing of names from a hat like last time.

Chair Dana Walukiewicz- thanks Ms. Sawyer for the reminder. In the event of competing applications, the board can take it under advisement, but we can't handcuff ourselves at this point. We do appreciate the guidance, because it gives us an understanding as to what the local jurisdiction favors.

- NEW LICENSE APPLICATIONS WITH OR WITHOUT ENDORSEMENTS

Chair Dana Walukiewicz- mentions that at the beginning of the meeting he promised to start the addendum tabs after the lunch break. He introduces Addendum tab 1 discussing Alaska Premier Auctions and Appraisals and the request for a 3<sup>rd</sup> waiver of operations which was tabled at the last meeting.

Attny. Jana Weltzin, representing JDW Counsel- speaks as legal counsel for the licensee to say that they were going to move this license to a new facility but with inflation and everything the original quotes they got for the build-out were not correct, and they were way higher than anticipated. They are now under contract to sell this license to another existing licensee. We're hoping to get this waiver approved so we can move forward with that transfer.

**Motion** to approve the third waiver for Alaska Premier Auctions and Appraisals 3<sup>rd</sup> by Diane Thompson. Second by Jan Hill. Unanimous affirmative vote. Motion carries.

Chair Dana Walukiewicz- introduces Addendum tab 2 considering Girdwood Brewing Company's application for a new REPL.

A lengthy discussion on Addendum tab 2 Girdwood Brewing Company's application for a new REPL begins at 2:29:20 of the recording.

Attny. Jana Weltzin, representing JDW Counsel- speaks as legal counsel for the licensees. What you have here is an application for a REPL which utilizes a food service management agreement where we're meeting the intent and spirit of the statute. She indicates that her letter walks through the statute and how the food services provided at the Girdwood facility meets the statute of control of the food service. The food service management agreement focuses on menu and pricing controlled by Girdwood Brewing. The hours of operation are controlled by Girdwood Brewing. The point of sale and all the revenue collected will be owned, if approved, by Girdwood Brewing. They have staffing and training oversight and staffing approval although it is an independent contractor relationship between the brewery and the food trucks. They have operational procedures in which the contractors (food trucks) will follow brewery-issued standard operating procedures to ensure that the standards are controlled so that consumers can rely on providing the food service through a contractor. We are also going to go through the Anchorage Health Department to have commissary compliance agreement.

Chair Dana Walukiewicz- summarizes that one question before the board is whether this is a bona fide restaurant. This board has had lots of discussion on what is considered a bona fide restaurant. The question this board should consider is whether subcontracting the preparation of food is allowable. He commends the food services agreement and believes there's a lot of legal controls put there, but it's still a question for the board to consider whether this meets the definition of a bona fide restaurant.

Evan Wood, representing the Brewers Guild- reads AS 04.21.080 for the definition of a bona fide restaurant. He states that he would argue that this licensee has clearly illustrated that with the licensed premises, there is a variety of food prepared on-site and that it is already served during hours of operation.

Chair Dana Walukiewicz- asks Attny. Andrew Bocanumenth if he has concerns. He goes on to state that the board is exercising some judgement here and asks if it is defendable.

Attny. Andrew Bocanumenth- explains that it really comes down to interpretation and how you're interpreting the statutes. What would be untested is, for example, given the legal independence of these food trucks, let's say some sort of violation occurred on the premises and it's clear that the food truck or the vendor was the one that committed the violation. Once we go to OAH and try to put the ownership on the licensee, will the ALJ agree. For example, you have a 16- or 17-year-old working in a kitchen and that becomes your violation.

Program Coordinator Jane Sawyer- clarifies that the application was brought to the board as an incomplete application so, with your approval that means you determine the application complete and approve with delegation. Then we will notify the local government, because we have not.

Chair Dana Walukiewicz- asks if there were other pieces that were incomplete.

Program Coordinator Jane Sawyer- states that this was the question, did they actually have control of their kitchen.

Chair Dana Walukiewicz- states that he would deem the application complete, assuming they get a food manager card, and you get your commissary agreement along with all the things mentioned in your package. We'll delegate that to the office to ensure that it gets done.

**Motion** to approve a new REPL application for Girdwood Brewing Company with delegation by Doug Moore. Second by Jan Hill. Unanimous affirmative vote. Motion carries.

Chair Dana Walukiewicz- moves to the Crowne Plaza on Addendum tab 3.

Program Coordinator Jane Sawyer- walks the board through the application and states that the lobby has been removed.

**Motion** to approve the Hotel/Motel Endorsement for Crowne Plaza 4844 with delegation by Jan Hill. Second by Diane Thompson. Unanimous affirmative vote. Motion carries.

Chair Dana Walukiewicz- introduces The Continental's package store license with protest at Addendum tab 4.

Mandy Honest, representing the Municipal Clerks Office- states that the licensee has called and taken care of the payment.

Chair Dana Walukiewicz- asks if there is anyone from the licensee on the phone.

Attny. Sherman Ernouf, from Ernouf & Coffey- speaks as legal counsel for the licensee.

Chair Dana Walukiewicz- asks regarding the Restaurant Endorsement if there are cooking facilities on the premises.

Attny. Sherman Ernouf, from Ernouf & Coffey- states that they are not required to make food for the license type applied here, but they are making an extensive amount of food offerings. Blue Line makes food; the same people are making the food as the ones running the facility. We can have a concession agreement if that's what the board would like to see.

Chair Dana Walukiewicz- asks if the RE will expand the hours of operation.

Program Coordinator Jane Sawyer- responds to say that no, the RE will not expand the hours of operation. She goes on to clarify the diagram. Mr. Ernouf states that the commercial kitchen is on-site, but on-site at the same location as the stadium. The licensed premises is just a piece of it and the coffee shop/restaurant is outside of that piece of the licensed premises and is operated by a different entity. The applicant here is not the one who makes the food, they don't have a kitchen.

Jessica Rady, applicant- she speaks to being a 50/50 partner owning the Polar Ice Rink. There is a coffee and concessions facility; it's called Blue District (entity). That is just part of the main entity, so it didn't require a separate entity to be created with the Sporting/Activity License. The food facility is part of our main facility operations and is staffed by the main facility, which is the same 50/50 ownership. Separately we are leasing area to Benchwarmers LLC, which is the bar and lounge area that is also a 50/50 ownership. This lounge area is the only heated section of the building, and we want people to come up and have a drink while the activities are going on but we would also like people to be able to have their coffee or food there and enjoy it while games are taking place. We have a full kitchen with a variety of food offerings. We would also like minors to be able to go there and eat food and watch the game. She reiterates that both entities are owned 50/50 by the same people and are in the same complex.

Chair Dana Walukiewicz- explains that a licensee wishes to get the restaurant endorsement, but the actual food preparation facilities are not within the licensed premises. He asks what the statutory or regulatory requirements? It still must maintain as a bona fide restaurant. We say that a variety of items appropriate for meals are prepared on-site. The kitchen is not within the licensed premises in this circumstance.

Attny. Sherman Ernouf, from Ernouf & Coffey- reads AS 04.09.450 the statute requires that a restaurant endorsement authorizes the holder of a beverage dispensary license or a sporting activity or event license. We have a holder of license. You're about to give the endorsement to Benchwarmers LLC, which is owned by the Rady's 50/50, but another entity is applying for the endorsement. The entities don't match in name, but they match in constitution. They're legal entities owned by the same people, so we could have a concession agreement between the two. The food is the only thing that we want to serve, the alcohol is not the issue, we just want to serve food.

Board Member Doug Moore- asks if the endorsement is approved then people under the age of 21 will be allowed to eat in the facility unaccompanied?

Chair Dana Walukiewicz- responds to say that Mr. Moore's understanding is correct.

Chief Inspector Joe Bankowski- clarifies from an enforcement perspective that only active eating is to be considered here by the unaccompanied minor.

Chair Dana Walukiewicz- asks the board if they feel that this is problematic.

Board Member Doug Moore- states that he doesn't feel that it's problematic.

Board Member Diane Thompson- states that she feels better that they have food.

*Chair Dana Walukiewicz- jumps from tab 9 and introduces tab 32 and 31 to accommodate individuals in the room from out of town. He states that tab 32 seems to have a memo regarding different ownership contemplating overlapping premises. Involving overlapping licenses 201 (Beverage Dispensary, 5462 (Distillery Manufacturer with an active Manufacturer Sampling Endorsement 15888), 15882 (Distillery Retail), and 15890 Manufacturer Direct Shipment License. The issue in front of the board right now is whether or not to approve this license, given that there is different ownership. There's overlapping premises, but there's different ownership of those entities. Is that the correct summation?*

*Attny. Jana Weltzin, representing JDW Counsel- introduces herself as legal counsel and confirms that the question is correct. She states that the natural persons are all the same in both entities, but two different entities. She reads 3 AAC 305.660. In this section, the board may approve and application for overlapping premises for two or more licenses owned by the same person or group of persons. The way we read this was that the group of persons can create two different entities, one to hold the bar license and one to hold the manufacturing and distillery licenses. To separate liabilities and to protect the owners.*

*John Blasco, with Anchorage Distillery and Frontier Crafted Spirits- introduces himself. He goes on to explain that Anchorage Distillery has 13 individual owners and 6 of those are part of Frontier Crafted Spirits. After working with our attorney, and reading the regulation, the decision was made to separate the assets for protection for insurance purposes.*

*Attny. Andrew Bocanumenth- speaks to a previous instance involving overlapping premises. That case was somewhat different in that you did have two entities, but the ownership was not the same for those two entities. This one is a similar situation where you have two entities, separate, different entities, but the ownership is the same. It comes down to how the board interprets the word person. The regulatory language says that two or more licensees owned by the same person or group of persons. From a legal perspective, an entity is a person, so from a legal standard, when I read person, I'm looking at the entity. Not the owners of the entity. Ultimately this regulation is from the board, the board adopted this regulatory language, so it is up to the board to interpret what it means when they say person.*

*Chair Dana Walukiewicz- so this is a different circumstance.*

*Attny. Andrew Bocanumenth- states that this is different, from the other case, there were two entities, but the ownership was different for the two entities. Here they're making the argument that we know it's two entities, but the ownership is the same, that's how they're trying to distinguish this case.*

*Program Coordinator Jane Saywer- states that it isn't the same.*

*Attny. Jana Weltzin, representing JDW Counsel- responds to say that all the people involved are the same, but the percentages are different.*

*There is a discussion about the breakdown of ownership and how the 16 people still exist in both entities even if it's by a small percentage within a sub-entity.*

*Attny. Jana Weltzin, representing JDW Counsel- states that Frontier Crafted Spirits does business as Anchorage Distillery and the*

transfer is going to Frontier, so I would say that all of the beer bar activity, anything that's over what Anchorage Distillery LLC can do under its license is under Frontier Crafted Spirits, but would have to work that plan up with the CPA to make sure that accounting wise, how to identity that.

Chair Dana Walukiewicz- suggests that it seems like a management agreement between the two entities would be helpful to make sense as far as your own books and records and so that it's clear to this board too, as to who's operating what license and at what times.

Board Member Diane Thompson- asks if Frontier has any ownership in Anchorage Distillery?

Attny. Jana Weltzin, representing JDW Counsel- states that everybody that owns Frontier and Anchorage Distillery LLC, which owns part of Frontier, also owns Anchorage Distillery. Frontier is not a member of Anchorage Distillery.

The board expresses no problems with the ownership structure being described.

Chair Dana Walukiewicz- introduces the continued discussion of AO360. At our previous meeting, we distributed some materials, which included the whole entirety of the regulations under 3 AAC 305, which is the alcohol license regulations, and Alcoholic Beverage Control Board Meeting December 2, 2025

*a good table there that the office put together, which is essentially a listing of those regulations that are required under statute. Obviously, there's a goal in this government to make life easier for those who wish to operate in the industry and the public as well, to understand what is out there and how alcohol is governed in the state. The homework assignment was to take a look through those to see if there's areas in which the board would like to focus on. There is another opportunity for stakeholders to speak with the office on December 9<sup>th</sup> at 10:00 am. I'd also like to open it up to the board to see if there's anything they'd like to see changed. The staff have already identified a couple of things, for example the endorsements available to package stores. That's basically a rewrite of the statute and might be something that we can easily remove to get to the 20 or 25% goal over the 2 years.*

*Board Member Diane Thompson- states that she concentrated on the trade practices and it looks like there's 11 statutory requirements but there's 172 in total, so maybe we could take a look at that.*

*Chair Dana Walukiewicz- responds to say that it could be something to take a look at, but we have to remember that it's written in statute. Trade practices are prohibited unless the board provides exemptions from those prohibitions. The way we tackled that was to rewrite the federal CFR into statute and then provide exemptions. What I'd be concerned about is there if we got in and muddled with the trade practices, that will end up removing the exemptions. Which would make it more difficult for the industry, because there's no more exceptions. We're running up to a deadline where if we don't approve something, everything would be prohibited. That means that a wholesaler couldn't even provide a sign. We would accomplish the goal of reducing regulations, but we'd end up shooting ourselves in the foot. We'd end up with a lot of people upset because they wouldn't get an exemption from something that's prohibited.*

*Director Kevin Richard- clarifies that we're not just looking at reducing overall regulations, it's regulatory requirements. In alcohol regulations there is redundant language, so, when those redundancies appear time and time again, then those are all separate requirements. Some cleanup work could be done on removing some of those redundancies and streamlining the language.*

*Chair Dana Walukiewicz- states that he would like to revisit this during the Feb. 3<sup>rd</sup> meeting.*

*Board Member Diane Thompson- asks when the deadline for the regulatory reduction suggestions are.*

*Director Kevin Richard- responds to say it is due by Feb. 15<sup>th</sup>.*

meetings are so efficient is because of staff. He thanks the board for all their volunteer time to go through the issues important to the State of Alaska and making good decisions. It really flushes out thoughts and ideas based on a public forum and the state is better off because of it.
