



## **ABC Board Adoption of Emergency Regulations Regarding Emergency Alcohol Curbside and Home Delivery FAQs (April 18, 2020)**

### **What Happened?**

After an emergency health mandate from the Governor of the State of Alaska, the Alcoholic Beverage Control (ABC) Board held an emergency meeting and adopted emergency COVID19 regulations that outline processes, procedures, requirements, and restrictions pertaining to the curbside delivery and home delivery of alcoholic beverages on a short-term, temporary basis during this crisis.

### **Who qualifies?**

For curbside delivery the following licenses qualify to apply:

- Package Store License
- Brewery License
- Brewpub License
- Distillery License
- Winery License
- Beverage Dispensary License

Including:

- Community
- Seasonal
- Duplicate
- Duplicate Seasonal
- Public Convenience
- Tourism
- Tourism Seasonal

Tourism Duplicate  
Tourism Duplicate Seasonal  
Restaurant Eating Place License

For home delivery of beer and wine with food the following licenses qualify to apply:

Restaurant Eating Place License (REPL)  
Beverage Dispensary License (BDL) with a Restaurant Designated Permit (RDP)  
Brewpub License with a Restaurant Designation Permit (RDP) or Restaurant  
Eating Place License (REPL)

### **What are the rules for Curbside Delivery?**

Licensed beverage dispensaries, restaurant or eating places, package stores, breweries, brewpubs, wineries/cideries, and distilleries may conduct curbside delivery of the types of alcoholic beverages normally allowed for sale by the respective license type, only if:

- The qualifying licensee provides written notification and acceptance to the Alcohol & Marijuana Control Office that it intends to deliver alcohol before conducting such activities.
- The curbside delivery location must be within 50 feet of an entry to the licensee's business premises.
- The alcoholic beverages offered for sale is factory sealed in manufacturer-sealed bottles or cans, or in growlers (limited to beer and cider only) that are sealed by the licensee with tamper-evident tape and adequate labeling; mixed drinks are prohibited.
- The licensee, agent, or employee who provides the alcoholic beverages to the customer must have a valid Alcohol Server Card.
- The licensee, agent, or employee who provides the alcohol must check the ID of every purchaser, regardless of age, and must not knowingly provide alcoholic beverages to a drunken person, an underage person, or a person who is legally prohibited from purchasing alcoholic beverages.

### **What are the rules for qualifying licensees regarding home delivery?**

Only bona fide restaurant or eating places (including those who hold beverage dispensary licenses and other qualified license types that possess restaurant designation permits) may deliver beer/wine/cider to a person's home with an order of food from that establishment, only if:

- The qualifying licensee provides written notification and acceptance to the Alcohol & Marijuana Control Office that it intends to deliver alcoholic beverages before conducting such activities.

- Only beer, wine, or cider can be included with the food order.
- The delivery order must have food prepared by the licensee.
- The value of the beer or wine purchased in the delivery cannot be more than twice the value of the food (e.g.: if \$25 of food is purchased, the value of the alcohol in that order must not exceed \$50).
- The beer/wine/cider offered for sale must be factory sealed in manufacturer-sealed bottles or cans, or in growlers (beer and cider only) that are sealed by the licensee with tamper-evident tape and adequate labeling.
- The licensee, agent, or employee who delivers the alcoholic beverages must have a valid Alcohol Server card; third-party delivery companies (DoorDash, GrubHub, UberEats, etc.) are prohibited from delivering alcohol.
- The licensee, agent, or employee who delivers the alcoholic beverages must check the ID of every purchaser, regardless of age, and must not knowingly deliver alcoholic beverages to a drunken person, an underage person, or a person who is legally prohibited from purchasing alcohol.

### **When can licensees begin to apply?**

The Lieutenant Governor signed the Alcoholic Beverage Control Board’s emergency regulations on April 16, 2020. Licensees who qualify for curbside and/or home delivery of beer and wine may email their application to the Alcohol and Marijuana Control Office (AMCO) for review at [amco.enforcement@alaska.gov](mailto:amco.enforcement@alaska.gov) and then wait to receive an email confirming the qualification of the request.

### **Is this mandatory for licensees?**

These programs are voluntary on the part of the qualifying licensees. If the licensee wishes to participate in curbside or delivery, the licensee accepts all responsibility to, and liability for, adhering to all emergency health mandates from the State of Alaska, and local governments to assist in keeping staff and the public safe during the COVID19 health crisis.

#### **Curbside Delivery Application Information**

Application for curbside delivery of alcoholic beverages is allowed for those who possesses a Beverage Dispensary License/Restaurant Eating Place License/Brewery License/Brewpub License/ Distillery License/Winery License or a Package Store License.
