Form MJ-15d: Previously Approved Edible Product THC Limit Change

Why is this form needed?

This form is required for all licensed marijuana manufacturers seeking to add the option of 10 milligrams (mg) per serving/100mg per package to their licensed manufacturing facility's currently approved products' THC content limit as described under **3 AAC 306.560**, unless otherwise approved by the board.

The required \$250 change fee may be made by check, cashier's check, or money order.

This form is the only required application to solely add the option of 10mg THC per serving/100mg THC per package (individual servings in a package may not be greater than 10 mg) to any of your current approved marijuana edible products. If any other changes are being requested, they must be requested on form MJ-15: Operating Plan Change.

This form must be completed and submitted to AMCO's Anchorage office prior to changing THC content in edibles. The licensed manufacturer's production of their currently approved edibles containing THC may not be altered unless and until the director has given approval.
