At this time, the owner(s) of the company that owns the marijuana establishment license must be an Alaska resident(s) which means a person who meets the residency requirements under AS43.23 for a permanent fund dividend in the calendar year in which that person applies for a marijuana establishment license.

If any of the owner(s) is not an Alaska resident, they cannot be an owner of the company owning the marijuana establishment license. However, right now we do not know, yet, how our office is going to address this, especially when license have already been issued.

a renewal matter. Please read 306.040 about ownership change to be reported. 306.990 (14) for definition of controlling interest. Ownership change or controlling interest change can happen at any time, not necessary at renewal time.

1) I pled guilty to Disorderly Conduct (AS 11.61.110.(a)(5)) on 10/26/15. A misdemeanor. 'challenge to fight' or 'disturbing peace with loud noise', but not charged with assaulting.
